## FEDERAL AND STATE AFFAIRS COMMITTEE

April 4, 1969 8:15 A.M.

The meeting was called to order by the Chairman who asked for action on SB 260. Mr. Andrews moved that this bill be left in committee. Motion was seconded by Mr. Turner and carried without dissent. The Chairman explained that it was obvious the CPAs were not in agreement on this bill although no amendments had been offered.

Mr. McGill moved that SB 258 be recommended favorably. Mr. Buchele made a substitute motion that Mr. Hoffman's proposed amendments be adopted. Motion was seconded by Mr. Keenan but lost by a vote of 7 yes to 10 no. Thereupon, Mr. McGill's motion was seconded by Mr. Unruh and carried 13 yes to 3 no.

The Chairman made the suggestion that SB 194 be held over for study; that there are arguments on both side that appear to have merit; that he had personally worked on the present law and felt that it was alright and that he opposed making substantial changes without deliberate study; that the committee would have a two or three day meeting in the interim and they would call in the people again and question them; that he was not attempting to stand up for the Board of Health in some of their rulings but felt it would be in the best interest of everyone to study this and come up with some satisfactory answers. Upon vote, the committee sustained the Chairman's suggestion with 13 yes votes.

Mr. Everett stated that he would like to be of record as dissenting on this decision; that he had some amendments he would have liked to offer; that this action means that dozens of people at Tuttle Creek will not be able to build their houses this year and it will hold up construction and tax valuations will be reduced on the platted property and hundreds of thousands of dollars will be lost.

Mr. McGill moved that SB 47 be recommended for passage. Motion was seconded by Mr. Patton and carried unanimously.

Mr. McGill moved that SB 113 be recommended favorably. Motion was seconded by Mr. Winters and carried by a vote of 13 yes and no dissents.

The Chairman stated that the agencies have amendments to SB 45 and that they are all in agreement. Mr. Ungerer moved that these amendments be adopted. Motion was seconded by Mr. Buchele and carried unanimously. Thereupon, Mr. Ungerer moved that the bill as amended be recommended for passage. The motion was seconded by Mr. Buchele and carried unanimously.

The Chairman displayed the amendments to SB 115 as proposed by Mr. Mosher. Mr. Buchele moved the amendments be adopted, which motion was seconded by Mr. Buck and carried unanimously. Thereupon, Mr. Buck moved that the bill as amended be recommended for passage. Motion was seconded by Mr. Woodward and carried 13 yes to 4 no. There was considerable discussion concerning the ramifications of this proposal before the vote was taken.

The meeting was recessed at this point to reconvene upon adjournment of the House.

The meeting was reconvened at approximately 10:00, and the Chairman called for action on SCR 25. Mr. Andrews moved that it be recommended for adoption. Motion was seconded by Mr. Woodward and carried by a vote of 8 yes and no opposition.

Mr. Patton moved that SB 278 be recommended for passage. Motion was seconded by Mr. Ungerer and carried without dissent.

The meeting was adjourned.
