REPORT OF SUBCOMMITTEE "A" by Senator Tillotson



THE SENATE JUDICIARY COMMITTEE amet January 15, 1970 in Room 523 at eleven o'clock A.M. Senator J. C. Tillotson, chairman of subcommittee "A", was ready with his report on work done on a number of bills held over from the 1969 session.

All members were present except: Senators Van Sickle, Storey, Smith, Hodge, Foster and Bell. The chairman, Senator Steadman Ball called the meeting to order.

Senator Tillotson distributed copies of reports prepared by the Revisor of Statutes' office to the members. The first bill reported on was Senate Bill No. 350 relating to selection of jury panels. Senator Tillotson stated that this bill was amended and favorably recommended to the full committee. Senator Pomeroy moved that the bill be recommended for passage as amended; Senator Tillotson seconded the motion and the members voted to recommend Senate Bill No. 350 for passage as amended.

Senator Tillotson told the committee that his subcommittee "A" had held a hearing on House Bill No. 1467 and that the judges attending the hearing felt this bill was workable as amended. Senator Woodard moved that this bill be recommended for passage as amended. After a second by Senator Tillotson, the members voted to recommend it for passage as amended.

House Bill No. 1096 was taken up by Senator Tillotson and after much discussion, Senator Bennett offered another amendment. Senator Bennett moved and Senator Arvin seconded a motion to add the amendment but it was defeated by a vote of 3 to 2. Senator Woodard then moved to recommend the bill for passage as amended by the subcommittee and after a second by Senator Tillotson the motion

carried unanimously.

Senator Tillotson took up Senate Bill No. 318 for which no report had been prepared. Senator Woodard moved the bill be passed over for further study and that it be referred to the Judicial Council to make sure there were no procedural traps. The motion was seconded by Senator Steineger and passed.

In regard to Senate Bill No. 320, Senator Woodard moved that the bill be not passed. After a second by Senator Bennett, the members voted that the bill be not passed.

Senate Bill No. 103 was discussed and it was decided to discuss it further when Senator Arvin could present some citations on the matter.

Senator Tillotson moved that Senate Bill No. 257 be recommended not for passage. Senator Bennett seconded and a report was made recommending the bill not for passage by a vote of the members.

Further consideration of House Bill No. 1378 was scheduled for a future meeting.

Senator Steineger moved, with Senator Pomeroy seconding, that the chairman be authorized to introduce the Code of Criminal Procedure and two companion bills recommended by the Judicial Council.

The meeting was adjourned to meet Tuesday, January 20, 1970.
