The Senate Judiciary Committee met January 23, 1970 in Room 523 with the Vice Chairman, Senator J. C. Tillotson, presiding. All members were present except Senators Ball, Bell, Gaar, Pomeroy, Rogers, Smith, Steineger, Storey and Van Sickle.

Attorney General Kent Frizell appeared in favor of Senate Bill No. 372, stating that this bill was introduced at the request of his office. He gave some introductory remarks, a copy of which is attached hereto and made a part of the minutes of this meeting. A discussion followed with Senators Hodge, Arvin, Herd, and Foster. Senator Tillotson asked the Attorney General if information requested by Sub-committee "A" regarding the number of agencies was available and the Attorney General introduced Edward G. Collister, who was prepared to give statistics regarding the agencies, number of attorneys employed, both permanent and temporary and the amount of money paid to them. His statement of statistics is attached hereto and made a part of the minutes of this meeting.

Mr. Collister also told of some instances of county
Attorneys writing briefs and appearing in Supreme Court. He
stated that some county attorneys write good briefs and some do
not: He also stated that the Attorney General has no control
over county attorneys and is governed by a very old statute dating
back to about 1850. He cited some examples occurring in Johnson
County and stated that someone is needed to try cases both at the
local level and state level.

Robert Hoffman was introduced and stated he had been in the office of Attorney General for eighteen years and that this bill

had been discussed by Attorney Generals as far back as John Anderson. He stated he was in accord with the previous speakers' statements and could give lots of examples along this line.

Senators Winter, Hodge and Arvin engaged in a question and answer discussion.

The meeting was adjourned to meet January 26, 1970 at 11 A.M. in Room 523.

statutes to determine what statutory authorization existed for employment of attorneys. The first list of twenty agencies are those given specific authority by statute to hire their own attorney of their own choosing. The second list of nine agencies are agencies authorized to employ an attorney either appointed by the Attorney General or with the approval of the Attorney below.

General. There are five additional agencies listed in the third list for which there are statutory references to an attorney, but there is no specific authorization for that agency or anyone else to employ an attorney for the agency.

- 65-2838. Board of Healing Arts -- May direct its regularly employed attorney to file petition; no provision for hiring an attorney.
- 66-106. Corporation Commission -- Speaks of "the attorney for the commission"; no specific authorization for appointment of attorney.
- 74-3302. Forestry, Fish and Game -- Speaks of chief legal counsel; no specific mention of hiring attorneys.
- 74-5326-27. Board of Examiners of Psychologists
 -- Speaks of attorney; no specific authority to employ or appoint.
- 75-3513. State Department of Social Welfare -- Mentions chief legal counsel.
