SENATE JUDICIARY COMMITTEE FEBRUARY 10, 1970 ROOM 523

The Senate Judiciary Committee met February 10, 1970 in Room 523 at eleven o'clock A.M. All members were present except Senators Foster, Gaar, Hodge, Storey, Van Sickle and Winter. The chairman, Senator Steadman Ball called the meeting to order.

Judge Owen was present to talk on Senate Bill
No. 578. He suggested changes on page 2, line 22, and line 26, and
page 3, in lines 7, 14 and 18. Senator Ball suggested that the
committee authorize Senator Arvin and the delegation from
Sedgwick County get together on these changes suggested and
bring in a report to the full committee. This was agreed upon
by the committee.

Senator Tillotson reported on Senate Bill No. 609 and stated this bill speeds up hearings on tax appeals. Senator Bennett moved that the bill be recommended for passage. Senator Arvin seconded and the motion carried.

Senator Tillotson reported on Senate Bill No. 350. He had this report already prepared (by Revisor's Office) and submitted same to the committee. Senator Bennett moved that the committee adopt the committee amendments. Senator Arvin seconded and the amendments were adopted. Senator Bennett then moved that the bill be reported back to the Senate with the recommendation that it be passed as amended. Senator Tillotson seconded and the motion carried.

The next item on the agenda was Senate Bill No. 67.

Mr. Stone Stalked on the bill and suggested the changes he thought necessary. The discussion was engaged in by Senators Bennett, Tillotson, Arvin, Pomeroy and Rogers. Senator Herd moved that the committee adopt the suggested amendments.

Senator Arvin seconded and the amendments were adopted. Senator Herd moved that the committee report the bill back to the Senate with the recommendation that it be passed as amended. carried and the bill was amended as follows: On page 1, in line 4, by striking "21-589" and inserting in lieu thereof "1969 Supp. 21-3729"; in line 5, by inserting after "issuance" the following: ", and has neither signed nor used such card"; in line 15, by inserting before the period the following: "and that he neither signed nor used such card"; also, in line 15, by inserting after the period a new sentence to read as follows: "Where any person has keep requested or solicited the issuance of a credit card from any person, firm, partnership, association, corporation or other business organization, or any agent thereof or such person has signed or used such card, the reissuance or renewal of such card, regardless of any specific request or solicitation therefor by the holder of such card, shall not be deemed to be the receipt of an unsolicited credit card within the meaning of this act."

Senate Bill No. 407 was then considered with suggested changes and Senator Pomeroy moved to adopt the suggested amendment. Senator Rogers seconded and the amendment was adopted. Senator Pomeroy moved that the committee report the bill back to the Senate with the recommendation that it be passed as amended.

The meeting adjourned to meet Wednesday, February 11, 1970.
