

SENATE JUDICIARY COMMITTEE

ROOM 529

March 5, 1970

The Senate Judiciary Committee met in Room 529, March 5, 1970 at eleven o'clock A.M. with the chairman, Senator Steadman Ball, presiding; all members were present except Senators Arvin, Healy, Steineger, Winter and Woodard.

Mr. Hotchkiss and fifteen students of the government class of Overbrook High School were present to observe.

Senator Smith was present to report on the work of his subcommittee and presented his prepared amendments on House Bill No. 1961. He explained that this bill had been worked on for the last two or three years and with this amendment, it would be more workable. He moved the bill be amended as per attached copy and that the committee report the bill back to the Senate with the recommendation that it be passed as amended. Senator Rogers seconded and the motion carried.

Mr. Gerald Goodell was present in the interest of House Bill No. 1832. He submitted his suggested changes in the bill and a copy is hereto attached and made a part hereof. He also presented statistics of states as per copy attached, and urged the committee to remove Sec. 2. Senators Herd, Storey and Pomeroy asked questions of Mr. Goodell and some discussion followed.

Mr. Stone of the Kansas Bankers Association spoke briefly endorsing everything Mr. Goodell had presented and asked the committee to consider the bill and report it favorably.

Mr. James Hubbard, Assistant County Attorney of Johnson County appeared in support of House Bill No. 1517. He explained the difference between the bill and the old laws of the State of

Kansas. He also explained his suggested amendments and cited the Supreme Court Case to support his explanation. Senators Smith and Tillotson commented on the bill.

At this point Senator Smith moved to amend House Bill No. 1832 as outlined in the material presented by Mr. Goodell. Senator Bennett seconded and the motion carried. Senator Smith then moved to delete Sec. 2 on page 7 of the bill and to renumber the remaining sections as Sec. 2 and Sec. 3. Senator Bennett seconded and the motion carried. Senator Storey moved to report the bill back to the Senate with the recommendation that it be passed as amended, Senator Bennett seconded and the motion carried.


Mrs. Jo Ann Rose representing the Kansas Council of Churches appeared on an amendment to House Bill No. 2016 on page 9 saying the Council opposes gambling where the income is used for revenue. The Rev. William F. Keucher, Executive Minister for the Kansas Baptist Convention also talked briefly and endorsed Mrs. Rose's statements.

House Bill No. 1809, formerly discussed in a hearing, was taken up and Senator Pomeroy moved, Senator Van Sickle seconded, that the bill be amended in the title and reported back to the Senate with the recommendation that it be passed as amended. The motion carried.

The meeting adjourned to meet in Room 523, March 6, 1970 at 11 A.M.

House Bill No. 1832 By Committee on Judiciary
(As amended by House Committee
of the Whole)

Recommends that

"AN ACT relating to the redemption of real property; amending K. S. A. 60-2414, and repealing the existing section."

be amended on page 2 in line 5 by adding the word "only" in lieu of eliminating that word as now printed; and on page 2 in line 6 by inserting a period after the word "mortgagor" and by striking the remainder of line 6, and all of lines 7, 8 and 9;

And that it be further amended on page 7 by deleting all of Sec. 2 and by renumbering Sec. 3 and Sec. 4 as Sec. 2 and Sec. 3;

And that the bill be passed as amended.

MR. PRESIDENT:

Your committee on Judiciary

Recommends that HOUSE BILL No. 1961

"An Act relating to the uniform anatomical gift act; defining death and providing certain rights and duties in connection therewith; amending K. S. A. 1969 Supp. 65-3215 and repealing the existing section."

Be amended:

On page 1, line 1, by striking all after the figure "1."; by striking all of lines 2 to 13, inclusive; in line 14, by striking all preceding the word "Definition"; in line 15, by striking "(A)";

On page 2, line 3, by striking "(B)"; in line 15, by striking "(C)"; and by striking all of lines 18 to 31, inclusive;

On page 3, by striking all of lines 1, 2 and 3; and by striking lines 9, 10 and 11; in line 12, by renumbering section 3 as section 2;

In the title, line 1, by striking "the uniform anatomical gift act;" and inserting in lieu thereof the word "and"; by striking all of lines 2 and 3; in line 4, by striking the word "section";

And the bill be passed as amended.
