SENATE BILL No. 504

With Proposed Senate Committee Amendments by Senator Winter

AN ACT relating to township zoning boards authorizing county commissioners of certain counties to appoint a consolidated township zoning board for townships; prescribing powers, duties, authority and jurisdiction thereof; and providing for compensation of members of such board, amending K.S.A. 19-2902, and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas Section 1. In lieu of appointing a township zoning board or boards for particular townships within a county as provided for in K.S.A. 19-2901, as amended, the board of county commissioners of any county authorized to provide for the zoning in townships by K.S.A. 19-2901, et seq. and which has heretofore or shall hereafter establish more than one township zones, may appoint a consolidated board of township zoning which shall consist of one member of each of the township boards in which township zoning is established by the county commissioners. Members shall be appointed for terms of two (2) years each, and if a new district is established during the tenure of a board, a representative shall be appointed from the township trustees to serve for the same term ending with expiration of the two-year terms. Vacancies shall be filled by the county commissioners for unexpired terms. Members shall each receive ten dollars (\$10) per diem for their services on the board, payable from funds available to the zoning board, and shall receive such traveling expenses as the county commissioners shall authorize.

- Sec. 2 Upon the appointment of a consolidated board of town-ship zoning, the separate board appointed pursuant to K.S.A. 19-2902, as amended, shall be dissolved by the county commissioners.
- Sec. 3. A consolidated board of township zoning appointed in accordance with section 1 of this act shall meet, select officers, keep records in the same manner as provided for township zoning boards under K.S.A. 19-2903, and shall have the same powers and duties as prescribed for such board under K.S.A. 19-2903 et seq. insofar as the same can be made applicable, and shall perform such additional duties as the board of county commissioners shall prescribe

and shall, in all cases, be subject to the jurisdiction and under the control and approval of the board of county commissioners.

Sec. 4. K.S.A. 19-2902 is hereby amended to read as follows:

19-2902. The county commissioners shall appoint five (5) members of
a zoning board for such township which board shall consist of seven

(7) members; five (5) of whom shall be freeholders and residents of
such township; and the county engineer and the township trustee shall
be ex officio members of the zoning board. The appointive members of
the board first appointed shall serve respectively for terms of one
year, two years and three years, divided equally or as nearly equal as
possible between these terms of one, two and three years. Thereafter
members shall be appointed for terms of three (3) years each. Vacancies
shall be filled by appointment for the unexpired term only. Members of
the board shall each receive ten dollars (\$10) per diem as compensation for their services, and shall receive such traveling expenses as
the county commissioners shall authorize.

Sec. 5. K.S.A. 19-2902 is hereby repealed.

Sec. 6. This act shall take effect and be in force from and after its publication in the statute book.
