Senate Bill No. 361 The above listed guests presented the views of the Kansas Bankers Association, represented by Mr. Stones, as well as their individual opinion. The conversation centered mainly around the difference between the 20 million dollars provision on page 4 of the bill as opposed to 40 million which was originally drafted. No action was taken by the committee until the guests had been dismissed. At that time, Senator Hinchey made a motion that the committee report the bill unfavorably, his motion was seconded by Senator Robinson and carried. The only dissenting vote was that of Senator Thomas.

On a motion by Senator Shultz, seconded by Senator Pomeroy, it was voted to recommend SENATE BILL NO. 98, unfavorable for passage.

Senate Bill No. 116 On a motion by Senator Robinson, seconded by Senator Foster, it was voted that the bill be not passed.

Senate Bill No. 119 On a motion by Foster, seconded by Senator Robinson, it was voted to recommend that the bill not be passed.

Senate Bill No. 182 On a motion by Senator Shultz, seconded by Senator Hinchey, it was voted to recommend that the bill not pass.

Senate Bill No. 330 On a motion by Senator Shultz, seconded by Senator West, it was voted to recommend that the bill not pass.

Senate Bill No. 383 On a motion by Senator Thomas, seconded by Senator Shultz, it was voted to recommend that the bill not pass.

Senate Bill No. 385 On a motion by Senator Shultz, seconded by Senator West, it was voted to recommend that the bill not pass.

Senate Bill No. 444 On a motion by Senator Thomas, seconded by Senator Saar, it was voted to recommend that the bill not pass.

Except as otherwise noted, the individual remarks recorded herein have not been transcribed verbatim and this record has not been approved by the committee or by the individuals making such remarks.

Senate Bill No. 467 On a motion by Senator Shultz, seconded by Senator Pomeroy, it was voted to recommend that the bill not pass.

Senate Bill No. 504 On a motion by Senator Shultz, seconded by Senator Robinson, it was agreed to amend the bill. A copy of the amended version of the bill is attached.. On a motion by Senator Shultz, seconded by Senator Saar, it was voted to recommend the bill favorable for passage as amended.

Senate Bill No. 540 On a motion by Senator Thomas, seconded by Senator West, it was voted to recommend that the bill not pass.

Senate Bill No. 547 On a motion by Senator Shultz, seconded by Senator Pomeroy, it was voted to recommend that the bill not pass.

Senate Bill No. 614 On a motion by Senator West, seconded by Senator Thomas, it was voted to recommend that the bill not pass.


Senate Bill No. 617 Mr. Poppewell, Southwestern Bell Telephone, expressed the views of his organization to the committee. After his dismissal by the committee, Senator Shultz made a motion that the bill be recommend unfavorably to the Senate. The motion was seconded by Senator Foster and carried.

Senate Bill No. 618 On a motion by Senator Thomas, seconded by Senator West, it was voted to recommend the bill favorable for passage to the full Senate.
