Today was the last day for House consideration of House Bills in Committee.

Mr. Steffes made a motion, second by Mr. Wilson, that

House Bill 1012 be carried over until next year. Motion carried.

(Chairman Dierdorff told the Committee Mr. Linde had made the request to carry the bill over as Mr. Nader told him he would appear on it next year.)

Mr. Jacobs made a motion, second by Mr. Spotts, that House Bill 1013 be reported unfavorably. Motion carried.

Mr. Allison made a motion, second by Mr. Lady, that House Bill 1172 be reported unfavorably. Motion carried.

Mr. Lady made a motion, second by Mr. Wilson, that House Bill 1283 be reported unfavorably.

Mr. Rosenau made a substitute motion, second by Mr. Ratner, that House Bill 1283 be held over in committee. Motion carried.

After discussion, the committee worked out the following amendment for House Bill 1294: On page 1, line 3, by striking the word "suspended" and inserting in lieu thereof the word "altered"; in line 6, by inserting before the word "motor" the word "passenger"; also in line 6, by deleting "suspend"; in line 7, by deleting "ed" and inserting in lieu thereof "which has been altered"; in line 9 by deleting the word "suspended" and inserting in lieu thereof the word "altered";

Mr. Hayes made a motion, second by Mr. Wingert, that the above amendments be adopted for House Bill 1294. Motion carried.

Mr. Rosenau made a motion, second by Mr. Wingert, that House Bill 1294 be passed as amended. Motion carried.

After discussion by the committee, Mr. Lady made a motion, second by Mr. Gray, that House Bill 1245 be held in committee and we try to work out something from HB 1245 and Senate Bill 137. Motion carried. (13 YES)

Mr. Ratner made a motion, second by Mr. Jacobs, that

House Bills Nos. 1092, 1136, 1126 be held in committee with

the possibility of being amended into Senate Bill 137 if it

should receive favorable consideration by the committee. Motion
carried.

Mr. Hayes presented the following amendment to House

Bill 1435: On page 1, in line 1 of the paragraph numbered

"(1)" of the preamble. by striking "Hays" and inserting in

lieu thereof "Hutchinson"; on page 4, line 1, by striking "Hays"

and inserting in lieu thereof "Hutchinson"; on page 12, in

line 10, by striking all after "exceeding" in line 11, by

striking "(\$180,000,000)" and inserting in lieu thereof

"(\$80,000,000)"

Mr. Hayes made a motion, second by Mr. Allison, that House

Bill 1435 be amended as suggested above. Motion carried.

Mrs. Hayes made a motion, second by Mr. Allison, that
