Senator Thomas discussed the Home Rule for Counties and will have this drafted into a Senate Resolution for study by the committee.

Discussion was held on the concurrent resolution proposed by Senator Moore. The committee agreed that Senator Moore should go ahead and sponsor this resolution.

Senator Bell appeared before the committee to discuss his S.B. #582. Senator West made the motion S.B. #582 be reported adversely, Senator Robinson seconded. Vote 9-0. Carried. S.B. #582 is hereby reported adversely.

Lahoma Dennis and Mr. Rufus Hays appeared as proponents for S.B. #513. Printed testimony was presented to the committee. Sebatir Pomeroy made the motion to amend S.B. #513 on page two, line one, by inserting the word and and striking the comma after the word facials; and on page two, line one, striking the word dye and inserting the word services; and on page two, line two, striking the words and sterilization and inserting a semi-colon after the word sanitation. Senator Thomas seconded, vote 9-0 S.B. #513 is hereby amended. Carried.

Senator West made the motion to amend S.B. #513 on page five, line twenty-four, striking, Provided, All instructors engaged in teaching the profession of cosmetology at the time of the taking effect of this act, shall be issued an instructor's license, valid for three years, and inserting a period after the word period. Senator Pomeroy seconded, vote 9-0. Carried. S.B. #513 is hereby amended.

Senator Thomas made the motion that S.B. #513 be reported favorably as amended. Senator Booth seconded. Vote 9-0. Carried. S.B.#513 if hereby reported favorably as amended.

Senator Thomas made the motion that S.B. #191 be reported adversely and Senator Robinson seconded the motion. Vote 9-0. Carried. S.B. #191 is hereby reported adversely.

Senate Bill #512 discussed. Senator Pomeroy made the motion to amend S.B. #512 on page four, line eighteen, striking the words army, navy or marine hospital service after the words the Unites States and inserting a semi-colon. Senator Booth seconded. Vote S.B. #512 is hereby amended. Carried. Senator Pomeroy made the motion to amend S.B. #512 by restoring

lines 19 and 20 on page 4. Senator Thomas seconded. Vote 9-0. Carried. S.B. #512 is hereby amended. Senator Gaar asked that Mr. Baxter submit any further amendments in a clear workable manner so that the committee can work with them.

Senate Bill #427 discussed. Senator Foster made the motion that S.B. #427 be reported favorably for passage. Senator Robinson seconded. Vote 9-0. Carried. S.B. #427 is hereby reported favorable for passage.

Senators Garr and West will analyze the Civil Rights Bill for presenting this to committee.

Senator West is analyzing public employees bill S.B. #146, and is in favor of the concept. Would like to amend bill to 60 days maximum paid sick leave.
