Senator Robinson made the motion that S.B. 551 be reported favorable

for passage as amended. Senator Hinchey seconded. Vote 9-0. Carried. S.B. 551 is hereby reported favorable for passage.

Senator Pomeroy discussed a policy matter regarding credit unions with the committee. In reference to the by-law forms of the Topeka Teachers Credit Union vs. the Public Employee Credit Union. Senator Pomeroy made the motion that this statutory matter be prepared as a proposition for committee introduction and be referred back to the committee for study. Senator West seconded the motion.
