S.B. 641 discussed. Senator Pomeroy made the motion to amend S.B. 641 on page 1, line 3, by inserting after the word "members" the words "no more than five of whom shall be members of the same political party" with Senator Herd seconding, Vote 10-0. Carried. S.B. 641 is hereby amended. Senator Herd made the motion to amend S.B. 641 on page 1, line 3, by inserting after "and" the words "each congressional district in the State of Kansas shall be represented on said commission by at least one member who shall be a resident thereof at the time of his appointment.", and on page 1, line 3 by "striking" the word "who", and on page 1, line 4, by inserting the words "Commission members" before the word "shall" with Senator West seconding. Vote 10-0. Carried. S.B. 641 is hereby amended.

Senator Thomas made the motion that S.B. 641 be amended on page 2, line 21, by striking the "period" after the word "office and inserting the words "and his salary shall be established by the state finance council". Senator Booth seconded. Vote 10-0. Carried. S.B. 641 is hereby amended. Senator Thomas made the motion that S.B. 641 be amended on page 2, line 19 by inserting after the word "director" the words "who shall serve at the pleasure of the commission." Senator Pomeroy seconded. Vote 10-0. Carried. S.B. 641 is hereby amended.

Senator Pomeroy made the motion that S.B.,641 be reported favorable as amended with Senator Herd seconding. ote 10-0. Carried. S.B. 641 is hereby reported favorable for passage as amended.

S.B. 557 discussed. Senator Thomas made the motion that the committee adopt the amendment Chairman Gaar presented by request for Senator Van Sickle, and that S.B. 557 be amended on page 1, line 9 by inserting after the period the following: "Upon request of two or more members of the finance council, exclusive of the governor, and with at least three days notice of such request given to the secretary of the council, an item shall be placed on the agenda of the next meeting." Robinson seconded. Vote 10-0. Carried. S.B. 557 is hereby amended. Senator Pomeroy made the motion to amend S.B. 557 on page 1, line 9, after the word "given" by inserting "at least three days" with Senator Foster seconding. Vote 10-0. Carried. S.B. 557 is hereby amended. Senator Thomas made the motion that S.B. 557 be reported favorable for passage as amended with Senator Booth seconding. Vote 10-0. Carried. S.B. 557 is hereby reported favorable for passage as amended.
