Vice-Chairman Pomeroy called the meeting to order.

S.B. 512 discussed. Senator Pomeroy presented the proposed amendments of the subcommittee (consisting of Pomeroy and Foster) as such: On page 2, by striking all of lines 11 to 23, inclusive; on page 3, in line 11, by striking "sworn";, in line 31, by striking all after the period:

On page 4, by striking all of lines 1 and 2; and in line 3, by striking all before the period and inserting in lieu thereof the following; "Within thirty (30) days after the withdrawal or the termination of any student, the owner or manager of each school or college shall notify the state board of barber examiners of said withdrawal or termination and forward to the board a copy of the student's record of attendance and completed instruction. Each school or college shall furnish to the state board of barber examiners at least fifteen (15) days prior to the date of anticipated graduation a certified summary of each student's grades, hours and attendance to date, and the proposed date of graduation"; in line 8, by inserting "1971 Supp." after "K.S.A." in line 12, by inserting before the period the following: "Provided, That nothing in this act shall prohibit the board from licensing a manufacturer to conduct a demonstration of his product without charge, at a place open to the general public, for a period not to exceed three (3) day"; in line 18, by striking "army, navy, or marine hospital service"; in line 19, by striking "and" where it first appears in said line; in line 20, by inserting before the period the following; "; and (e) licensed cosmetologists and apprentices"; in line 24, by striking "statute book"; and inserting in lieu thereof "official state paper"; Senator Ball moved the adoption of the amendments with Senator Thomas seconding. Vote 8-0. Carried. S.B. 512 is hereby amended.

Senator Ball made the motion to report S.B. 512 favorable for passage as amended with Senator Herd seconding. Vote 8-0. Carried. S.B. 512 is hereby reported favorable for passage as amended.

S.B. 577 discussed. Senator Hinchey made the motion to report S.B. 577 favorable for passage with Senator Robinson seconding. Semator Herd made a substitute motion that this action be delayed one day with Senator Ball seconding. Vote 4-4. Substitute motion failed. Vote on Senator Hinchey's motion to report S.B. 577 favorable for passage 4-4. Primary motion failed.

S.B. 430 discussed. Senator Hinchey made the motion to report S.B. 430 favorable for passage with Senator Robsnson seconding. Vote 5-3 Sneators Saar, Ball, West, Thomas, Pomeroy "No", Booth, Robinson and Hinchey "Yes". Vote failed.

Senator Gaar stated Senator Hinchey has the permission of the committee to bring either or both of these bills up for consideration again.
