MINUTES OF THE COMMITTEE ON Federal and State Affairs
Held in Room 510 , at the Statehouse at $2:45$ $max_m./p.m.$, on
January 20 , 1975.
All members were present except: Representative Mikesic ,,
Conferees appearing before the Committee were: Mr. Bob Alderson of
the Revisor's office, and Mr. Russ Mills of the Research Department
The Committee considered the following items: House Bills 2021, 2013, 2022 and 2027.
Mr. Alderson explained that the Revisor's office has a statutory obligation to review statutes and suggest repeals to the proper committee when statutes have been found incorrect. He explained that HB 2021 is such a matter, and specifically has been drafted to take care of a repealer at an earlier date. Mr. Alderson stated that HB 2022 deals with a statute which was repealed in 1949, and that it was replaced by 79-3837. This bill is simply a clean-up amendment. HB 2027 is a matter brought to the attention of the Revisor by the Real Estate Commission, and is another clean-up amendment.
It was moved by Mr. Ward and seconded by Mr. Cooper that HB 2021 be recommended for passage and placed on the Consent Calendar. Motion carried without dissent.
It was moved by Mr. Ungerer and seconded by Mr. Cooper that HB 2022 be recommended for passage, and placed on the Consent Calendar. Motion carried without dissent.
It was moved by Mr. R. Miller and seconded by Mr. Cooper that HB 2027 be recommended favorably and placed on the Consent Calendar. Motion carried without dissent.
Russ Mills discussed HB 2013, which resulted from an interim study on Proposal No. 34. He explained that all of the sections deal with statutes which the computer picked out as being sexually biased; that in general, it changes the wording to denote "person" rather than male or female. He went through the bill section by section and after discussion on certain sections, it was agreed to accept the bill as written and the motion as mentioned above was passed. It was recommended that when the bill is reprinted it should be amended on page 10, line 9 (cont'd.)

by re-inserting the word "employ" where it has been stricken.

The Chairman mentioned that HB 2034 repeals the sections providing for joint conventions of the House and Senate; that because of the proposed joint rules which may be adopted, perhaps action should be delayed.

The Chairman suggested that although HB 2032 is probably not controversial in that it deals with the pre-organizational meeting where the House and Senate leadership is elected, it should perhaps be explained by someone from the Revisor's office.

The Chairman displayed a bill which the committee has been requested to introduce. He explained that it concerns places in the state where alcholic beverages can be served, and amends the existing statute insofar as residences of state officials and employees in certain categories is concerned.

It was moved by Mr. Morris and seconded by Mr. Cooper that this bill be introduced as a committee bill. Motion carried without dissent.
