House Bill 3203 - Garnishment to enforce support orders. Mr. Griggs explained that this bill had been requested in order to deal with the situation of a person who was in the armed services and who had become very delinquent in support payments.

House Bill 2709 - Crimes, contributing to miscondict or deprivation of a child and aggravated juvenile delinquency. Following committee discussion, Senator Parrish moved that the amendments previously placed on the bill be stricken; Senator Steineger seconded the motion, and the motion carried. Further action on the bill was postponed.

House Bill 2147 - Prohibiting disclosure of certain arrests, declare certain acts to be a crime and providing for nondisclosure of certain arrests. Following committee discussion, including the suggestion that the subject matter of the bill could be dealt with in HB 2711, Senator Steineger moved to report the bill adversely; Senator Hess seconded the motion, and the motion carried.

House Bill 2711 - Expungement and annulment of certain convictions. Following committee discussion, Senator Hein moved to amend the bill to provide for expungements of arrests; Senator Hess seconded the motion, and the motion carried. Senator Steineger moved to strike the word "entire" in line 27; Senator Parrish seconded the motion, and the motion carried. Senator Steineger moved to strike section 3 and make appropriate references to the provisions of SB 408; Senator Parrish seconded the motion, and the motion carried. Senator Parrish moved to amend the bill to provide that it would apply to expungements or annulments under the old law; Senator Hein seconded the motion, and the motion carried. Senator

Parrish moved to report the bill favorably as amended; Senator Simpson seconded the motion, and the motion carried.

House Bill 3114 - Probate proceedings providing limitation on inheritance by minors after a felonious killing. The chairman explained proposed amendments to the bill suggested by Ben Farney. Following committee discussion, Senator Hein moved to amend the bill to follow the suggestions made by Mr. Farney; Senator Parrish seconded the motion, and the motion carried. Senator Parrish moved to strike section 1 of the bill; Senator Simpson seconded the motion, and the motion carried. Senator Parrish moved to report the bill favorably as amended; Senator Simpson seconded the motion, and the motion carried.

House Bill 3226 - Legal entities required to file documents with the secretary of state. Following committee discussion, Senator Hess moved to amend the bill in accordance with the suggestions for clean up changes; Senator Parrish seconded the motion, and the motion carried. Senator Simpson moved to report the bill favorably as amended; Senator Mulich seconded the motion, and the motion carried.

House Bill 2717 - Sub. for HB 2717; liens on residential property, warning statements. Following committee discussion, Senator Burke requested that staff prepare balloon copies of suggested amendments.

House Bill 3031 - Disposition of life insurance in divorce proceedings. Following committee discussion, Senator Steineger moved to report the bill adversely; Senator Mulich seconded the motion, and the motion carried.

House Bill 2713 - Uniform child custody jurisdiction act. During committee discussion of the bill, it was pointed out that this bill has conflicts with HB 3031 and SB 780. Action on the bill was postponed to see what disposition the House Judiciary Committee makes of SB 780.

House Bill 3005 - Liens, service of lien statements. Senator Hein moved to amend the bill by changing "any one" to "all"; Senator Simpson seconded the motion, and the motion carried. Following further committee discussion, Senator Simpson moved to report the bill adversely; Senator Steineger seconded the motion, and the motion carried.

The meeting adjourned.

PROPOSED AMENDMENT TO K.S.A. 59-2242 By Ben Farney

59-2242. Sale of personal property. A petition for the sale of personal property of a decedent may be heard with or without notice. The order of sale shall describe the property, and direct whether it shall be sold at private sale or public auction. No sale of personal property shall be made at private sale for less than three-fourths of the valuation pursuant to K. S. A. 59-1201, or in the event of appraisement, the appraised value pursuant to K. S. A. 59-1202. [L. 1939, ch. 180, § 218; L. 1976, ch. 245, § 11; July 1.]

59-2242. Sale of Personal Property. A petition for the sale of personal property of a decedent may be heard with or without notice. The order of sale shall describe the property, and direct whether it shall be sold at private sale or public auction. No sale of personal property shall be made at private sale for less than three-fourths of the valuation pursuant to K.S.A. 59-1201, or in the event of an appraisement, for no less than three-fourths of the appraised value so determined pursuant to K.S.A. 59-1202.
