House Bill No. 2034 - Criminal procedure, prohibiting disclosure of certain arrests. The staff reviewed the fiscal note on the bill.

Tom Kelly testified that the Kansas Bureau of Investigation feels that the bill has some defects that would hamper the system. He stated it would be in conflict with having a jail calendar; it would alter information handling practices of several state and local agencies; it will not have any effect on agencies outside of Kansas. He testified the intent of the bill is good but the application would be difficult. Committee discussion with him followed.

Representative Ferguson, the author of the bill, testified in support of his bill. Committee discussion with him followed.

House Bill No. 2501 - Court costs in mental illness cases. Representative Martin, the author of the bill, testified in support of the bill, which he said was introduced at the request of his district judge.

Mike Boyer of the GCCA testified with regard to concerns about obtaining statistics, and suggested that the bill be amended in lines 28 through 32.

Fiscal year 1978: 191 admissions of which 27 were committed Class A, B, or C felonies. (14%).

Average length of stay (all admissions) for FY 1978 was 345 days.

Per diem costs was \$45.38.

Therefore, the charge back to counties in FY 1978, would be \$2,567,600.40 (164 x 345 x 45.38), for all non A, B, or C felonies.

First Half of FY 1979: 88 admissions of which 14 were committed for Class A, B, or C felonies. (16%).

Average length of stay (all admissions) for first half of FY 1979 was 323 days.

Per diem costs established by Governor for 1979, is \$51.49, so if the trend continues for the rest of FY 1979, YCAT can expect about 148 non- A, B, or C felonies who will be there an average of 323 days at \$51.49 per day or \$2,476,669.00 would be charged back to the counties.

Governor's recommended FY 1980 budget for community corrections was \$2,415,000. FY 1979 was approximately \$480,000.

I was unable to find exact data on the YRC'c, but it can be noted that their per diem costs were higher in 1978 (TSH - \$84.19; OSH - \$59.94; LSH - \$66.25). If the average length of stay was 340 days, average population at capacity and average A, B, or C felonies 15%, charge backs to the counties would total as follows for FY 1978:

YRC's:

TSH (15 beds) - \$ 364,963.00 OSH (45 beds) 779,519.00 LSH (30 beds) 574,387.00 \$1,718,869.00

About the only conclusions we can draw from these figures is that if all counties participated in the community corrections act, charge backs to counties for non-A, B, and C felonies for commitments to YCAT and the three YRC's, would total approximately \$4,286,469 for FY 1978.
