The chairman reported to the committee the senate bills which still remain in the House Judiciary Committee, following its final meeting for this session.

House Bill No. 2012 - Juvenile code, out-of-home placement of juveniles. Representative Glover testified in support of proposed amendments relating to the inclusion of the contents of Senate Bill 379 into this bill. Committee discussion with him followed.

Senator Parrish moved to amend the bill regarding educational assessments; Senator Hess seconded the motion, and the motion carried. Mr. Griggs reported that Senate Bill 113 passed the House this morning and explained the conflict with this bill. Senator Parrish moved to resolve the conflict by amending this bill; Senator Hess seconded the motion, and the motion carried. Senator Parrish moved to report the bill favorably as amended; Senator Burke seconded the motion, and the motion carried.

House Bill No. 2124 - Criminal trespass in divorce cases. The chairman reminded the committee that all of the content of this bill was included in House Bill 2619, and consequently this bill was available as a vehicle for other bills which have previously passed the Senate but seemed to be having difficulty moving in the House. The chairman pointed out that Senate Bill 42 seemed to be having calendar difficulties in the House. Following committee discussion, Senator Parrish moved to strike the portion of House Bill 2124 that was duplicated in House Bill 2619 and to further amend it by including the provisions of Senate Bill 42 as that bill passed the Senate; Senator Hess seconded the motion, and the motion carried. pointed out to the committee that in the House Judiciary Committee, Senate Bill 110 had been amended to include the marihuana provisions and therefore was having calendar difficulties. Following committee discussion, Senator Simpson moved to incorporate the provisions of Senate Bill 110 as it passed the Senate into House Bill 2124; Senator Berman seconded the motion, and the motion carried. The chairman distributed copies of House Bill 2144 which dealt with unclassified misdemeanors. Following committee discussion, Senator Berman moved to amend the content of House Bill 2144 into House Bill 2124; Senator Parrish seconded the motion, and the motion carried. Senator Parrish moved to report the bill favorably as amended; Senator Berman seconded the motion, and the motion carried.

House Bill No. 2059 - Require district courts to submit juvenile statistics to SRS. The chairman reported that he has not yet received a reply from the Judicial Administrator.

The meeting adjourned.
