Chairman Beezley called the meeting to order and asked the sponsor of a group of high school students to tell about their granization. The sponsor, Gene Miles, Seaman High School stated that organization, Close Up is composed of a group of seventeen northeast Kansas schools. Many of the students in the group had been to Washington, D.C. to attend committees and seminars; to watch government in action.

Rep. Crowell made a statement to the fact that Mr. Walsh, who appeared before the Committee yesterday, was here strictly for information purposes only and had no bearing on how the bill would be handled. Rep. Crowell commented that it would be good to wait and see what Iowa does and let the bill lay until next year.

HB 2390 - Grain Storage Indemnity Fund

Raney Gilliland, Research Dept., gave a brief outline of the bill.
Rep. Hamm stated that this bill is patterned after Oklahoma law.
It is of interest to farmers this year, as also is the Missouri case.
Rep. Hamm passed out a paper showing losses that certain grain elevators had. (See Attachment I) He stated that farmers need some kind of protection. After Rep. Hamm finished his presentation he stated that he would be glad to answer any questions. Many of the members responded with their questions and comments.

Mr. Tom Tunnell, Ks. Grain & Feed Dealers stated that this organization involves about 95% of the grain business, both co-op and independent. Mr. Tunnell said that there had been quite a discussion among upper level managers regarding this bill. They are not going to oppose the bill, but are not going to be proponents of the bill either. His organization would like to see this bill tabled until it can be brought before a study committee. Mr. Tunnell was very concerned about the Missouri case. He stated that we must maintain the integrity and credibility of warehouse receipts. We want to have the strict restrictions. Some members of his organization would like to see a criminal prosecution clause put into the bill. Asked about his feeling toward state licensing of all elevators, Mr. Tunnell replied that he would have no objection as he feels the state inspectors are competent and he thinks highly of them.

Mr. Scott Woodbury, General Manager, Burlingame Co-op Elevator, Burlingame, KS., came to address the Committee from a local point of view. He stated that question why should a reputable firm subsidize someone that is not in good shape. He commented that 90% of the firms that go bankrupt do so through poor management. Mr. Woodbury answered several questions put to him by Committee members.

Mr. John Miller, Committee of Kansas Farm Organizations, spoke briefly. He recommended that an interim study be done of this bill.

Chairman Beezley thanked the conferees, reminded the Committee of the next day's meeting and asked for action on the minutes. The minutes were approved and the meeting was adjourned.
