HB 2038 - Board of education of USD 269 authorized to transfer land.

Representative Leary Johnson, author of the bill, appeared before the Committee and asked for a favorable response to the legislation. He said the building, formerly a public school, had been unoccupied since 1977. Mr. Johnson said the city planned to use the facility as a civic center. (Attachment A)

HB 2080 - Unified school district No. 241, tranfer of land to township.

Representative Crumbaker, author of the bill, said the legislation would allow USD 241 in Wallace County to transfer the land and buildings to Harrison township to be used for a township hall and community center. He stated the USD 241 Board of Education had agreed unanimously to make this transfer. Representative Crumbaker asked the Committee to give favorable consideration of the legislation.

Representative Crumbaker announced that he would like for three School Finance proposals to be introduced as Committee Bills. One would be the Governor's proposal, one would set the budget limitations at 102-104% and another would set limitations of 103-106%. A motion was made by Representative Apt, seconded by Representative Moomaw to introduce the three proposals as Committee Bills. The motion carried.

Representative Hassler moved that legislation be introduced as a Committee Bill regarding transfer of funds as requested by the Governor. Representative Myers seconded the motion and the motion carried.

Representative Lowther requested that a Committee Bill be introduced which would cap, at the present level of \$39.4 million, the Transportation Aid distributed to USD's.

Mr. Lowther so moved his request which was seconded by Representative Fuller. The motion carried.

The Chairman adjourned the meeting.

Subject: House Bill 2038

Mr. Chairman, members of the committee, I appreciate the opportunity to bring before you House Bill 2038.

The subject bill authorizes the Unified School Disctict No. 269, in Rooks County, to transfer a tract of land and associated structures to the city of Zurich. Such transfer shall be made by quit claim deed for consideration of \$1 and other conditions as mutually agreed upon by both parties.
