Chairperson Harper called the Elections Committee meeting to order. The first bill up for consideration was HB 2524, An Act relating to elections; concerning the recall of elected public officials.

Representative Baker made a motion to pass out HB 2384 favorably as amended. Representative Kline seconded.

Representative Fox made a substitute motion to restrict it to matters of local public interest, rather than statewide. Representative Moomaw seconded.

At this time, Representative Fox withdrew his substitute motion.

Representative Fox made a substitute motion to strike line 37, or state and line 23. Representative Dean seconded.

Representative Justice supports HB 2384 in the form of its original motion and wishes to send it down to the entire House.

Representative Fox at this time withdrew his substitute motion, and back now to the original motion to pass the bill out favorably as amended. Motion carried.

HB 2280 was next on the agenda for discussion and final action.

It was moved that the Committee adopt the amendments passed out to the Committee by Representative Fox. Representative Blumenthal seconded. Motion carried.

Representative Dean moved that the Committee pass out HB 2280 as reported favorably as amended. Seconded by Representative Acheson. Motion carried.

HB 2488 was the next order of business on the agenda.

Representative Dean made a motion to strike line 43, which reads Individual expenditures of less than \$1 shall not be required to be reported under this subsection (b). Seconded by Representative Acheson. Motion carried.

Representative Crumbaker moved to pass HB 2488 favorably as amended. Seconded by Representative Fox. Motion carried.
