The following committee action was taken:

 $\underline{\text{SB }122}$, Concerning certification of agents; providing for rules and regulations; amending K.S.A. 40-241i and repealing the existing section.

Chairman Hoy briefly explained the bill. Rep. Long moved to pass SB 122 out favorably. Rep. Cribbs seconded the motion. The motion carried.

 $\underline{\mathtt{SB}\ 124}$, Concerning coverage of health care benefits; concerning the jurisdiction of the Commissioner.

Chairman Hoy briefly explained the bill. Rep. Cribbs moved to pass SB 124 out favorably. Rep. Spaniol seconded the motion, and the motion carried.

 $\underline{\text{SB }134}$, Concerning the revocation or suspension of agent's or broker's license, amending K.S.A. 1982 Supp. 40-242 and repealing the existing section.

Chairman Hoy briefly explained the bill. Rep. Leary Johnson asked for some of the reasons an agent's license might be revoked. Dick Brock of the insurance department gave several reasons, and explained the administrative process involved. Rep. Sutter moved to pass SB 134 out favorably. Rep. Cribbs seconded, and the motion carried.

 $\underline{\text{SB }145}$, Concerning insurance holding companies; amending K.S.A. 40-3304 and repealing the existing section.

Chairman Hoy briefly explained the bill. Rep. L. Johnson moved to pass out SB 145 favorably. Rep. Fuller seconded. The motion carried.

SB 157, Concerning life insurance companies and other than life insurance companies; relating to investments; amending K.S.A. 40-2a08, 40-2a12, 40-2a16, 40-2b06, 40-2b07, 40-2b09, 40-2b13 and 40-2b20 and K.S.A. 1982 Supp. 40-2a09, 40-2a13 and 40-2b10 and repealing the existing sections.

Chairman Hoy gave a brief explanation of the nine changes the bill proposed. There was some discussion on who would benefit if the bill is passed. Rep. Spaniol moved to report SB 157 adversely. Rep. Long seconded the motion. Rep. Turnquist offered a substitute motion to table SB 157. Rep. Sutter seconded. There was a brief discussion on tabling, and Chairman Hoy brought out that the bill could be brought out of tabling by a vote of over 50%. Chairman Hoy asked Dick Brock for an explanation of the bill, and there was further discussion. A vote was taken on the substitute motion to table. Ten voted in favor, four in opposition, so the bill was tabled.

Rep. Sutter moved to adopt the minutes of March 15, 1983, and March 21, 1983. Rep. Cribbs seconded, and the motion carried.

The meeting adjourned at 4:00 PM.
