The meeting was called to order for the purpose of discussing SB 157, which was tabled at the meeting of March 22, 1983. Rep. Littlejohn moved to take SB 157 off the table. Rep. Fuller seconded. The motion carried. Rep. Blumenthal moved to pass SB 157 out favorably. Rep. Cribbs seconded the motion. Chairman Hoy said there were some technical amendments that should go on, and Gordon Self of the Revisor's Office passed around Attachment 2 and explained the amendments which had been suggested by the insurance department. Rep. Blumenthal said he would re-make his motion to say pass out SB 157 as amended. Rep. Cribbs said his second to the motion would be changed also to include "as amended". Rep. Spaniol said he had several amendments to offer but would offer them on the floor and debate the bill then, rather than taking up more time for the committee. He said he thought the committee members should ask themselves how this bill would benefit the Kansas consumers; he did not think it would benefit them in any way. A vote was taken on the motion to pass out favorably as amended, and the motion carried. Rep. Baker and Rep. Spaniol asked to be recorded as voting No.
