Proposal Regarding Age Discrimination in Employment

Representative Duncan presented a proposal to prevent the practice of discrimination against an employee because of age. Provisions of the proposal would be based on a federal model act (Attachment No. 1). Representative Justice moved that the Committee introduce the proposal as a bill, seconded by Representative Harper. Motion carried.

Proposal Regarding Preliminary Hearings

Jim Clark, Kansas County and District Attorneys Association, said the proposal provides for a preliminary hearing before a magistrate for persons charged with a felony and would cut down on time spent on preliminary hearings. Representative Justice moved that the proposal be introduced as a bill, seconded by Representative Duncan. Motion carried.

HB 2269 - An act relating to paramilitary training.

A hearing was held on the bill. General Ralph Tice, Adjutant General, spoke in support of the bill and urged the Committee to outlaw the military training of militant groups that has no place outside of the military. When the National Guard is called to assist in civil disorders, they should not be faced with automatic weapons, grenades, and guerilla warfare. He had no objections to groups of sportsmen getting together for target practice and firearms instruction.

In discussion, General Tice said military schools are established under Kansas law and would not come under provisions of HB 2269. A member questioned the exemption in the bill of the National Guard, armed forces, and law enforcement officers which, in his opinion, would infer that all other groups would be subject to the bill. How the bill would affect the state militia was mentioned. General Tice said only the State of Kansas can train its militia.

Tom Kelly, Director of the KBI, gave a statement supporting the bill (Attachment No. 2). In discussion, a member noted Mr. Kelly's statement contained no evidence of intent of the group to cause civil disorder which would make such a case hard to prosecute. Mr. Kelly said information in his statement came from an undercover law enforcement officer who attended the

classes. There are leaders who advocate the violent overthrow of the government and in stockpiling arms.

Jim Flory, Office of the Attorney General, said there is potential danger from segments in the community that won't hesitate to use paramilitary training. Although HB 2269 would not cure all the problems, it was a step in the right direction and provides law enforcement and prosecutors a tool to deal with people who intend to carry out acts of violence. Prosecutors would have to prove paramilitary training had been planned for illegal purposes.

In discussion, the federal civil disobedience act dealing with civil disorders was mentioned. It was noted the Committee should have a summary of this legislation.

Allen Katchen, Plains States Regional Director of the Anti-Defamation League of B'nai B'rith, supported the bill, which is based on the ADL model bill. His group is concerned with the security of minority groups and keeps what it believes are anti-democratic and racist groups under surveillance. He believed the groups involved in paramilitary training were potentially the most dangerous and most prone to violence. He furnished information published by the Posse Comitatus group (Attachment No.3). He noted the Attorney General believes this group is a growing terroristic threat. Mr. Katchen also furnished news articles from the Kansas City Star (Attachment No.4) and mentioned a radio broadcast from Dodge City radio station KTTL-FM that urged listeners to go out and get guns to kill Jews. The ADL has evidence that extremist, paramilitary groups have ties with foreign terroristic groups. He compared paramilitary training with the early stages of Nazism and the rise of Hitler which were not taken seriously at the time.

During questioning, Mr. Katchen said the ADL suspected but had no evidence extremist groups in America were being furthered by the Soviet Union, but this aspect should be considered in this legislation.

John Chambers said he appeared as an individual but, as a newsman, has had occasion to study these groups. His statement is attached (Attachment No.5) and supports HB 2269. The statement also contains remarks made by Posse Comitatus members and those of other groups.

Wendell Wiebe, Jubilee Mennonite Church, supported the bill and believed it would help protect against Communism.

Denny Burgess, Kansas Wildlife Association, stated his group has problems with the bill and present statutes would cover the intent of HB 2269. By exempting law enforcement officers, the National Guard, and the military and not other groups, the bill would affect hunter safety programs, gun clubs, etc.

Lewis Elliott, Regional Director for the National Rifle Association, opposed the bill. He stated he had received many phone calls from concerned sportsmen in the state. Present law already outlaws civil disorder, murder, and possession of certain weapons and explosives. He mentioned the proof of intent requirement in the bill and noted it would be impossible to know a person's intent or if that person was a member of an extremist group when taught the use of a gun in hunter safety programs and gun club activities. He questioned how activities such as occurred at Weskan, Kansas, could be outlawed when the type of information taught in those classes could be obtained by mail and at libraries. Mr. Elliott said he objected to the bill because there may be an Attorney General who may not feel the same as he does about gun ownership and paramilitary organizations. He said the bill would be more acceptable if it contained exemptions to protect gun and sportsmen's clubs, but, in his opinion, HB 2269 was unnecessary. Mr. Elliott was requested to submit suggestions for amendments to the Committee.

Del Goheen, President, Kansas Rifle Association, gave a statement in opposition to HB 2269 (Attachment No.6). He stated groups that are violating existing laws will also violate this law. He noted the Kansas Rifle Association does not condone or have anything to do with the Posse Comitatus.

Mike Reed, member of the Mill Creek Rifle Club and the International Practical Shooters Association, Kansas City, pointed out language in the bill that, as a former prosecutor, he believed was objectionable and which could be given many different interpretations. Provisions were too broad, and present law already covered the intent of the bill. He suggested the bill could simply state it is unlawful to train people to break the law and provisions should be made as narrow as possible to accomplish its purpose.

Tom Wempe opposed the bill and stated he appeared as an individual representing no group. He questioned if Mr. Kelly's report (Attachment No.2) came from the KBI or the Attorney General. He quoted from what he said was the conclusion of this report, not contained in Attachment No. 2, which concluded that the Weskan activities did not teach anything that could not be learned from military information sent through the mail and textbooks. In his opinion, at Weskan there was no instruction in making illegal machine guns, and instructors stressed that everything be done legally. He believed HB 2269 violated the Kansas and U. S. Constitutions which provide that the country must be defended from all enemies, both within and without. The bill enslaves people and is Communistic. Mr. Wempe was asked if he believed HB 2269 was Communist inspired. He said it was another step in the gradual takeover of the country, and the takeover creates an obligation for people to take up arms in defense. Mr. Wempe said he was not a member of the Posse Comitatus. A newsletter from the Citizen's Union of Osage County, Kansas, distributed by Mr. Wempe is attached (Attachment No.7).

Charles Jordan, from Beloit, opposed the bill, stating present laws would take care of the problems.

Ted Cunningham, Kansas Outdoors Unlimited, opposed HB 2269 for the same reasons as other conferees. He did not believe a statute could be enacted that would keep subversive groups from continuing to train because of Constitutional problems. Amending the bill would just lead to other amendments.

The meeting was adjourned at 5:15 p.m.

Enclosed please find the Model Age Discrimination in Employment Act, as requested. This proposal is drafted after the U.S. House Select Committee on Aging's Model Anti-Discrimination in Employment Law and is similar to legislation approved by the National Council on Senior Citizens. This proposal is also similar to legislation that the State of Florida and Maine have enacted for Age Discrimination Employment laws.

This proposal differs from HB-2171 in that the model bill creates a separate section under the Civil Rights Protection amendments Chapter 44 of the Kansas Statutes. This would specifically emphasize the need for persons who are at least 40 years of age but less than 70 years of age to be protected from discriminatory employment practices.

The Model Age Discrimination in Employment bill provides for the following:

- (1) Prohibits the use of age as the sole criterion for employment decisions for persons between the ages of forty and seventy.
- (2) Applies to all Kansas employers with four or more employees.
- (3) Prohibits mandatory retirement before age 70 except in certain specified instances.
- (4) Leaves intact retirement and pension plans permitting an earlier retirement.
- (5) The Kansas Commission on Civil Rights will be responsible for handling and investigating Age Discrimination in Employment cases.

Like HB-2171, this model proposal meets the basic protections of the Federal Age Discrimination Employment Act. However, with the enactment of a separate civil rights protection section, the crucial importance of anti-age discrimination employment practices will be emphasized. This will expand the Kansas Civil Rights Protection Act to further protect the employment rights of Kansas' 412,296 older citizens.

TESTIMONY OF THOMAS E. KELLY,

DIRECTOR, KANSAS BUREAU OF INVESTIGATION,

BEFORE

THE HOUSE JUDICIARY COMMITTEE

REGARDING HOUSE BILL NUMBER 2269
RELATING TO PARA-MILITARY TRAINING

FEBRUARY 21, 1983

DEAR MR. CHAIRMAN AND MEMBERS:

I APPRECIATE THE OPPORTUNITY TO COMMENT ON THE SUBJECT OF UNLAWFUL PARA-MILITARY TRAINING. FOR MANY YEARS, WE HAVE RECEIVED REPORTS FROM OTHER STATES REGARDING SCHOOLS CONDUCTED FOR THE PURPOSE OF PARA-MILITARY TRAINING ACTIVITIES FOR PERSONS WHO ARE NOT MEMBERS OF LAW ENFORCEMENT OR MILITARY UNITS BEING TRAINED AS PART OF THEIR OFFICIAL DUTIES. IN MANY REPORTS, THE TRAINING WAS BEING HELD FOR MEMBERS OF "SURVIVAL GROUPS" WHO PROFESSED A FEAR OF A TAKEOVER OF THE UNITED STATES BY COMMUNISM, NUCLEAR WAR, RACE WAR, SEVERE DEPRESSION, OR FOR ANY REASON THAT MIGHT CAUSE A COLLAPSE OF GOVERNMENT AND INDIVIDUALS WOULD BE CALLED ON TO SURVIVE IN ORDER TO RE-ESTABLISH THE NATION. SOME OF THESE GROUPS PROFESS TO BE A RELIGION OR CHURCH AND MAY

TAKE POSITIONS OF BEING ANTI-BLACK, ANTI-JEW, ANTI-CATHOLIC, ANTI-TAXES, AND ANTI-GOVERNMENT TO THE POINT OF PREACHING ANARCHY. REGARDLESS OF THE ALLEGED REASON FOR THE ORGANIZATION'S EXISTENCE, MANY OF THEM ENCOURAGE THEIR FOLLOWERS TO STOCKPILE GUNS, AMMUNITION, FOOD, AND, TO BE TRAINED TO DEFEND THEMSELVES AND THE ORGANIZATION AGAINST THEIR ENEMIES, WHOEVER THEY MAY BE.

DURING THE PERIOD OF MARCH 26 THROUGH 28, 1982, A THREE-DAY TRAINING SESSION WAS HELD NORTH OF WESKAN, KANSAS, AND IT WAS LISTED AS AN ECOLOGICAL SEMINAR, BUT WAS IN FACT, PARA-MILITARY TRAINING. THE REGISTRATION FEES WERE \$100.00 PER MAN, \$50.00 PER WOMAN, AND \$35.00 PER CHILD AND THE GROUP TOTALED FIFTY-FIVE (55) MEN AND WOMEN, AND ONE (1) CHILD. AT THE REGISTRATION POINT, THE REGISTRANTS WERE REQUIRED TO SIGN A FORM STATING THEY WERE NOT EMPLOYED BY A FEDERAL, STATE, COUNTY OR CITY, OR ANY FOREIGN AGENCY AND THE FORM WAS WITNESSED BY TWO (2) PERSONS AT THE REGISTRATION POINT.

AT THE BRIEFING FOR THE ENTIRE GROUP, THEY WERE INTRODUCED TO THE INSTRUCTORS AND FOUR (4) SMALLER GROUPS WERE FORMED. THE INSTRUCTORS WERE FORMER UNITED STATES MILITARY PERSONNEL. THE TRAINING CONSISTED OF FOUR (4) SESSIONS PER DAY, ONE WITH EACH INSTRUCTOR.

A BRIEF DESCRIPTION OF THE SUBJECT MATTER TAUGHT IS SET FORTH:

1. CAMOUFLAGE AND ITS USE:

DIFFERENT TYPES AND PATTERNS OF MILITARY CAMOUFLAGE IN REGARD TO CLOTHING, FACIAL CAMOUFLAGE AND COMBAT GEAR.

ALSO TAUGHT WAS THE RECOGNITION OF TEAR GAS AND THE NEED FOR A GAS MASK IF YOU ARE GASSED.

2. MUNITIONS AND TECHNIQUES:

THE SESSION DEALT WITH COMMERCIAL AND HOMEMADE EXPLOSIVES,
DETONATORS, FUSES AND TIMING DEVICES, INCLUDING DETONATING
CORD, DYNAMITE AND BLASTING CAPS. INCLUDED IN THE TRAINING
WAS INSTRUCTION FOR VARIOUS EXPLOSIVE CHARGES AND ANTIPERSONNEL MINES, AND LAYING AND CHARTING A MINE FIELD.

3. KILLER TEAMS AND TROOP MOVEMENTS: THE SESSION INSTRUCTED THE USE OF TWO AND THREE MEN KILLER TEAMS TO MAKE QUICK LETHAL ATTACKS IN HIT AND RUN OPERA TIONS AGAINST THE ENEMY.

4. GUERILLA WARFARE:

THIS WAS A DISCUSSION ON GUERILLA WARFARE AND THE TACTICS
TO BE UTILIZED.

5. PERIMETER DEFENSE AND PENETRATION:

THIS DEALT WITH MILITARY COMPOUND AND DEFENDING AGAINST
INTRUDERS; AND DISCUSSED WERE THE USE OF BARBED WIRE, FOOTHOLES, TRIP WIRES FOR FLARES, BOOBY TRAPS, LAND MINES,
PUNJI STICKS, BARRICADES, AND THE STRATEGIC PLACING OF FIRE
POWER.

6. USEABLE POISONS:

THIS SUBJECT CONCERNED THE MAKING OF POISONS FROM COMMON HOUSE PLANTS, AND TO REDUCE IT TO A GREATER STRENGTH THROUGH EVAPORATION OR HEAT. ALSO COVERED WERE THE MEANS OF DELIVERING THE POISON BY KNIFE BLADE, CROSSBOW BOLTS, NEEDLES, AND SOME

SPRAY BOTTLE APPLICATIONS.

7. SILENCERS AND ENEMY DETECTION:

THE DISCUSSION ON SILENCERS HAD TO DO WITH THE USE OF SILENCERS TAKEN FROM THE ENEMY. THE MATTER OF ENEMY DETECTION DEALT WITH ELECTRONIC DETECTION THROUGH LISTENING DEVICES, STARLITE AND INFRARED SCOPE, TRIP FLARES AND BOOBY TRAPS.

8. COMBAT PATROLS AND AMBUSHES:

THE INSTRUCTORS DISCUSSED PATROL USED TO GATHER INTELLIGENCE AND THE COMBAT PATROL TO FIGHT THE ENEMY, INCLUDING
THE USE OF AMBUSHES. ALSO INCLUDED A NIGHT PATROL MISSION
WHICH FAILED BECAUSE THE LEADER BECAME LOST.

9. KNIFE FIGHTING:

INSTRUCTION WAS GIVEN IN REGARD TO THE SELECTION OF THE KNIVES TO BE USED, HOW TO HOLD THEM AND THE EXECUTION OF CUTTING AND BLOCKING MOVEMENTS.

10. HAND TO HAND COMBAT:

THIS SUBJECT MATTER COVERED HAND TO HAND COMBAT, SENTRY
REMOVAL AND SILENT KILLING TECHNIQUES. THE WEAPONS COVERED
SPECIAL BOLT ACTION AND SCOPE COMBINATIONS FOR SNIPING,
AS WELL AS SOME PARA-MILITARY TYPE WEAPONS AND COMMON
HUNTING WEAPONS AND HANDGUNS.

11. FIRST AID AND WOUND TREATMENT:

TAUGHT BASIC FIRST AID MATTERS AND REMOVAL OF WOUNDED TO

AN AID STATION.

AT THE CONCLUSION, THE PERSONS WHO SERVED AS INSTRUCTORS OR SUPPORT PERSONNEL MADE SHORT TALKS, CONCERNING THE TRAINING BEING HELPFUL FOR WHATEVER HAPPENS IN THE FUTURE. THE PARTICIPANTS WERE ALSO ADVISED TO BUY MANUALS FROM THE MILITARY REGARDING SOME OF THE COURSES TAUGHT. DURING THE COURSE OF INSTRUCTION, THE INSTRUCTORS ADVISED THE PARTICIPANTS NOT TO BUY OR MAKE AN ILLEGAL MACHINE GUN.

I BELIEVE IT IS CLEAR THE CONTENT OF THE TRAINING DESCRIBED IN THIS

SEMINAR IS NOT THE TYPE OF TRAINING THE AVERAGE RESIDENT OF OUR STATE WOULD

HAVE ANY REASON TO SUBSCRIBE TO OR TO BE ABLE TO UTILIZE IN EVERY DAY ACTIVITIES.

THE TRAINING IS OBVIOUSLY FOR THE PURPOSE OF PHYSICAL COMBAT WITH AN ENEMY TO

BE DETERMINED BY THE INDIVIDUAL SO TRAINED. IT IS DESIGNED FOR THE USE OF

THE INDIVIDUAL AND NOT ON BEHALF OF ANY GOVERNMENTAL UNIT.





HOLOCAUST In Memoriam of THE DRESDEN HOLOCAUST

It was a cold winter's night in Europe on Shrove Tuesday, February 12, 1945 that. Hitler was on the run and the tragic war would soon be over. Refugees were on the run too, many from the Red Army using the confusion of war to escape that terror which is Communism. For months these pitlful refugees worked their way to a city in Germany where they felt they would be safe. That city was Dresden, Germany, a city of about 500,000 — a city of parks, gardens, a center of the arts and manufacturing of fine china, a city considered by both sides of the conflict to be an "OPEN CITY"— a city which in the name of civilization would be spared the obliteration bombings. Very unexpectedly, at 10:09 P.M. the first fire bombs from the Allied Air Forces - British and American — fell. A second raid commenced at 1:22 A.M. on February 14. In a third raid, P 51's straffed and bombed the rubble and remaining victims that were still alive or burning at 10:30 A.M., Feb. 14, ASH WEDNESDAY.

In that 14 hours of total HELL that measured the length of the attacks,

250,000 PEOPLE DIED

mostly old men, women, children and refugees — a small number of soldiers home on leave — either burned to a crisp in the tornado which formed in the firestorm or melted down in the bomb shelters into a pool of 3-4 feet of human flesh and oil.

Let us compare that to holocausts you have heard much about. At Hiroshima 70,000 Japanese died and at Nagasaki 36,000 died — the first atomic bomb attacks, and made by us, on the most heavily populated Christian cities in Japan, by the way.

At Dresden a total of 250,000 White German Christians were murdered

by White English and American Christians.

The American farmer has finally begun to awaken out of his sleep and world of make-believe by the sudden shock of reality. In all the years that the farmer has worked and toiled, trying to be successful in working his land, he has lost his battle for survival not only for himself, but his family and his once Christian republic. To whom has the farmer lost this battle-none other than the JEWISH MONEY BARONS who hold the mortgages on the farmers' property and equipment, and at this moment are on the verge of foreclosing.

Now, pouring gas on the already blazing fire, the farmer, in a desperate attempt to save "something", turns to the present "man god" that everyone seems to acknowledge at this late date in time: THE FEDERAL GOVERNMENT. The farmer feels "Jimmy Peanuts" and his boys will help them, not realizing that the federal government is one of the primary reasons he is in such a desperate financial situation. In essence, it's like asking Satan (the federal government) to help save him from the very situation that Satan got him into in the first place.

In the very, very near future, there will be a grab for land in America, making the Northern Jewish carpetbaggers and their deeds after the Civil War look like small potafoes. The United Nations Covenant on Economical, Social and Cultural Rights.

In order to verify the above information, send a request to your Senator for copies. If he is still on the side of the people, he will send the evidence to you.

One would think that if the American farmer were in serious financial difficulty, the federal government would come running to assist them, just like they do for the Jew-owned airlines, tobacco companies, railroads and steel industries, just to name a few. But then, you don't find any Jews working the land, do you?? Do you know why?? Almighty God put a curse on Cain, who is their father (Matt. 23:35) so that the earth-would not yield her fruit (Gen. 4:12) to Cain and his descendants. JEWS AS A RACE CANNOT GROW ANYTHING. In the Mideast, the Jews bring Christian agriculture experts in to supervise Arabs who are brought in by the truckload to work the fields for that very

reason. Also in Genesis 4:12, God condemned Cain and his descendents to be vagabonds in the earth from that time on. Isn't it strange that the Jews, who not only can't grow anything, also wandered the earth until 1947 when they stole the present property they live on from the Arabs. They acquired this property by signing a piece of paper with the British, WHO HAD NO RIGHT TO GIVE THE PROPERTY AWAY. Why didn't the United States defend the Arab's human rights then? And wouldn't it be nice if Christian American farmers, or any American, could get land free just by signing some papers with the federal government, AND THEN RECEIVE ANNUAL ASSISTANCE LIKE THE JEWS RECEIVE.

Another item I'd like you to take into consideration: Since the British gave the land to the Jews, why aren't they financing the damn Jews to the tune of over \$600 million per year instead of the American taxpayers? That's one of the reasons the farmers can't get any money from their own government—the Jews already have the farmers money.

THE JEW RUN BANKS AND FEDERAL LOAN AGENCIES ARE WORKING HAND IN HAND, foreclosing on thousands of farms right now in America. They are, in essence, nationalizing farms for the Jews, as the farmer becomes a tenant slave on the land he once owned. After stealing the farmer's land, they have the Jewish gall to then ask the farmer to remain and run the farm for a modest \$200 per week (if he's lucky) as their SERF, BONDSERVENT, or SLAVE.

The farmer lost his battle years ago when he LISTENED and TRUSTED in Uncle Sam's super plans to personally expand the American farmers' potential so he could feed the whole pagan world. The farmer inconveniently and not unsuspectingly buried himself in debt to the Jewish run lending institutions by buying more land and more equipment. These actions by the farmer DEMANDED VERY HIGH INTEREST (usury), a direct violation of God's law (Deut. 23:19).

Now that the farmer was in debt up to his ears, the bankers, who control the land and money values, started to increase the value of the farmer's land in order to delude the farmer into thinking he was really getting ahead. The money changers, regulating the value of real estate, has been done only to allow the farmer to get further ensnared by the international bankers' (Jew) web through means of heavier financial obligations. This is, in reality, robbing him of his hard earned substance under the pretext of law. The tapering off of land values is the straw that is breaking the farmer's back. THE BANKERS HAVE THE FARMER'S LAND TIED UP, LOCK, STOCK AND BARREL.

The time has finally come to pay off the notes PLUS all of the UNGODLY INTEREST, but the farmer hasn't any credit or money to do so, in plain words, BECAUSE THE PLAN MAGNIFIED THE AUTHORITY OF THE STATE, THE FARMER BOUGHT THE FEDERAL GOVERNMENT'S JEWISH PLAN, HOOK, LINE AND SINKER. Jesus warned His people in Genesis 3:1 that the serpent was more subtle (cunning or sneaky) than any beast of the field. Since we know that the serpent's descendents are the Jews (Matt. 23:31-33), all White Christians can now see how they have been conned.

The Jew banks and federal loan agencies are committing treason, extortion, and outright theft under the guise of LAW and so-called HUMAN LIBERTY before the eyes of Almighty God, Jesus the Christ (Deut 23:19). They are doing the stealing

under the pretense of being legal in the eyes of the local, state and federal governments (man's laws), which IS OPPOSED to and in contravention with God's law. Helping them are the pharaseeic lawyers whose origins and nature we are only beginning to understand.

The banks are now driving down the price of land for the final death blow before the farmers and their families are thrown into the street with nothing. Joel 1:4 foretells the dilemma of the farmer in the following words:

"That which the palmerworms (Jewish lenders) hath left hath the locust (federal taxes) eaten; and that which the locust hath left hath the cankerworm (state taxes) eaten; and that which the cankerworm hath left hath the caterpillar (hidden taxes and government agents with their super plans) eaten." (Read in harmony also Luke 12:54-59).

The farmer looks to the federal government, thinking it is going to help him, but this is just wishful thinking. The federal government follows a WELL REGULATED PLAN that goes hand in hand with the Jewish money barons who pay off the politicians that control the prices of the farm crops, to ensure that the farmer never gets ahead, no matter how hard he tries. Then the farmer sells his hard earned, SELF-INVESTED crops to the local Jew governed cooperative, in turn practically giving the crops to our enemies for next to nothing. Since the farmer also pays taxes, his tax money is given to his enemy, who in turn uses it to purchase the farmer's grain dirt cheap.

America is in a severe, but deliberately created financial crisis. The farmer, as a last resort, is turning to the federal government which, in reality, is part of the "beast system" mentioned in the Bible. Instead of getting on his knees and begging Jesus the Christ to help him, his family and his Christian nation, the Christian believer is neutered by his preacher into believing it is morally wrong to be ACTIVELY OPPOSED to these evils prevailing in our land. In turning to the federal government, the farmer is saying to Jesus, "The federal government will take care of me and my family. I don't need you." (Matt. 6:24) Instead, the preachers should be telling the people:

"If my people which are called by my name (Christians) shall humble themselves, and pray, and seek my face and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land." (II Chron. 7:14)

During the depression of 1929, created by the Jew money barons, the FEDERAL RESERVE CORPORATION took a great deal of money out of the business market, thus creating a severe money shortage. Thus the depression followed. There were goods to be bought and men to work, but there was no money. The Jews controlled the money which they then used to buy up Christian property at a fraction of the normal value.

In 1929, 26% of White Christian America lived on farms and had their own gardens, cows, chickens, wells and wood stoves, and thereby could still survive. But today, my friend, only 3% live on farms. Today's farmer has become specialized in either crops, beef, dairy or whatever. The federal, state and local governments have been busy in each and every state forcing this specialization through taxes, zoning laws, or out of

complete financial necessity. Heavy multiple taxes and complex zoning laws throughout America have further made it impractical for the small farmer to continue his past means of sustaining himself and his family. His once fierce pride in personal achievement and independence, based upon the true foundation of Christian convictions and national pride, have faded away. He has been forced to conform to the scheme that has been meticulously followed through in every detail to totally destroy everything he holds dear and worthwhile to him.

The farmer HAS BEEN MILKED DRY while his sons and daughters have been run off by cleverly calculated economic pressure designed to DESTROY THE FAMILY AS A UNIT throughout our society. If the independent self-made farmer refused to conform to the will of the oppressor, he was reprimanded, fined or forced off of his land by one or more measures brought upon him by the proselytes of the Jews running the various bureaucratic offices.

The combined pressures which afflict us today has forced the farmer to streamline his earning capabilities, making it very impractical to rely on the traditional methods of providing for his family as did his forefathers. Slowly, like the exerted pressure of a python, the farmer has become more and more dependent upon the SUPERMARKET. This is the highly centralized mass food distribution outlet which has a super-Jew sitting at every key point to assure success of their overall scheme to subject any rebellious segment of the population that might arise. Now the one who has always been alien to your Christian precepts has BECOME THE MASTER of the 20th century art of control.

The White Christian American now stands as a SERF upon the soil his forefathers fought, bled and died to give him so he could have life. liberty and property in the pursuit of happiness upon the sure "Rock" of Christian law.

Yes, indeed, the fellow in the supermarket, transportation, newspaper, radio, and television nerve centers WITH THE YIDDISH ACCENT is not there by accident by any means. The White Christian American will soon be forced to surrender all or fight. If he chooses to fight against the task master, those resisting will find themselves cut off from food supplies, materials and support of any kind. Presidential Executive Order #11921, dated June 11, 1976, states that the federal government may confiscate any or all survival foods or materials during a national emergency." This Executive Order also calls for a total dispersement of blacks into the countryside as well as total regulation of highway traffic. A copy of this Executive Order may be obtained through your library or Senator, but they might not be too anxious to help you obtain it.

The well-programmed communications network will confuse the masses to oppose their own liberty and freedom as they once again express their ignorance to the Jewish methods in a blood-letting ritual called WAR or REVOLUTION. Though the Jew represents only 3% of the American population, it is amazing how they have demonstrated their capability to whip up such diabolical hatred of one Christian for another. The masses have always rallied to the traditional drumbeat of the Yiddish piper. The masses today, as in the days of Noah, are SELF-DESTRUCTIVE. Every Christian should be faithful, realistic and objective in order to see quite readily who is behind it all. If we read Luke 11:50-51 and Matthew 23:15 and apply a

literal interpretation of the scripture, we find it profitable for reproof and correction in our situation.

NOW LET'S GET DOWN TO BRASS TACKS.

Someone is failing to sound the alarmin God's Holy Land, the United States of America. Since we know that the media is controlled by the antichrist and the federal government, then the ONLY other place where one would expect to hear the truth is in the VARIOUS CHURCHES in America. But come Sunday, there is NO priest, pastor or minister in all the denominational church world shouting out in defiance to this tyranny. They express no Christian indignation to the planned takeover of not only the farmers' private property but also all other private property belonging to the productive White Christian working man. Mark 7:6-13 as spoken by God himself should give you the evidence one needs to understand why. These false prophets are preaching man's laws and not the laws of Almighty God.

IF White Christian America would read the Bible, BELIEVE what Jesus says and LIVE by the word (laws) of God instead of listening to some minister exalt the Jew as God's chosen people, White Christian America's problems would be solved in a hurry. When we learn to live by the laws of God, then and only then will He save His people from this pathway of destruction. So don't look to the federal government for salvation from this dilemma. Either be Christ's or antichrist. Whom do you choose to serve in the hour of the harvest? (Joel 3:13)

In 1912, the prominent Jewish writer and Communist theoretician, Israel Cohen, wrote an extensive plan called "A Racial Program for the Twentieth Century." This will give you better insight on how crafty the devil's kids really are, and how they got the federal government to implement their program.

"We (Jews) must realize that our party's most powerful weapon is racial tension. In pounding into the consciousness of the dark races that for centuries they have been oppressed by the White Christians, we can mold them to the program of the Communist (Jew) party. The terms 'colonialism' and 'imperialism' must be featured in our propaganda. In America, we will aim for a subtle victory. While inflaming the Negro minority against the Whites, we will endeavor to instill in the Whites a guilt complex for their exploitation of the Negroes. We will aid the Negroes to rise in prominence in every walk to life, in the professions and in the world of sports and entertainment. With this prestige, the Negroes will be able to intermarry with the White Christians and begin a process which will deliver America to our cause."

The above goes right along with what modern churchianity has been cramming down the throats of their congregations for years, calling it gospel. White Christian America has swallowed the bait (Proverbs 8:36, 10:2, 11:4 and 14:12). When Jesus returns, don't be found guilty of this Baal worship, as told of in Numbers 25.

Has your minister taught you all the laws of Almighty God as they apply today? (Lev. 26:45-46 and Deut. 4:30-31). Jesus is the only one to receive any tithe offering----NOT THE INTERNAL REVENUE SERVICE----and the offering is to be 10% of all your earnings. Everyone gives this 10% to God--no more, no less. There are no payment-free trusts, writeoffs or other Jewish

garbage where the rich get richer and the poor get poorer. This 10% is to pay for the Christian education of our children, national defense, care of the aged or fatherless as well as all other administrative functions. Of this 10%, 1% is for the total support of the ministers and their functions to teach THE TRUE WORD OF GOD AS WRITTEN IN THE HOLY BIBLE. The remaining 90% of your earnings belongs to you, TAX FREE. It seems today that the clergy has forgotten all the laws except for the law of the tithe, but has changed even that to benefit only himself. A fancy new church or big mission program is very impressive to the minister's head office.

Over eighty years ago, the Jewish elders laid down methods they planned to use to subject the non-Jewish world to their will. This blueprint for conquest, called "The Protocals of the Learned Elders of Zion" (translated by Victor E. Marsden) was unknown to even the average Jew. EVERY CHRISTIAN SHOULD READ THIS BOOKLET.

The control over the press now exerted by the learned elders HAS DEPRIVED Christian Americans of their right to freedom of the press for well over sixty years. The control over the people they envisioned as part of their final step to dictatorship is found in Protocal #13, paragraph one, which states:

"The need for daily bread forces the goyim (non-Jew) to keep silence and be our humble servants."

By means of controlling our food resources, they can induce just enough preservatives and chemicals into our food and water supplies to keep you permanently in a state of APATHY and INDIFFERENCE as they go about their plans in the ultimate new order of 20th century serfdom.

The American farmer is the primary target of Protocol #6, which in part states this:

- We (Jews) shall soon begin to establish huge monopolies, reservoirs of colassal riches, upon which even large fortunes of the goyim (non-Jew) will depend to such an extent that they will go to the bottom together with the credit of the States on the day after the political smash.
- In every possible way we must develop the significance of our Super-Government by representing it as the Protector and Benefactor of all those who voluntarily submit to us
- 4. It is essential therefore for us at whatever cost to deprive them of their land. This object will be best attained by increasing the burdens upon landed property--in loading lands with debts. These measures will check land holding and keep it in a state of humble and unconditional submission.
- 7. We shall raise the rate of wages, which, however, will not bring any advantage to the workers, for, at the same time, we shall produce a rise in prices of the first necessaries of life, alleging that it rises from the decline of agriculture and cattle-breeding: we shall further undermine artfully and deeply sources of production by accustoming the workers to anarchy and to drunkenness and side by side therewith taking all measure to extirpate from the face of the earth all the educated forces of the goyim.

My fellow Christians, this is but part of one of the Protocols that the children of Satan (Jews) have amassed against God's

true covenant seed in this earth. The booklet, Protocols of the Learned Elders, must be read by every Christian immediately in order, to fully grasp the severe and dire situation that fully confronts our beloved Christian Republic and the Christian people.

If our founding fathers in all their wisdom would have recognized the prophets of their day, they could have taken the effective guard of our nation through the fullness of Christian law. Our constitutional framers could have been guided by the admonishment of sacred scriptures as written in II John 8-11. Had they taken heed of these scriptures, WE WOULD HAVE FOREVER BARRED THE ANTICHRIST JEWS FROM OUR SHORES. Instead we are now the heirs of this transgression. Had our immigration laws protected our Christian way of life, we would have never become the participating financiers of the Jewish plague called socialism and communism. God holds us all accountable for contributing to the establishment, growth and continued nourishment of the Communist Jews conquests in all nations of the world.

George Washington was wise indeed and gave vocal opposition to the insideous forces that were at work even then trying to undermine our national Christian standards when he said:

"They (Jews) work more effectively against us than the enemy's armies. They are a hundred times more dangerous to our liberties and the great cause we are engaged in. . . It is much to lamented that each state, long ago, has not hunted them down as pests to society and the greatest enemies we have to the happiness of America."

(Maxims of George Washington by A.A. Appleton & Co.)

Washington understood his Christian obligation to oppose the forces of the Jews even then. On many occasions he voiced his righteous indignation against the Jews and thereby contributed in great measure to the future security of our freedoms. Yet even this was limited.

Benjamin Franklin was another one of our truly great leaders in the struggle for independence. Mr. Franklin stood firm and immovable in our great struggle for Christian liberty and freedom. In his address to the Constitutional Convention in Philadelphia in 1787, Franklin came forth with the most important admonishment that our young Republic could have received when he said:

"I agree fully with General Washington--that we must protect this young nation from the insideous influence and impenetration. That menace, gentlemen is the Jew.

In whatever country Jews have settled in any great numbers, they have lowered its moral tone, depreciated its commercial integrity, have segmented themselves and have not been assimilated, have sneered at and tried to undermine the Christian religion upon which that nation is founded by objecting to its restrictions, have built up a state within a state, and, when opposed, have tried to strangle that country to death financially, as in the case of Spain and Portugal.

For over 1,700 years the Jews have been bewailing their sad fate in that they have been exiled from their homeland, as they call Palestine. But, gentlemen, did the world today give it to them in fee simple, they would at once find some reason for not returning. Why? Because they are vampires, and vampires do not live on vampires. They cannot live only among themselves. They must subsist on Christians and other peoples not of their race.

If you do not exclude them, in less than 200 years our descendents will be working in the fields to furnish them substance, while they will be in the countinghouses rubbing their hands. I warn you, gentlemen, if you do not exclude Jews for all time, your children will curse you in your grave.

Jews, gentlemen, are Asiatics, let them be born where they will, or how many generations they are away from Asia, they will never be otherwise. Their ideas do not conform to an American's and will not even though they live among us ten generations. A leopard cannot change its spots. Jews are Asiatics, are a menace to this country if permitted entrance, and should be excluded by this Constitution."

Franklin was indeed a wise individual. Had his words been heeded over the influences of Alexander Hamilton, our Republic might have been spared from the peril that is now upon us.

So the American farmer may fully comprehend where he stands in relation to the state and fèderal governments, it becomes necessary to examine closely what has happened in the past. We must compare the situations that have developed in those countries that have come under the hammer of Communist tyranny. History, like Bible prophecy, HAS A WAY OF REPEATING ITSELF. Through such understanding is the only way of avoiding God's judgment upon ourselves for having played a national role in the implementation of Jewish tyranny abroad.

As Czarist Christian Russia transformed itself into the tyrannical Jewish state now identified as Communist Russia, it received all the assistance the Jewish manipulators in the United States could assemble through political influence. Our EXECUTIVE OFFICES lent their authority to behind-thescenes Jewish efforts. Jacob Schiff, the main thrust behind the Federal Reserve System, along with Leon Trotsky financed (to the tune of over \$20 million in gold) and trained seventeen hundred cut-throat terrorists in New York City. They were sent, along with three ships loaded with war materials, AGAINST the unfortunate Russian peasants, compliments of America. They were apprehended enroute by a British man-of-war which placed them under arrest for their revolutionary intentions. The British war office immediately notified President Woodrow Wilson, also of Jewish descent, who conferred with Col. Edward M. House, the Kissinger of that day. Their reply was that if Britain wanted to avoid a provacative international incident and retain our support for their war with Germany, they allow the ships to proceed. Thereby America became responsible for the success of the Russian Communist Bolshevik Revolution and, therefore, became responsible to God for the slaughter of over 60 million Christians in that nation alone.

The Christian Russian farmer was the strongest line of

resistance the Jews encountered, since they were fiercely independent and self-supporting on their small farms. The Jews plundered, pillaged and dictated their terms to ruthlessly destroy every semblance of resistance the farmer could erect Even after they could no longer bear arms, these farmers still resisted by opposing the land zoning laws imposed upon them. The Russian peasant further resisted in the late 20's and 30's by destroying their own crops and livestock in hopes that conditions would become so unbearable that industrialized city dwellers would overthrow his Jewish oppressors and reinstate good Christian government. As a result of this rebellion, the Jews sent their army across the farms of Russia and commandeered all grains, the result being mass starvation. The peasants looked to their fellow Christians in America for help. but died by the millions with only tree roots, wallpaper paste and canabalism to keep some alive.

Joseph Stalin's appeal to the Jewish advisors of Herbert Hoover's administration gained full assistance to send enough food, military supplies and financial support to assure the Jews' continued control over the frustrated efforts of the peasant farmers. As long as the Jews could feed the masses, they had no fear of a total rebellion. By the continuous process of giving AMERICAN GROWN GRAIN to the Communists in their hour of need, Americans have been guilty of giving assistance to the enemies of God and assisting them in the further enslaving and murdering through starvation of countless millions.

My Christian friends, all the information you have just read pertaining to the Jewish Bolshevik Revolution can be verified in the Overman Report published in 1919. Your Senators and Congressmen are aware of this truth but are failing to sound the alarm to the American people. America's paid off politicians DO NOT CARE about anything other than how much money they steal from the American taxpayer. In not telling the truth, these traitors bow down before the devil's kids (Jews) and lick their feet for a few morsels of financial gain.

Under God's law, we must love "our" enemies. But if we love "HIS" enemies (the Jews), we come under His judgment. If any man thirst, should you give him gall? If and man hunger, should you give him stone? When the Russian peasant stood in his perilous need, shouldn't we have been "his keeper" by helping him destroy his oppressor?

Right now the "peace, peace" theme is being harped upon by the Jews seeking to DESTROY the last semblance of a true Christian nation, all in the name of HUMAN RIGHTS. South Africa and Rhodesia stand alone because of their feeble attempts to retain a few true fundamental Christian priniciples of government. What is America's stand on this issue?

President Carter has pledged full support to the pagan organization called the UNITED NATIONS in any attempt to destroy those principles. Further, our National Council of Churches has been actively engaged in sending money and supplies to the Communist nations surrounding South Africa and Rhodesia.

The Jews have provided for many grain transactions between America and the Communist nations. This move is designed so that when Russia attacks America, we will not be able to fall back on our grain reserves to feed our people. What they have not been able to ship out of this country, they are destroying outright by blowing up the grain storage elevators. Their latest ploy is to CONVINCE THE FARMERS TO STORE their last

holdings of grain in the elevators to await an increase in price. The Jews are after the farmer's own personal reserve of grain to destroy that also.

Recent information noted in the economic newsletter, L. T Patterson Strategy Letter of January 1978, states that President Carter has unofficially put price controls on all farm goods into effect. This is to cause scarcity and black markets and ultimately falsification of the consumer price index. There is no longer a free market in farm products, but rather a monopoly operated by the U.S. Department of Agriculture to HOLD DOWN PRICES against the farmers. It is government policy that private, secret deals between the large Jewishowned grain exporters and Communist governments are to be encouraged and fostered. . .such a policy acts to slap a lid on farm prices and, in effect, FEDERAL PRICE CONTROLS. Keep in mind that agricultural products are far and away the most important export item and, thus, THE LARGEST PROP UNDER THE U.S. DOLLAR. Government policy on grain exports has the same practical effect as if price controls were "official policy." Instead of being straightforward and honest with the American public, we have more subversive activity and attempts to mislead and confuse. The result of these price controls is bankruptcy and hardship for the farmers. Carter wage and price controls have long been forecasted. Here we can see the practical effect in the farm strike in the first implementation of such controls. The purpose of these HIDDEN PRICE CONTROLS on agriculture is to deliver up the bounty of the American free enterprise farm to the Russians and their satellites and artificially depress the widely quoted Consumer Price Index to mislead and fool the American public -- and mostly the AMERICAN FARMER. The effect of agricultural price controls can be judged by the following figures: corn has fallen from a recent high of \$3.46 a bushel down to \$2.20 a bushel and wheat from \$5.04 a bushel to \$2.75 a bushel. Keep in mind, Christian farmer, these quotes are NOT ALL TIME HIGHS (\$4.00 for corn and \$6.00 for wheat). USDA estimates that granting the farmers' demands would raise consumer food prices 25% in 1978, not counting the 6% already forecasted (for a total of 31% during the next 12 months). Farmers' demands WILL NOT BE GRANTED, with the result being tremendous hardship for this sector of American society and a collapse in food production and, ultimately, the END OF ABUNDANCE IN THE UNITED STATES. Carter policy is to hide any "visible thermometer" such as the Consumer Price Index. Therefore, the policy was adopted to DEPRESS FARM PRICES by prohibiting publication of Russian agriculture intelligence and allowing FRADULENT ESTIMATES of Soviet farm production. The Soviets are thus able to grab up a substantial percentage of U.S. agricultural production AT A 50% DISCOUNT. Temporary lower prices might, be some cause for joy for the consumer, but the LONG TERM RESULT will be VASTLY HIGHER PRICES and black markets and scarcities that have not been seen in this country since World War II. Short term it is conceivable that the farm strike might take on massive proportions and result in temporarily bare shelves, although this is unlikely. Meanwhile grain elevators around the country have been destroyed at tremendous loss of life. No explanations for these explosions have been offered either by the companies, grain industry. shipping industry OR THE GOVERNMENT. It is obvious that these are a result of sabotage and will have disastrous effects on the U.S. dollar if these elevators are ordered closed down for any appreciable period.

Since 99% of Americans depend on the Jew-owned grocery store, you can well understand why the chaos and violence is going to be so severe. Another COLLAPSE OF THE STOCK MARKET is in the making. The federal government has already printed a new type of money that will be used after this crash. The purpose of this will be to absolutely control the masses who will be looking for any form of relief, ESPECIALLY FOOD. The Jews have controlled the whole world up to now through money, and now will control through food as well. Do you have a food reserve plan? Or will you be forced to take the "MArk of the Beast?" (Rev. 13:15-17 and 14:10-12) Either the masses of people do what the Jews and traitors of the present government demand, or THEY DON'T EAT. It's that simple (Matt. 25:1-13).

Time is short to the collapse of the dollar in the United States and its world wide influence. THE FARMERS SHOULD CONTINUE THEIR STRIKE, but continue it demanding also that the name of Almighty God be honored and followed in our government law. DON'T give your precious crops to the Jews so they can feed an army to "rend you." You will need your crops to EXIST ON in the hard times ahead. If the bankers try to take your land, THROW THEM OFF by whatever means are necessary. ORGANIZE! Stand together or fall alone! Jesus said, "If a house (of farmers) be divided against itself, that house cannot stand." (Mark 3:25) Without your hard work and cheaply reimbursed crops, the Jews will lose control not only of this nation, but also all the other nations in the world the control with your food. The farm strike is hurting the Jews one thousand fold, far more than they dare to admit. You may expect the Jews to put the full force of government against you whether you organize or not.

Another item of importance to the farmer is a New York Jew, Michael Fribourg, president of the CONTINENTAL GRAIN CORPORATION. He is in charge of buying the farmer's crops once they reach the cooperatives, then selling it to our nation's enemies. We have one Jew buying from another Jew for a penance price the same crops that the poor Christian farmer worked his heart out for and had to borrow money in order to plant.

Christian America has really been SET UP by the pagan Jews. The banks are owned and controlled by the Jews, the cooperatives are controlled by the Jews, Continental Grain is owned by a Jew, and the local, state and federal governments are "paid for" and controlled by the Jews. ANYONE who tries to rebuke the Jewish controlled system immediately has the bankers, FBI, CIA, IRS, CID, ADL, HUD, HEW, EPA, etc. on their backs to foreclose upon them, harrass or arrest. THIS IS LIBERTY AND JUSTICE?? THIS IS FREEDOM??

WAKE UP AMERICA and stop being a slave for the Jews. Your land and your belongings are at stake, just as they were after the Civil War.

Another bit of information—Who heads the NAACP? Very few people know that no Negro has ever been president of the NAACP. In the early 1930's, Joel Spingarn, a millionaire Jew, was elected president, serving until his death in 1939. His brother, Arthur Spingarn, became president at that time serving until the mid-1960's when Kivie Kaplan, a millionaire Jew shoe manufacturer from Boston, Massachusetts, took over. For many years, the head of the NAACP legal fund has been another Jew, Jack Greenburg, who has filed the legal actions for the

blacks which have resulted in the unconstitutional Supreme Court rulings. Non-whites are equated as equals through man's laws (courts) while God's law discriminates against all noncovenant, non-white peoples. Roy Wilkens, a Negro, was Kivie Kaplan's secretary until he retired recently and was replaced by another Negro front man, Benjamin L. Hooks. Hooks resigned from the Federal Communications Commission to accept the phoney front job by appointment through the Jews. Hooks gets much publicity from the daily press and television media, owned by the Jews, but this is to keep you in dark about the Jew mentalities in control of the NAACP. THE JEWS AGITATE THE NEGRO AGAINST THE WHITE, using their Negro front men as the TRIGGER MECHANISM for the disturbances, while the Jews wait on the sidelines to pick up the pieces. It is obvious that the Negro doesn't have the intelligence for the intricate operaton of the NAACP which has inflicted so much damage upon the rights of the White Christian America.

Again I must ask the question: WHERE ARE THE CLERGY to voice their opposition in order to protect God's flock of Christian sheep? One would think they would cry out against the present and continuing form of socialist antichrist government that has for many years controlled our beloved Christian republic.

Jesus warns His people (Matt. 7:15-20 and Jer. 2:8) that FALSE PROPHETS would not teach His sheep the real truth in the end days, and has just reward for the ministers who have betrayed His sheep (Jer. 25:34-36, Jer. 23:1-2, Ezek. 34:2, Zech, 13:2-9). Today the clergy is telling their congregation MANY LIES ABOUT JESUS. One lie is that "Jesus was a Jew." In John 8:38. Jesus himself said there were two fathers. His father is from above, but the father of the Jews is from below (John 8:20-23). Jesus called the Jews a race of serpents (Matt. 23:31-33) and devils (Rev. 12:9). Another lie is that "the Jews are God's chosen people." Jesus said the Jews were not His sheep (John 10:26-27) and that the Jews were not of God (John 8:47). Another lie is that "the Israelites of the Old Testament are the Jews." IN Isaiah 65:15 God said he would leave the Jews' name as a curse unto His chosen, but would call His servants by another name. The cross-reference to this is Acts 11:26 which tells "the disciples were first called Christians at Antioch." Finally, there will not be a "rapture" of any sort. In fact, the word doesn't appear in the Bible. The minsters use it as a crutch and "psychological out" for the weak Christians who will not face reality in this late doomsday hour. Jesus said his servants would fight, not fly

The truth is evident that the ministers don't really understand their Bible. They betray their congregations Sunday after Sunday by infesting the minds of God's true chose (Christians) with lies and deceit upon orders of the National Council of Churches, also run by the Jews.

Jesus didn't say to "PREACH," but rather told his disciples to go forth and "TEACH" the truth and the law, both OLD and New Testament law. The white women must cohabit with members of the dark races, and the white men with black women. Thus the white race will disappear, for mixing the dark with the white means the end of the White Man and our most dangerous enemy will become but a memory. 

Freeze all wages and prices. 13.

- Demand emergency welfare services (food, clothing, lodging) in PRIVATE homes for those said to be in need.
- Regulate the amount of your own money you may withdraw from your bank or savings and loan institution, or freeze your account.
- Close all banks, stock exchanges, etc., and freeze stock and bond prices. Institute extraordinary measures with respect to any facility, system, or
- service said to be essential to national survival.



hey speak the language of hate, with icy smiles.

They flaunt white supremacist beliefs but are quick to profess Christian love for all—even the non-Caucasian. Their white skin, they say, is a godly sign of their role as caretaker of

all races. They are among the growing number of Americans banding together in the big cities, suburbs and rural areas of the nation to prepare for the day they believe is fast approaching—the day America is toppled by race wars, communist invasion and economic col-

While they wait, they preach. And

what they preach, they concede, is racism. But they prefer to call their sermon a doctrine of "survivalism."

Critics say the survivalist theme among most of these groups is merely a smoke screen designed to conceal areads of racial biothers. creeds of racial bigotry.

"They are vicious racists and anti-Semites (who preach) raw hate, as extreme as it can get," said Irwin Suall, chief researcher for the Anti-Defamation League of B'nai B'rith, recognized by the federal government as the foremost watchdog of extremist activity.

Authorities from the private and

public sectors who monitor the movement confirm that the extreme rightwing has been gaining momentum for

at least five years.
(Profiles of some of the region's dominant groups are on Page 13A.)

The officials, including those with the national Klanwatch operation of the Alabama-based Southern Poverty Law Center, the Anti-Defamation League, the federal Bureau of Alcohol, Tobacco and Firearms and the U.S. Civil Rights Commission, have tracked a resurgence or growth of such ultraconservative groups as the Ku Klux Klan and the Christian Patriots Defense League. They said newer sects, including The National Emancipation including The National Emancipation of Our White Seed, Posse Comitatus and The Covenant-The Sword-The Arm of The Lord, have emerged and also are growing.

And that growth, the officials say, is occurring in the Midwest and elsewhere, with older groups like the Klan adding members and newer white su-premacist groups apparently having little trouble attracting followers.

Of the major groups, the researchers said, the only ones not gaining mem-bership are the country's five largest neo-Nazi groups, which together have an estimated membership of 1,000 to 1,200 members.

Mr. Suall said those groups are stagnant because "some right-wing leaders think it's a tactical error to go around with a big, fat swastika on your arm. But that's only a tactical difference, not a philosophical difference."

While the old-line and newer groups vary somewhat in ideology, most share a basic tenet of white supremacy and

racial separation.
"What's wrong with me being for my own home team, for my own race?"

said John Harrell, the millionaire founder of the Christian Patriots Defense League, a paramilitary organization that operates a survivalist center near Licking in south-central Missouri and with headquarters in Illinois, about 90 minutes east of St. Louis. "We're not all created equal."

Groups mushrooming

The Anti-Defamation League says monitoring by its researchers shows that such groups are mushrooming. And authorities say much of the financial support and membership, especially in Missouri, come from Kansas City and St. Louis.

The Anti-Defamation League concluded three years ago—and reaffirmed last year in a yet-to-be released study for the U.S. Commission on Civil Rights—that groups like the Klan and the Christian Patriots have increased memberships since the mid-1970s by up to 100 percent.

"Organized bigotry is on the rise," said Mr. Suall, whose group has pinpointed a doubling of membership nationally in the Klan from about 6,000 to about 12,000 in

But the most disturbing fact discovered by league researchers, said Mr. Suall and others in his organization, is the extent of public support. The anti-defa-mation group study estimates that for ev-ery Klan member there are 10 sympathizers.

Frustration mounting

Paul Marquardt, a federal Alcohol, Tobacco and Firearms agent who monitors radical right-wing groups suspected of possessing explosives and automatic weapons, said there is no question that established groups have been growing and new ones are emerging. But he believes growing public support is based on factors other than sympathy for what the groups stand for.
"I think that it is perhaps a mounting

frustration over the country's recession

rather than a growing approval of white supremacy," Mr. Marquardt said.

While the economy and concern over nuclear war have played a significant part in the growth of the militant right wing, those factors are not alone responsible. sible, say many who have observed the movement for decades.

Not to be ignored, they say, is the more abstract feeling that the time, simply, is

right.
"Times of high social unrest are the times best suited for heavy Klan growth," said Randall Williams of the Southern Poverty Law Center. Mr. Suall agreed: "It's too easy" to

blame the growth on economics. "In my opinion, that's a very thoughtless way of analyzing what's going on.'

Coping difficult

Some frustrated conservatives tend to embrace the right-wing fringe after rap

id and sweeping changes that are diffi-cult to cope with, he added.

Laird M. Wilcox, author of numerous political directories that include mailing addresses for 1,800 white right-wing organizations, and donor of the nationally recognized Wilcox Collection of extremist political literature at the University of Kansas in Lawrence, said he, too, has found a resurgence of radical right-wing

activity.

It is within the radical right-wing groups, such as the Klan and Christian Patriots Defense League, Mr. Wilcox said, where "race starts to really predominate. Race and religion start to real-

ly take over.'

One group in this region that typifies the blending of race and religion is The Covenant-The Sword-The Arm of The Lord (CSA), a group of about 100 white supremacist-survivalists who own a 220acre Ozarks encampment near Pontiac, Mo., just north of the Arkansas border.

The members call their settlement Zarephath-Horeb, a name taken from a biblical purging place and from the ancient name for Mount Sinai where, according to the Bible, Moses received the Ten Commandments.

Training for sale

Kerry Noble, a former preacher from Texas who serves as a CSA elder, said any Christian Caucasian interested in learning skills to survive impending race wars or communist invasions can buy the training at the camp.

"We do believe non-whites and Jews are a threat to our Christian, white race and to this country," Mr. Noble said. "We know Jews are financing the training of blacks to take over most of our

major cities.'

To generate financial support, Mr. No-ble and his fellow members of Zare-phath-Horeb travel extensively each month through the Midwest and South to stage \$10-a-ticket seminars where they sell an array of racist, weaponry and survivalist literature.

Mr. Noble said the seminars generally attract about 100 persons interested in joining or supporting CSA, although a recent area session attracted fewer than

"We were very disappointed in the Kansas City turnout," Mr. Noble said.
Mr. Noble agreed that CSA and most other similar groups portray themselves as family-oriented, encouraging wives to become members and enrolling children in classes or training sessions set up to teach them white supremacy and surviv-

Officials said the Midwest also is home to several groups that have formed as churches, although they are similar in nature to the CSA. One such congregation is the Church of Israel near Schell

City, Mo., about 100 miles south of Kansas City.

"We do predict the country will come to an end because of racial conflict," said Dan Gayman, the church leader. Mr. Gayman acknowledges that white supremacy is a basic tenet he preaches to

his membership of 60 families.

"We believe there is no equality, genetically, in the races," Mr. Gayman said. "We believe in the total separation, not

integration, but separation, of the races. The Caucasian people must join lines now on where they're going to stand."

Mr. Suall of the Anti-Defamation
League and Alan S. Katchen, Plains

states regional director for the league in Omaha, said the most threatening aspect of today's radical right movement is the mixing of racist doctrine with paramili-

tary training.
"We are much more into a violentprone state than ever before," said Mr. Katchen, citing nationwide increases in the last two years of synagogue defacings and confrontations between Klan groups and anti-racist demonstrators. "Violence begets violence, it's almost a self-fulfilling prophecy."

Disturbances on rise

The community relations division of the U.S. Department of Justice in Kansas City has reported nearly two dozen racial incidents in Missouri, Kansas, Iowa and Nebraska since 1979, said Pascual G. Marquez, a division official.

The incidents ranged from a cross-burning in the yard of an interracial cou-ple in the Kansas City area in 1979 to confrontations during a Klan rally in

Hannibal, Mo., last April.

While Mr. Suall believes the growth of the radical right has tapered off in recent months, Mr. Harrell said membership is swelling in his Christian Patriots Defense League and in other groups. Mr. Gayman also said the views of his Church of Israel are receiving a better

reception than ever.

More than 25,000 followers are claimed by Mr. Harrell—though official monitor-ing groups peg the figure at 3,000 to 5,000. Mr. Harrell, who has been preaching his doomsday message more than 20 years, said attendance at his annual four-day "Freedom" festivals has about doubled since he began holding the survivalist workshops in the summer of 1979. An estimated 1,500 persons participated that year.

Officials say most of the groups have increased support drives and recruiting efforts. They cite the Klan's recent efforts to recruit youngsters, the Midwest expansion of the militant and white supremacist Posse Comitatus, and an in-

crease in survivalist festivals.

In addition, more groups appear to be weaving the use of weapons into their programs, according to authorities. And they say the radicals are dropping secrecy and are seeking publicity, especially focusing on the growing use of arms.

Scripture a weapon

Many of the new-right militants, including the Christian Patriots and the CSA, hold summer weapons-training sessions that have been characterized as "kill camps," or "hate fests" by antagonists.

The sessions are held in rural areas and train participants in the best type of weapons to use to fend off what CSA and Christian Patriots' leaders refer to as "marauding blacks," "power-hungry

Jews," or 'pinko (communist) invasions." At the camps, interpretations of Scripture also are part of the schooling.

"The Emancipation of Our White Seed, which exists in central Missouri, actually teaches that some minorities are de scended from various animals and still have sexual relations with them," Mr. Marquardt of the alcohol, tobacco and firearms agency, said.

A matter that has concerned many ob-

servers of the radical right is the dearth of government agencies that track the groups' activities. In response to Watergate-era revelations about abuses of domestic spying techniques, Congress and the Supreme Court sharply curtailed

intelligence activities.

"Nobody's watching them as groups," said Max Geiman, a spokesman in Kansas City for the Federal Bureau of Investigation.

He said agents are allowed to spy on individuals suspected of having committed federal crimes but that group monitoring was prohibited under guidelines issued in 1976.

The Commission on Civil Rights, which investigates allegations of civil rights violations, acknowledges that the Anti-Def-

amation League is the only agency moni-toring extremist right-wing activity.

Because of the league's knowledge of extremist activity, the commission, which reports to Congress and the president, signed a \$20,000 contract with the organization in 1981 to prepare a report. The report, not yet released, is titled

"Racism and Violence: The Hate Movement Today."

Mr. Katchen said the league thinks it is imperative that the government again monitor the radical right: "ADL is in famonitor the radical right: "ADL is in favor of stepped-up monitoring of, especially, the paramilitary groups, by the FBI. We are also concerned of the possible weakening of ATF (through federal budget cuts), especially when it involves a cutback in their monitoring duties of groups which use, or are suspected of us-

ing, explosives and automatic weapons."

The fact that the government has pulled back has almost given the groups an invitation to expand, Mr. Marquardt

said.
"There's some bucks to be made by those who organize these right-wing efforts," he said.

"And without normal monitoring, it should surprise no one when they become more militant, more violent and much

Preparing for the day of disorder

oung children learned to use combat knives and martial-arts weapons at a four-day survival festival in June in Louis-ville, Ill., while their parents lis-tened to a doctrine of white suprem-

tened to a doctrine of white supremacy.

The festival, held by the militant Christian Patriots Defense League, looked like a church summer camp. Husbands and wives lounged on the grass overlooking a pond, young children played in a sandbox, stands were set up to sell hamburgers and soda, and meetings were held under a large blue and white striped canvas tent.

ers and soda, and meetings were held under a large blue and white striped canvas tent.

But not far away the setting took on a different tone. Dozens of persons were dressed in combat clothes, children stood with scabbards strapped to their belts and adults tested the heft and trigger action of a semiautomatic weapon.

John Harrell, founder of the league, says the annual festival, which is open only to white Americans, draws thousands of persons who want to learn the techniques necessary for survival in case of a world holocaust and race turmoil.

Dozens of workshops were offered in which visitors could learn how to can food or protect their homes from the racial riots they expect when all social order collapses. Guns, knives, martial-arts weapons (such as nunchucks and Chinese stars), and survival foods were displayed on tables under the canvas awnings.

The backdrop for the festival was the league's headquarters, a largerthan-life replica of Mount Vernon, the home of the nation's first their state delegation of the set with their state delegation.

Visitors were asked to sit with their state delegations as festival organizers sounded roll call. Nearly every state was represented, with most of the visitors coming from Illinois, Missouri and Arkansas.

Leaders share views on supremacy, calamity ahead

The Ku Klux Klan: Midwest growth buovs organizers

len Wells can't understand why people have a low opinion of the Ku Klux Klan.

The 61-year-old Preston, Mo., man, known in the central Missouri hill country as the grand titan of the Klan's 7th District, said the folks who wear hoods and robes are just Midwesterners-Folks who like quiet living, just like you

Take away the sheets and masks, Mr. Wells said, and Klan Klaverns could be mistaken for Jaycee chapters or Masonic

"I mean we help poor white people, col-lect money for white burn victims, and do everything else that those other groups do," Mr. Wells said.

But Midwestern members, said Mr. Wells, suffer because of a "bunch of badapple types in Klans from out East who act like . . . in front of those television cameras."

Mr. Wells and other Klan officials refuse to say how many chapters or members there are in Missouri and Kansas. But law enforcement officials and researchers say that of 12,000 members nationally, 800 to 1,500 reside in the two

"When you talk numbers, you only invite someone or some group to challenge you," said William Kohler, grand dragon of the Joplin, Mo., Klan,

In any case, there is no doubt the Klan exists. Authorities say chapters are found in-but not limited to-the Wichita and Kansas City, Kan., areas and along the Kansas-Oklahoma border. In Missouri, they say, Klan activity abounds in the southeast, central, southwest and Bootheel sections, and in the St. Louis and Kansas City areas.

"The Klan's Midwest growth has been on the rise, just as it has in other parts of the nation," said Mark Nichols, an Overland, Mo., organizer who put together a rally in April in Hannibal, Mo.

It is that growth that has sent organizers on recruitment trails.

And the new visibility has put some activists on a path that is "blackening the good white name of the Klan," said Don McLeod, who said he shed his robe and hood for good because of the Hannibal

"Everything (Mark) Nichols and the others told me to do made us look like a bunch of yo-yos," Mr. McLeod said. "They told me to lie to the press and say we had all kinds of Klan members here in Hannibal. Truth of the matter is, I was the only one.'

Mr. McLeod isn't the only one upset with the Hannibal event. Mr. Kohler and Mr. Wells say they and Midwesterners take pains to avoid activities that attract "crazies . . . We don't get our members that way."

The way the Klan does recruit is fairly consistent throughout the region.

Bill Snyder, a grand dragon in Weaubleau, Mo., south of Sedalia, said anyone who wants to join must contact an active member and underge screening by a spe-

There are no identifying marks, no hidden symbols and no secret languages linking members of groups of right-wing extremists that populate the Midwest. Some are on welfare. A few are millionaires, Some

are highly educated; others are not. Some come from

urban areas. Many grew up in the country. What they share is white skin and a belief that non-

whites are genetically inferior.

They also share a vision that the world is skidding toward calamity and that Caucacians excluding Jews-have been chosen by God to prevail after the second coming of Jesus Christ.

For some the lure is patriotism, for others it's ma-

chismo. Some see it as divine direction, and others are drawn by the community of the combat-ready. To understand the attraction of the ultraright-wing

and the types of people who have joined the movement, Deborah Singer and Roger Moore, staff writers for The Kanzas City Star, profile some of the region's

Kohler said. "We try to find out what kind of person we have here."

Once an applicant is approved, Klan sources said, each is initiated in a 45minute to one-hour ceremony in which they recite secret pledges and oaths.

"There are no silly initiation tricks or anything," Mr. Wells said. "It's sort of religious.'

Initiation fees are \$15 to \$40. Monthly dues average \$7.50. Linen robes and hoods cost \$15 to \$30 and satin models sell for \$40 to \$50.

All Klan members interviewed said they still burn crosses at private rallies. "But that's just for our ceremonies now," Mr. Kohler said. "We now leave cards in somebody's windshield when we want them to know we've been there."

Members of Missouri's Black Leadership Association can attest to that tech-

Late last year top black government officials from across the state gathered at a small diner in Hayti in the Missouri Bootheel, said Alvin Brooks, a top official in Kansas City, president of the group and chairman of the Missouri Human Rights Commission.

When the officials went to their cars they found dozens of calling cards that read: "You have been patronized by the

"I had read and had been told the Klan was going through a resurgence," said Mr. Brooks. "But until this incident, I had simply assumed the growth was taking place in the Southern states."

Survivalism with a religious bent

ith all the affability of a smalltown politician, John R. Harrell, leader of one of the nation's largest militant right-wing organizations, delivers his dire warning:

"The country's in deep trouble. We're going into revolution. It (the catalyst) can be economics. It can be race. It can be direct attack.

And he warns that if you want to survive, you had better be a Christian, a patriot or both.

In the pantheon of gods on the far-right wing, Mr. Harrell is a major deity. He claims 25,000 followers, and he has dotted the Midwest with survivalist camps.

What he preaches is white supremacy. racial purity and separation, survivalism, zealous patriotism and fundamental 'We contact folk from the applicant's Christianity. He offers paramilitary home county and hometown," Mr. training, instruction in survival skills

and the opportunity to be one of the blessed who will serve when Jesus Christ returns "to head up this government after the holocaust."

After more than 20 years of preaching the same sermon, Mr. Harrell, 60, and a millionaire several times over, said people are starting to listen.

"The '60s were sizzling times," said the silver-tongued orator and unsuccessful 1960 candidate for the U.S. Senate from Illinois. "A patriot didn't raise his head. It's almost popular to be a patriot now-almost, but not quite."

Mr. Harrell should know. In 1961 his 55acre farm was raided by federal agents and he was arrested and sentenced to 10 years for providing sanctuary to an AWOL Marine and for resisting federal officers.

At the time, Mr. Harrell was leader of the Christian Conservative Church, which "blended Christianity and patriotism together to effectively oppose Zio-nism and communism." He and his small band of followers were living off the land at Louisville, Ill., at the time of the raid, which he said was contrived by the Kennedy administration.

After serving four years, Mr. Harrell was released and again spread the word of impending anarchistic revolution.

From his Christian Conservative Church evolved the Christian Patriots Defense League in 1977, and the Citizens Emergency Defense System in 1978. The defense system encompasses the group's paramilitary operation and is headed by retired U.S. Army Col. B.F.M. von Stahl, who holds the rank of major general.

The brigadier general of the system,

created to "provide a last line of defense and safety for its people . . . in the event of a complete breakdown of existing authority," is retired Army Col. Gordon

Through "spiritual prompting," the Christian Patriots have designated a "Mid-America Survival Area"-all of Missouri and Kansas and parts of 18 oth-

In Mr. Harrell's view: "If the Mid-America Survival Area can be held and maintained until it gains the strength needed, it is felt it can . . . overpower and evict any alien forces holding territory within the borders of the United States of America."

How do religion and killing mesh?

"Most certainly you do not kill needlessly under any condition," Mr. Harrell said. "But there comes a time when, if you want to remain free, you have to kill

For \$200, elders of this white supremacist movement, known as The Covenant-The Sword-The Arm of The Lord, will take you to Silhouette City and teach you to survive race wars or communist inva-

They will, by burning old tires, make it appear the row of gutted buildings and wrecked cars has been set afire by marauding minorities or a nuclear holo-

Kerry Noble, an elder, lives with 100 others at the settlement near Bull Shoals Lake on the Missouri-Arkansas border. They arm themselves with guns and Bi-

"We are Christian survivalists who believe in preparing for the ultimate holocaust," Mr. Noble said at a recent fundraising seminar in the Kansas City area.

The ultimate holocaust, he says, will either be a takeover of the country's largest cities by non-whites and Jews or a devastating nuclear war.

"We know that Jews are financing the training of blacks to take over the major cities," said Mr. Noble, who formerly a Baptist minister in Texas, "We teach weaponry and other skills to all whites interested in preparing for their surviv-

Founded in 1976, CSA-unlike other similar groups-does not have or want not-for-profit status with the Internal Revenue Service, Mr. Noble said, although he conceded members have accepted welfare when the group is unable to cut timber for income.

The CSA travels the Midwest and South to hold monthly survivalist seminars designed to raise money and spread white supremacist messages.

"We do believe in the superiority of the white race, and we do believe in the Bible's teaching that races should not mix," Mr. Noble said.

Upset that publicity about their settlement is concentrating on their racist rather than religious beliefs, Mr. Nobel recently banned reporters from the settlement.



f you want to hear Dan Gayman preach of white supremacy at his Church of Israel in the backwoods. near Schell City, Mo., you'd better have an invitation-and you'd better be white.

"At the present time we have a very close screening process," Mr. Gayman

Mr. Gayman said he fears that the church doctrine of white separation and purity, mixed with a sermon about im-pending world chaos, could attract hostile non-whites.

"We simply want to have the right and privilege to have a racially separated congregation, because it is what the Bible preaches," Mr. Gayman said.

The church compound includes a school for about 30 children. The main tabernacle is across the road from a complex of cabins that surrounds a large brick building. That is where the church holds "festivals" that area authorities say attract hundreds of sympathizers.

Mr. Gayman, a former Walker, Mo., high school principal, and three of his brothers belong to the church he founded in 1973 after a feud with a fourth brother. Duane. Dan Gayman contended his brother was influenced by the 1960s civil rights movement and was considering worshiping with blacks.

He said that is contrary to the beliefs of his ancestors, who moved from Denver to southwest Missouri in 1938 with several other families, all seeking refuge from race conflicts and urban turmoil.

The two brothers now have separate churches a few hundred feet apart on land staked out by their father and grandfather. Dan Gayman insisted his church holds close to the fundamentalist tenets of his forefathers, and he criticized his brother for straying.

Shortly after the brothers' feud, Dan Gayman became affiliated with the National Emancination of Our White Seed, a group described by Irwin Suall, director of research for the Anti-Defamation League of B'nai B'rith, as "a very extreme organization."

One of the more memorable reminders of Mr. Gayman's affiliation with the militant group is a news picture taken in 1976 when Mr. Gayman and 10 followers were arrested for trespassing at Duane Gayman's church. The photograph shows the men standing in front of a banner emblazoned with the group's name, holding their arms high in a Nazi-like salute.

Mr. Gayman said he left the Emancipation group because of its militancy. He denied reports that his church keeps an arsenal and said he has never advocated violence against non-whites or the government.

To support his contention that nonwhites are genetically inferior, Mr. Gayman read from a 1911 edition of the Encyclopaedia Britannica:

Mentally the Negro is inferior to the

He ignored the part of the article that says the lot of blacks was largely the result of white oppression.

Judiciary Committee

Kansas Legislature

Ladies and Gentlemen of the committee:

Eight days ago, bursts of automatic weapons fire at the North Dakota village of Medina left two U.S. marshals dead and a third critically wounded.

Five suspects were arrested. In the search for a sixth suspect, Gordon Kahl, law enforcement officers found a farmhouse containing up to 50 guns and 50,000 rounds of ammunition.

Kahl was identified by officials as a member of Posse Comitatus, a right-wing paramilitary group, and as a convicted income tax evader who had vowed he would not be taken alive for probation violation.

This tragedy was spawned by the Posse's cyncial view of history and government, survivalist mind set, and incitement to vigilante violence.

Posse Comitatus is one of many religious and political organizations which justify the bypassing of judicidal and legislative processes and the use of violence to attain their goals.

They exploit the misery and despair of the unemployed worker and the fears of the bankrupt farmer. They focus their hatred upon Jews, whom they accuse of conspiring to control the world through economic means. They also hate blacks, Hispanics and other minority groups whom they see as inferior, and judges, whom they see as interfering with their rights.

Last November a "Citizens Grand Jury," following the preachments of such right-wing organizations, issued an "indictment" calling 10 Kansas judges "outlaws." It ordered all Kansas sheriffs to apprehend and incarcerate them for three years.

The "indictment" threatened that if the sheriffs should fail to do so, the judges would end up in "Potters field."

These indictments were mailed to all Kansas sheriffs.

In response to the threats it perceived from these groups to the public peace and safety, the Kansas Bureau of Investigation held a seminar about them for law enforcement officials earlier this month in Salina.

Lest there be any mistake about the seriousness of the threats these persons pose to the general peace and safety, let me quote from some of their own material and from news interviews with their leaders (my apologies to my Jewish and black friends for having to repeat these attacks):

- 1. From The Covenant, the Sword, the Arm of the Lord (CSA):
 "God wants Christians to kill their enemies...God's enemies
 include Jews, who are natural enemies of Christians."
- 2. From James P. Wickstrom, Posse Comitatus official:
 "Better start choosing a telephone pole for your favorite
 legislator...The Posses of the Plains States KNOW THEIR
 ENEMIES and will do their job very soon...A prairie fire is
 starting to burn in the West which will not go out until all
 the telephone poles are occupied with bodies. By the way, how
 do you get a Jew or a corrupt judge out of a tree? CUT THE ROPE...

Yes there is power in prayer, but there is more in PRAYER AND A 12-GAUGE SHOTGUN."

- 3. From the official Posse Comitatus Manual: Any official who fails to do his duty as the Posse interprets it "shall be removed by the posse to the most populated intersection of streets in the township and, at high noon, be hung by the neck, the body remaining until sundown as an example to those who would subvert the law."
- 4. From National Identity broadcasts on KTTL-FM, Dodge Mariposa, Califo
 City, by Rev. William P. Gale, retired U.S. Army colonel:
 "Empty skulls in Washington, D.C...going to get filled up or busted -- one or the other very soon...You're either going to get back to the Constitution of the United States in your government or officials are going to hang by the neck until they're dead -- as examples to those who don't."
- 5. From Gale's broadcasts: "If you won't fight for your God, you won't fight for the country and don't get in my outfit or don't get in my way because we're going to fight for Jesus Christ, and anybody who gets in the way is going to get wiped out."
- 6. Gale's broadcast: "If the Jews even fool around with us, or try to harm us in any way, every rabbi in L.A. will die within 24 hours... Every state in this union has a hard core Identity group."
- 7. "You're here to fight. You're not here just to be lovers...You're God's battle-axe...They're going to cleanse this land...with blood...Isn't that going to be fun."

As repugnant as their views are to most Americans, these radicals are guaranteed the right to express them and to seek

adherents for their causes. Our quarrel is not with the free expression or exchange of ideas. Let the warfare consist only of the clash of ideas.

But the North Dakota incident -- the most recent and most violent to date -- indicates that the battles envisioned by the Posse Comitatus and similar hate groups is not only a battle for the minds of men.

Last March a weekend guerrilla-type training session was conducted by the Posse Comitatus near Weskan, along the Colorado border. Among the instructors were former Vietnam special forces veterans.

Instruction was given in such activities as making explosives, guerrilla attacks, booby traps, use of poison and knives, silencers, ambushes, hand-to-hand combat techniques and sniping.

And there for the simulated "fun" was the Rev. Mr. Gale.

Again, our quarrel is not with words, but with actual terrorism and violence, and the training of paramilitary forces to perpetrate them.

The point at which government can and should intervene is the point at which philosophy becomes conspiracy, where rhetoric becomes terroristic threat, and where inflamatory speech becomes guerfilla training -- not merely to defend against some imagined enemy, but to oppress and destroy minority citizens, and to intimidate and punish duly-elected officials.

It is not enough to wait for these people to attack, to hang a judge, firebomb a synagogue, or lynch a black man. We

must serve notice to these hate peddlers that we will not yield due process to mob violence. And we must provide for our law enforcement agencies every legal tool with which to stop violence while it is in the making.

I am Delwin Goheen of Beloit, Kansas.

I have been a law abiding citizen of the United States and the State of Kansas for the past 58 years. During that time I served four years with the United States Navy during WW II, and for the past 19 years I have served with the Kansas National Guard.

I am presently serving my second year as President of the Kansas State Rifle Association, Inc. In this state there are approximately 37 clubs affiliated with the KSRA plus nearly 1000 individual members, and more than 1000 Kansas Trap Shooter Association members. We are concerned about House Bill No. 2269. This bill, if enacted, could be construed to ban all target practice, either formal or informal, and all matches or competition of any kind that are held in many areas of Kansas. KSRA sponsors approximately 12 matches of different types annually and approximately 2000 law abiding citizens compete each year.

Since the Hunter Safety Course was made mandatory by Kansas Law eleven years ago, I have been a Master Instructor for the Kansas Fish and Game Commission. By law, anyone born after July 1, 1957, must train and pass the course before he or she may hunt. A session of live firing and target practice is encouraged by the Kansas Fish and Game Commission.

This bill, if enacted, could be an infringement on our individual rights to gather, even in our homes, for discussing and "conversationalizing" on riflery of any kind and we as upright citizens will be the ones treated as lawbreakers.

House Bill No. 2269, if enacted, would have no deterrent effect on subversive or paramilitary groups - these people are violating existing laws and have stated that they will continue to do so. The addition of any law of this nature will in no way deter them. The Ku Klux Klan has violated many laws and the Klan continues to be in existence.

THE GREATEST COMMANDMENT

(Matthew 22: vs 34-40)

34. "But when the Phar-i-sees had heard that he had put the Sad-du-sees to silence, they were gathered together.

35. Then one of them, which was a lawyer, asked him a question, tempting him, and saying,

36. 'Master, which is the great commandment in the law'? 37. Jesus said unto him, 'Thou shalt love the Lord thy God with all thy heart, and with all thy soul, and with all thy mind'.

38. This is the first and great commandment.
39. And the second is like unto it, thou shalt love thy neighbor as thyself.

40. On these two commandments hang all the law and the prophets'.'

What happens to a people when they (as a group) fail to obey this Commandment?

For the answer to this question, you will have to study the Old Testament in the King James version of the Bible.

POSSE COMITATUS

There has been much discussion about the "Posse Comitatus" lately. We think there is much confusion concerning the Posse. Some call it a "vigilante" group. Others call it a "radical" group. Still others say the posse's beliefs clash with those of law. The sad part is that all these newspaper articles use these words and statements in such a way as to confuse the general public as to the real function and purpose of the Posse Comitatus. Maybe a few definitions will clear some of our minds:

70 American Jurisprudence 2d defines Posse Comitatus at section 30 as: "the male population of the County" or "the power of the County'

80 Corpus Juris Secundum defines Posse Comitatus at section 34 as: "the whole power of the County".

Could the Posse Comitatus possibly be called the "Militia"? Let's see what Kansas law says:

K.S.A. 48-101 defines Militia as: "those able-bodied male citizens prescribed and contemplated in article 8 of the Constitution of Kansas"

Article 8 of the Constitution of Kansas reads as follows: sec. 1. "Composition; exemption. "The militia shall be composed of all able-bodied male citizens between the ages of twenty one and forty five years, except such as are exempted by the laws of the United States or of this State"

The World Book Encyclopedia Dictionary defines Posse Comitatus as: "the entire body of male citizens, as the body from which a sheriff is authorized to call for aid in keeping the peace and carrying out certain of his other duties as an officer of

Do the above definitions make you think of the entire able-bodied citizens of the County as "vigilantes"? or as being "radical"? or as having beliefs that clash with those of law?

If you are a male citizen of Osage County, and are between the ages of twenty one and forty five, you are a member of both, the Posse Comitatus, and the militia.

What is a Vigilante? A vigilante is defined by the World Book Encyclopedia as: "a member of a vigilance committee". A vigilance committee is defined as: 1. "a self-appointed and unauthorized committee of citizens to maintain order and punish criminals in a community where law enforcement is imperfectly or insufficiently organized". The word vigilance is defined as :n. 1. "watchfulness; alertness; caution".

Is there something wrong with the citizens of the county if they are watchful, alert, and cautious about some of the things

our government is doing?

It looks like our news media and television industries have been working overtime to "educate" us that "Posse's" and "vigilante groups" are something to be avoided. Shouldn't our Sheriff, instead, be informing the Posse Comitatus (militia) to arm themselves, as provided for in the 2nd amendment, in the event that subversives(Bureaucrats) should try to take over our government?
