Chairman called meeting to order.

Chairman called members attention to the letter from Mr. Smith of the Ks. State Board of Embalming, (see Attachment No.2.), and recognized Mr. Smith as conferee. Mr. Smith stated his position and requested committee to introduce a bill to amend K.S.A. 65-1721 to include:-- "(c) The board shall have the right to administer a written or oral examination of the statutes and regulations that govern funeral directing in the state of Kansas." This statute change will allow HCR 5011 to keep its present form.

Conferee Mr. Jim Snyder also made a few comments in regard to this request.

Representative Harder moved that this bill be requested as stated, Rep. Hassler seconded the motion, and motion carried.

Discussion followed on HB 2012.

Discussion centered on whether this was creating a duplication of the scope of the State-wide Health Coordinating Council, what its function would actually be.

The make up of the commission, what the cost of such a commission would be, its scope, whether policy making or advisory only.

Motion by Rep. Niles to pass HB 2012 favorably, seconded by Rep. Wagnon.

Substitute motion by Rep. Hassler to amend bill as follows: In line 23, by striking "ll" and inserting in lieu thereof "l3"; also in line 23, by striking "five" and inserting in lieu thereof "seven"; in line 27, by inserting before "one" the following: "one of whom shall represent the county health department, one of whom shall be a licensed professional nurse,"; On page 2, in line 49, by striking "six" and inserting in lieu thereof "seven"; in line 50, by striking "six" and inserting in lieu thereof "seven"; motion seconded by Rep. Helgerson.

In depth discussion especially concerning Public Health Department and possible duplication of professionals.

Dear Representative Littlejohn and Members of the Committee,

The Kansas State Board of Embalming would like to request a statute change in conjunction with HCR 5011 that has been assigned to the House Public Health and Welfare Committee. The board would like K.S.A. 65-1721 to be amended to include the following: (c) The board shall have the right to administer a written or oral examination of the statutes and regulations that govern funeral directing in the state of Kansas.

The above statute change would allow HCR 5011 to keep its present form.

The reason that the Embalming Board is requesting this change is so that a person applying for a reciproca! funeral director license will be subject to an examination over the states statutes and regulations governing the funeral laws. While it's true that close to 90% of the states in the U.S.A. require a written examination in order to obtain a funeral director license, it should be noted that the examination is over that particular states laws. No two states have identical laws in the area of funeral directing, and the board feels that it would be better to administer an examination on the laws opposed to simply requiring an applicant to sign a piece of paper stating that they have read, understand and will abide by the rules of our state.



65-1721. QUALIFICATIONS; PERSONS FROM OTHER STATES. (a) The board may, in its discretion, upon payment of the fees herein provided for, issue licenses to funeral directors residing in other states, and who are funeral directors in good standing in their own states, and whose methods of transacting business do not, in the opinion of the light, violate any of the laws of Kansas, or the rules and regulations of the logical.

and engage in that business in this state, the funeral director shall not be required to serve ane year as a license assistant funeral director in this state if the funeral director favorably recommended in writing by the license board of the state of the funeral director's previous residence, and has had at least one full year of actual experience as a funeral director, in that state, and if the state of the funeral director's previous residence has educational requirements for funeral directord at least equal to those in Kansas, such person shall pay the same fees as required of other applicants on this state.
