The meeting was called to order by Chairman Bunten.

New members of the committee were welcomed by the Chairman and he urged them to feel free to ask any questions as they should occur. Former members of the committee were welcomed back. The Chairman introduced his new office staff to the members of the committee as well as the staff serving the Ways and Means committee.

The Chairman advised the committee that promptness will be necessary this year in order to accommodate those members of the committee that are assigned to other committees meeting at 3:30 p.m. He stated that the meeting time may need to be adjusted in the future if the 1:30 time does not prove to allow enough time.

Chairman Bunten suggested that if there are specific questions on a budget item, that it would be helpful if those questions be directed to the subcommittee chairman, in order to save time in the regularly scheduled committee meeting. However, he stressed that questions would always be welcome from any committee member at any time.

With regard to subcommittee work on House appropriations bills, as has been the custom in the past, agency studies that originated in the Senate for the past two years will be studied in the House for the next two years. Chairman Bunten added that the sub-committee chairmen were selected with the input of the Speaker and with consideration being given to the work load of the committee members. Those members serving as chairmen of other committees are not serving as sub-committee chairmen of Ways and Means.

Chairman Bunten pointed out that it will be the policy of the Speaker and this committee to deal with the financial problems of the 1984 budget by getting the best estimate as to what our income will be, to determine what we think is a reasonable balance at the end of fiscal year 1984 and to hold spending to within that dollar amount. There will undoubtedly have to be some difficult decisions made in regard to the 1984 budget.

Marlin Rein, of the Legislative Research Department, was called upon by the Chairman to introduce his staff serving in the Research Department. He indicated that copies of the agency assignments will be given to the members of the committee. (See Attachment). Committee members were given copies of Proposed Schedule of Deadlines for Subcommittee Review of State Budgets, Subcommittee Assignments on House Appropriations Bills, Special Individual Assignments and Subcommittee Assignments on Senate Appropriations Bills. (See Attachments).

A tour of the Lansing facility will be conducted for any interested committee members on Thursday, January 13, 1983. Any committee member wishing to go will be excused from the regularly scheduled committee meeting at 1:30 p.m.

The meeting was adjourned by the Chairman at 2:15 p.m. Following adjournment, orientation for new committee members was conducted by members of the Research staff.
