Senator Gaar opened the hearing on H.B. 2201, concerning licensing of dogs in unincorporated areas. Representative Duncan, who sponsored the legislation at the request of Wichita, Kansas, explained its intent and responded to questions. Mr. Dewey and Mr. Allen appeared as proponents of the bill.

Representative Matlack explained and expressed support of H.B. 2333, addressing the method of reimbursement of funds to the fiscal agent for the redemption of bonds and coupons. Mr. Dewey presented testimoney in support of the bill. Senator Gaar distributed copies of a letter from the office of the State Treasurer describing the fiscal impact of the bill on that office (See Attachment I). Senator Daniels moved to report the bill favorably for passage. Senator Mulich seconded the motion, and it carried by unanimous vote. Senator Daniels was appointed to carry the bill.

Mr. Kaup addressed the committee in support of  $\underline{\text{H.B. }2210}$ , establishing a procedure for the dissolution of drainage districts. Senator Gaar advised that he will reopen the hearing on H.B. 2210 the week of March 21, in response to a request.



HB 2333 Senate Local Government Committee Hearing March 16, 1983

- 1. Law allows only cities to file certificate and remit three days ahead of maturity change lets all municipalities do the same.
- 2. Three factors of operation earn interest for General Fund:
  - a. investment of funds for twenty days
  - b. coupon and bonds presented after due
  - c. check float
- 3. Fiscal agency second largest state depositor. Current earnings  $1\frac{1}{2}$  million year. Last year deposits of 198 million.
- 4. Assume all money comes in only three days in advance 50% reduction in earnings \$750,000.
- 5. Last year actual earnings on certificated funds received 3 days in advance \$24,000.

  If we had money for 20 days could have earned \$146,000.
- 6. 14% of money received last year was remitted three days prior to maturity (by cities that had option) 20 30 cities
- 7. State does not charge local units commission on coupon collections.
- 8. Charges \$1.25 per bond.
- 9. Sends cancelled bonds and coupons back with no postage reimbursement required of local units.
