Mr. Heim briefed the committee on the intent of <u>H.B. 2010</u>, which would permit a governing body by resolution to delay the assessment of actual costs of improvements within a sewer district for up to 10 years. Mr. Anson informed the committee that the Johnson County Board of Commissioners supports the bill. <u>Senator Allen moved to report the bill favorably for passage</u>. <u>Senator Ehrlich seconded the motion and it carried by unanimous vote</u>. Senator Allen was assigned to carry the bill.

Senator Bogina presented the subcommittee's report on H.B. 2334 and H.B. 2335, both pertaining to plats, and the following action was taken: Senator Bogina moved to amend H.B. 2334 in line 41 by striking "single ownership" and inserting "the ownership of the party who caused the plat to be prepared; by inserting "approving" preceding "city"in line 42; and by inserting "after substantiation of the existence of the error" following "located" in line 43. Senator Mulich seconded the motion, and it carried. Senator Bogina then moved to report H.B. 2334, as amended, favorably for passage. Senator Mulich seconded the motion, and it carried by unanimous vote. Senator Bogina advised that the subcommittee recommended no amendments to H.B. 2335 and moved that the bill be reported favorably for passage. Senator Mulich seconded the motion and it carried unanimously. Senator Bogina was assigned to carry both bills.

Senator Mulich moved to report H.B. 2374, authorizing establishment of a sheriff's imprest fund, unfavorably for passage. The motion died for lack of a second. Following discussion, Senator Mulich again moved to report the bill adversely. The motion was seconded by Senator Bogina, and it carried by a vote of 3-2.

A discussion of <u>H.B. 2438</u>, concerning publication of real estate subject to sale for nonpayment of taxes, followed. <u>Senator Ehrlich moved to report the bill favorably for passage. <u>Senator Mulich seconded the motion and it carried by unanimous vote</u>. <u>Senator Mulich was appointed to carry the bill.</u></u>

Senator Ehrlich moved, and Senator Bogina seconded, to approve the minutes of the March 24, 1983, meeting as distributed. The motion carried.

The meeting was adjourned.
