Mr. Chairman and members of the Committee...Thank you for the opportunity to present this proposed legislation.

This bill is being presented because of the economic crisis facing agriculture. For many years farmers and ranchers have used the Production Credit Association and the Federal Land Bank as integral parts for their financial needs, assuming they would stay with them through the bad years as well as the good years.

Not so. Since the present administration in Washington, D.C. has been in power, we have seen much pressure from David Stockman to reduce the monies appropriated by Congress through the Fm.H.A.

As recently as the last six months we are seeing thousands of Kansas Farmers being foreclosed upon by the Farm Credit System.

Many farmers for the first time in their lives are facing the loss of their life's work and, in many instances, the loss of farms that have survived several generations as a family unit.

Now farmers are in a panic to try to save what they had thought was safe and secure from foreclosure. The loan agencies mentioned here in my legislation have suddenly become foreign to the people they serve. Many feel they have no recourse to delay the action of foreclosure. Many feel they are being denied due process of law by the agencies' action.

Atch. I 2/16/84 Mr. Chairman and members, I could go on for hours relating terrible stories of how people have been treated by the actions of the Federal Land Bank and Production Credit Association foreclosures.

Now the word is out for farmers to stand up and be counted. Actions have been taken by many to bring charges against these federal entities. They are asking for facts and figures to use to defend themselves.

I feel this small act requiring disclosure at the State level is but a small thing to ask of these organizations. I know their reports are made and sent to Washington regularly, and I feel a copy to the Secretary of State's office would only indicate good faith on their part.

These organizations must realize if they are going to serve the people in agriculture in the years to come they too must do their utmost to be honest and helpful to see agriculture through this crisis.

In closing I have been made aware that if the Farm Credit
Act is going to continue to serve agriculture instead of bailing
out when the times are tough, we will surely see action coming
from Congress. In a very short time those in the Farm Credit
System are surely going to suffer by not being responsive to the
needs of the people they serve.



TESTIMONY TO COMMITTEE ON COMMERCIAL AND FINANCIAL INSTITUTIONS REPRESENTATIVE HAROLD P. DYCK, CHAIRMAN BY DONALD P. EDSON, VICE PRESIDENT, FEDERAL INTERMEDIATE CREDIT BANK OF WICHITA

Ladies and Gentlemen:

I appreciate the opportunity to testify in opposition to House Bill 2809. My name is Don Edson and I am Vice President of Administration for the Federal Intermediate Credit Bank of Wichita. Our bank, a wholesale bank, supervises and provides services to production credit associations in Kansas, Colorado, Oklahoma, and New Mexico, the Ninth Farm Credit District. We join with Federal Land Bank and Federal Land Bank associations and the Bank for Cooperatives to form the Farm Credit System in these four states. There are similar configurations of organizations in eleven other districts covering the United States and Puerto Rico.

The Federal Land Banks and Federal Land Bank associations provide mortgage credit, backed by first mortgages on farm real estate, to farmers and ranchers. Production credit associations provide short and intermediate term operating credit and family living expense money to farmers and ranchers. The Federal Intermediate Credit Bank supervises PCAs and also discounts agricultural notes of certain other financing institutions. The Bank for Cooperatives supplies all credit needs of farmer-owned cooperatives.

Together, these institutions in Kansas have approximately \$2.9 billion outstanding to almost 35,000 farmers, ranchers, and cooperatives.

Atch. III. 2/16/84 The Farm Credit System was incorporated under federal law beginning in 1916. The entire Farm Credit Act was rewritten in 1971 and specific amendments added to that Act in 1980 by the U. S. Congress. The entire Farm Credit System is regulated and supervised by an independent federal agency within the executive branch of government, the Farm Credit Administration in Washington, D.C. Should you or your research people have need for further information about the Farm Credit Act or its amendments, we would be happy to provide copies at your request.

Although originally capitalized by government funds, the Farm Credit System was later authorized to repay those funds and that process was completed in 1968. Therefore, the entire Farm Credit System is owned and capitalized by its borrowers—farmers, ranchers, and cooperatives.

The specific mission of the Farm Credit System is to improve the income and well-being of American agriculture through the extension of sound and constructive credit to farmers, ranchers, and their cooperatives. Nationwide, the System extended over \$75 billion of credit to these groups in 1983. In Kansas alone, the Farm Credit System extended \$2.9 billion of credit to approximately 35,000 farmers, ranchers, and their cooperatives last year. Because I know you're quite interested in the health of Kansas agriculture, I have attached to my remarks a copy of a situation report that we prepared for the congressional delegation from Kansas on a recent visit to Washington, D.C.

The System obtains its money through the sale of securities, bonds and discounts notes primarily, to the investing public worldwide. This process

is accomplished through the Federal Farm Credit System Funding Corporation, headquartered in New York City. Those bonds and discount notes require that we extend sound and constructive credit to farmers, ranchers, and their cooperatives because of our need to maintain a spotless image of being able to repay all borrowed funds on time and at the prevailing rates of interest. To this date, in the 65 year history of the Farm Credit System, that goal has always been met. As a result, because of our size and the perceived safety of our securities, the Farm Credit System securities sell at comparable levels to United States Treasury notes in the agency market. That economical rate is of large benefit to agriculture, particularly during these kinds of times.

Recognize, however, the importance of our continuing to extend sound credit with minimal losses to American agriculture. Anything less and the investors' perception of the safety of their investments would suffer and our rates would increase as a result.

Each member borrowing funds from the Farm Credit System has one vote in the operation of their organization. Therefore, at the annual stockholders meeting of membership, a complete disclosure of all financial information is provided to every stockholder. Additionally, most associations have continuing newsletters and other correspondence with their membership and reveal fully all of the information necessary for their making sound business judgments regarding their organization. The current annual reports to stockholders of Farm Credit System organizations are much more detailed than are required by any individual secretary of state's office. Publication of these annual reports makes all of this information on operations a matter of public record and available to all who can use it.

Should an association suffer undue loss through mismanagement or conditions beyond control, the stockholders of that organization, as would be the case with any corporation, are subject to losing part or all of their investment in the association. Each time a member borrows funds, they are required to capitalize their loan to as much as ten percent of its face amount. That stockholder capital is at risk, should the association fail. Thus far, no association in the Ninth Farm Credit District has ever suffered losses to that extent and member capital has never been impaired. Again, however, the importance of extending sound credit is emphasized.

Finally, in recognition of the aforementioned information, we feel it would be imposing an undue hardship on our associations to meet the terms of House Bill 2809. Our associations are currently providing stockholders, their supervisory bodies, and interested parties outside the association with more extensive information than other corporations are required. We are doing that annually and feel that providing the information semiannually to the secretary of state in Kansas is an unnecessary duplication and an imposition of additional and unneeded work on each of our organizations. These reasons are in addition to the serious constitutional problems which have been identified by our bank's legal staff and which will be addressed by the Federal Land Bank's general counsel, Ray Brummett.

Therefore, Mr. Chairman and ladies and gentlemen of the committee, we recommend that favorable action not be taken on this bill.

This concludes my prepared remarks and I again want to thank you for your time and attention for the opportunity to express our views.

WICHITA FARM CREDIT BANKS SITUATION REPORT December 1983

The Farm Credit Banks of Wichita are a major source of credit for farmers, ranchers, and their cooperative agri-businesses. Providing this financial resource is a continual challenge because of the volatile economic and natural environments. Net farm income has been depressed for several years and prospects for near-term improvement appear to be very limited.

The payment-in-kind program provided some help during 1983, but exceptionally good wheat yields kept prices under pressure. The livestock industry is also troubled by lack of profitability. A severely hot, dry summer further compounded the problem for producers of major fall crops -- corn, soybeans, and grain sorghum. These factors, combined with continued high interest rates and reduced land values leave much of agriculture with a very depressed financial position.

Borrowing by farmers and ranchers has trended downward as producers looked for ways to cope with the economic squeeze. Sound credit administration and financial management continue to receive heavy emphasis in financial planning and counseling provided by the lending institutions of the Farm Credit System.

Our system is well-equipped to serve the changing needs of agriculture because of the lessons learned during our successful history of providing sound credit through both good times and bad. Chartered by Congress, the system was initially capitalized by government, but designed to obtain lending funds from the investing public. All government funds were later repaid, and the entire cost of the system, including the Farm Credit Administration as the supervisory body, is paid from the interest received on loans to farmers, ranchers and their cooperatives.

Our primary source of loan funds comes from the sale of bonds which are marketed by the Federal Farm Credit Banks Funding Corporation through a network of bond dealers. While these bonds are not guaranteed by the government, they do enjoy agency status. That, coupled with the financial strength of the Farm Credit System and of American agriculture, causes them to sell at very attractive rates.

Were it not for our success in the money markets, we would find it difficult to continue serving agriculture with adequate amounts of reasonably priced credit. With the recent release of the report on the presidents private sector survey on cost control (a study headed by Peter Grace), we again note attempts to remove the agency status of the Farm Credit System. Such a move would damage our attempts to help agriculture in the future.

As always, but especially during these periods of economic adversity, it is very important for the Farm Credit System to be a strong, reliable source of reasonably priced credit so that farmers, ranchers, and their cooperatives can continue to provide the necessary food and fiber for our country and deficient areas of the world.

The Federal Land Bank has seen a slight increase in both the number of delinquent loans and foreclosures since last year, but neither have reached alarming proportions. At the end of calendar 1983, payments were current on 95.15 percent of all land bank loans. This compares with 96.09 percent the previous year. Because of the large number of loans with annual payments due after the first of the year, the January 31 repayment rate is expected to worsen.

If the present disparity in our agricultural economy continues another year, land bank borrowers will encounter further difficulty with repayment. Land bank lending for 1983 fell 52 percent below the 1982 level, reflecting a very cautious attitude toward expansion felt by most farmers and ranchers. Both the number and the amount of land bank loans outstanding decreased during 1983, falling to 66,963 loans for \$5.153 billion from 68,023 loans for \$5.229 billion a year earlier.

The numbers of farmers and ranchers in the district borrowing from production credit associations continues the decline that began in mid-1981. Reasons for the decline include the conscious attempt by producers to reduce borrowing through sale of assets to infuse additional capital into the operation, delayed purchases of equipment and other capital items, and the inability of certain producers to qualify for sound credit in view of extremely adverse economic conditions. Actual dollars lost and loans in the process of liquidation increased substantially in 1983 and are projected to show little improvement in 1984.

The extreme financial difficulty being experienced by producers has had an adverse effect on the financial health of some production credit associations. Where critical, special supervision, mergers and other techniques are being used to assure continuous availability of credit to worthy producers. Overall, reduced loan volume and earnings capacity and the use of loss reserve funds is not critical in the district's associations, but certainly the trend cannot continue over the long-term.

As a result of difficult economic conditions and the PIK program, farmers and ranchers have reduced their demand for products and services offered by agricultural cooperatives. Grain and cotton handled by local cooperatives has also been impacted by the PIK program and drought in fall-crop production areas. These factors have resulted in a reduced demand by cooperatives for credit from the Wichita Bank for Cooperatives. Local cooperatives' operations vary according to management capacity to adjust operations to current conditions. Cooperative liquidations have increased somewhat during the past two years but represent less than two percent of bank borrowers. The bank's credit staff is continuing to work closely with cooperatives as they adjust operations.

Solutions to agriculture's current economic problems will not come easy, but they must be found. They hinge on increased export demand to work out of over-supplies of many commodities, a broad-scale general recovery of our domestic economy, direct and positive action toward decreasing overproduction of grain, and individual attention to reducing heavy debt loads. At the same time, our system must continue to make sound loans to credit-worthy producers and cooperative agri-businesses to assure a continued healthy and productive agriculture in the long term future.

Currently, the three farm credit banks have over \$7 billion in agricultural loans outstanding in the four states we serve. The following table depicts our loan portfolio as of December 31, 1983.

TESTIMONY BEFORE THE KANSAS HOUSE COMMITTEE ON COMMERCIAL AND FINANCIAL INSTITUTIONS FEBRUARY 16, 1984 HB 2809

Mr. Chairman, Ladies and Gentlemen of the Committee, my name is Ray L. Brummett, and I am the General Counsel of The Federal Land Bank of Wichita. We appreciate the opportunity to offer testimony concerning HB 2809 and thank you for hearing our remarks. HB 2809 concerns only the Federal Land Bank Associations and Production Credit Associations located in the State of Kansas and although I do not represent the Production Credit Associations as its legal counsel or otherwise my remarks concerning the Bill would apply to those corporations.

The corporations named in HB 2809 oppose the Bill on the grounds they are incorporated only under federal law, have federal charters of incorporation and are supervised and regulated by an independent federal agency within the Executive branch of the government — the Farm Credit Administration in Washington D.C. As such, they derive their authority to exist and conduct business from federal law and regulations and not from the laws of any State.

These corporations respectfully submit, and offer for your consideration, that HB 2809 has no legislative purpose other than as an

attempt, or forerunner for later attempts, to regulate federally chartered and supervised corporations. In addition to the lack of a valid legislative purpose, we offer for your consideration our view that HB 2809 has serious constitutional implications. Before I briefly point out some of these constitutional implications, a short explanation of the nature of these institutions may be of assistance to you.

These corporations are part of a nationwide farmer-owned cooperative system established by Congress as early as 1916 for the purpose of providing credit to farmers and ranchers and their Cooperatives at the lowest possible cost. Congress established the Farm Credit Administration as an independent agency in the Executive branch of the United States government for the purpose of regulating and supervising the banks and associations of the Farm Credit System through-out the nation which make the actual extensions of credit. In the laws passed by Congress, the 12 Federal Land Banks, several hundred Federal Land Bank Associations, 12 Federal Intermediate Credit Banks and several hundred Production Credit Associations through-out the nation were made federal instrumentalities and given federal charters along with specific powers and authorities to carry out, on a nationally uniform basis, the Congressional objective and mandate of providing a dependable system of agricultural credit. A borrower obtains his or her loan through a federal land bank association or production credit association serving the area in which the borrower's farming or ranching operations are conducted. The borrower becomes a member of that association and

holds stock which entitles him or her to attend annual meetings, vote in board of director elections and generally have a voice in association affairs. At annual meetings, or anytime he or she requests it, a borrower/member is given statements of financial condition of the association as well as the names and addresses of board members and association employees. Additional details are contained in the attached brochures. The federal law governing the farm credit system known as the Farm Credit Act is found in Vol. 12, United States Code, Section 2001 - Section 2260.

The primary constitutional implication arises by reason of Article VI of the U.S. Constitution known as the "Supremacy Clause" which provides that the laws of the United States (such as the Farm Credit Act) shall be the supreme law of the land to which the states are bound. This means that any state law which interferes with or is contrary to a law enacted by Congress or imposes additional or auxilliary requirements not expressly allowed by federal law or regulations will be pre-empted by that federal law. We believe that HB 2809 clearly attempts to establish a means to govern and regulate certain corporations charted under federal law and under the supervision and complete scheme of regulation by an agency (Farm Credit Administration) of the U.S. government and would thus be contrary to the Supremacy Clause.

The second constitutional implication exists by reason of Article I

Section 10 of the U.S. Constitution which provides that no State shall pass a Bill of Attainder. HB 2809 says that for every day the corporations fail to comply each officer and director shall be fined \$100.00. A Bill of Attainder can best be described by looking at its elements.

- 1. It inflicts punishment or penalty of any degree of severity.
- 2. It is directed at named individuals or an easily ascertainable group of persons.
- 3. The penalty inflicted is without judicial proceedings or trial.
- 4. The purpose of the legislation is the punishment of specific persons having specific characteristics and not the legitimate regulation of conduct expected of all persons.

Very clearly the objective of HB 2809 is to punish an easily ascertainable group of persons (each officer and director) since without the penalty the Bill has no teeth. Upon failure to comply the corporations have no state charters or licenses to be revoked or certificates of authority to be withdrawn as would be the case with domestic corporations and foreign corporations authorized to do business in Kansas. In addition, the Bill contemplates no judicial trial for it says the persons "shall be fined".

The third constitutional implication is the 14th Amendment which provides that no State shall deny the equal protection of its laws. HB 2809 would not only regulate, restrict and burden a federally chartered corporation and its officers and directors by requiring registration and appointment of registered agents but would do so without requiring the same of other federal instrumentalities such as those national banks, national credit unions, FHA, SBA and federal savings and loan institutions doing business within the state. The classification established in HB 2809 is obviously arbitrary in its imposition of burdens and penalties and thus denies the application and protection of the laws to all members of the same class.

Incidentally, we have observed that HB 2809 does not expressly indicate but appears to attempt to treat federally chartered corporations as "foreign corporations" thus subjecting them to registration and registered agent requirements. The U.S. Supreme Court has stated that the laws of the United States are the laws of the several states and are not the laws of a foreign sovereignty and thereby are concurrent with the laws of the states. The corporations named in HB 2809, being incorporated under federal law and having federal charters, are not corporations "formed under the laws of another jurisdiction" and thus are not foreign corporations subject to registration and registered agent requirements of the state.
