She stated the bill would affect the procedure for non-renewal of contracts for administrative and supervisory employees in the community colleges. Recommends that House Bill No. 2647

"AN ACT relating to certain public educational entities; applying the statutory procedure for nonrenewal of contracts of advisory and supervisory employees thereof to community colleges; amending K.S.A. 1983 Supp. 72-5451 and 72-5455, and repealing the existing sections."

Be amended:
