The minutes of January 26 were approved as written.

The Chairman opened hearings on HB 2768 changing the notification date by school districts for discontinuation of teacher contracts from May 15 to May 1.

Bill Curtis, KASB, testified in support of HB 2768. (ATTACHMENT I)

Jerry Schreiner, United School Administrators of Kansas, submitted a written statement in support of HB 2768. (ATTACHMENT II)

Craig Grant, K-NEA, testified in opposition of HB 2768. He stated backing the date up to May 1 would only allow fifteen days for those teachers who wish to seek positions in other districts. The school districts can release teachers after the deadline of course, but more and more districts are refusing to do so, wanting to keep the teachers in their own districts. He suggested, to allow the same time frame in existence now and still work with this bill's concerns, the possibility of rolling the April 15 date back to April 1.

The hearings on HB 2768 closed.

The Chairman opened the meeting to discussion and possible action on bills previously heard.

Representative Murphy made a motion to amend HB 2618. (ATTACHMENT III) This amendment drops the fifteen minute a day proposed extension to the school day, but changes the required attendance year for grade twelve from 900 hours to 1050 hours. twelfth grade change would be the only change from current requirements. Representative Apt seconded the motion.

Committee discussion revealed the graduation requirements would not be changed and twelfth graders would be allowed the same lattitude as now in their scheduling. The only change from present operation would be computation of FTE for funding purposes.

The motion to amend HB 2618 carried.

Representative Leach moved to table HB 2618. Representative Moomaw seconded the motion. The motion failed.

Representative Apt moved that HB 2618 be passed out of committee with the recommendation of "Be Passed as Amended". Representative Reardon seconded the motion. The motion carried.

Representative Lowther moved HB 2738 be recommended favorable out of committee. HB 2738 concerns the due process procedure making arbitration binding by unanimous Representative Hassler seconded the motion.

Representative Brady made a substitute motion to pass HB 2729 out of committee with a favorable recommendation. HB 2729 affects the due process procedure for teachers

The next meeting of the committee will be February 1, 1984 at 3:30 p.m.



Testimony on H.B. 2768

Mr. Chairman and members of the Committee, we appreciate the opportunity to appear before you today in support of H.B. 2768. The bill was introduced by this Committee at the request of the Kansas Association of School Boards.

This past November the Delegate Assembly of the Kansas Association of School Boards, the body which determines the legislative policies of this association, approved a new policy which would support legislation that changes the date for teachers to notify boards of education of their intent not to return to the district from May 15 to May 1.

Many boards of education have expressed concern that the present teacher notification date works a hardship on boards in recruiting replacement staff members. This is primarily due to the fact that most teacher training institutions have completed the semester before May 15 and potential candidates are difficult to locate. If the date were moved back to May 1 most of these same institutions are still in session and candidates could be interviewed on campus. Thank you for your attention. We urge your support of H.B. 2768.

## To House 3ill No. 2618

On page 1, in line 24, by striking "(1) A" and inserting in lieu thereof "Subject to the other provisions of this section, a"; in line 26, by striking ", subject to"; by striking all of lines 27 to 32, inclusive; in line 33, before the period, by inserting the following: "(1) for pupils regularly enrolled if the school district maintains kindergarten, not kindergarten, less than 180 school days and each such school day shall consist of not less than 2 1/2 hours; and (2) for pupils regularly enrolled in any of grades one through 11 of the school district, than 180 school days and each such school day shall consist of not less than six hours; and (3) for pupils enrolled in grade 12 of the school district, not less than 175 school days and each such school day shall consist of not less than six hours"; in line 34, by striking "(2)" and inserting in lieu thereof "(b)"; in line 38, by striking "1,125" and inserting in lieu thereof "1,080"; in line 40, after the stricken material, by inserting "Il of the school district, and not less than 1,050 school hours for pupils regularly enrolled in grade"; in line 43, by striking "provision (2)" and inserting in lieu thereof "subsection";
