The minutes of March 12, 1984 were approved as written.

The Chairman opened the hearing on \underline{SB} 502.

Senator Don Montgomery presented \underline{SB} 502 which allows school bus use for adult education participants. Senator Montgomery stated that this bill was offered at the request of the Kansas Young Farmers and Young Wives. When they have their State Convention, they would be able to legally use the school districts busses. The Senator added that there would be no cost to the school district as the organization would, by contract, cover all of the expenses. He added that this legislation is not mandatory, but permissive.

Representative Don Rezac testified in support of \underline{SB} 502. He stated that he had introduced a bill in the House identical to this legislation.

Bill Curtis, Kansas Association of SChool Boards, testified in support of $\underline{SB~502}$. He stated that this expands permissive authority if approved by the board of education. When asked how the fees collected for this bus use would be deposited, Mr. Curtis answered that the collections would be used strictly to defray the expenses incurred.

This concluded the hearing for \underline{SB} 502. The Chairman opened the hearing for \underline{SB} 520.

Kathleen Homlish, State Board fo Education, presented \underline{SB} 520. This legislation would affect the licensing and certification of teachers on an interstate agreement basis. Ms. Homlish stated that the present system is greatly inconvient, and this legislation would provide legal authority to develop a system of interstate agreements with states that have comparable standards.

Dr. Richard Funk, Kansas Association of School Boards, testified in support of \underline{SB} 520. He stated that this would give the school boards added flexibility without sacrificing the basics, especially in that the added available teachers would have to be approved by the State Department of Education before they would be able to fill a position in Kansas.

Craig Grant, Kansas-National Education Association, had asked to be listed in support of <u>SB 520</u>. Mr. Grant, however, could not be in attendance to testify.

Jerry Schreiner, United School Administrators, had asked to be noted as a supporter of \underline{SB} 520, although he could not testify at this time.

This concluded the hearing for \underline{SB} 520. The Chairman opened the meeting to discussion and action on today's bills if the committee so desired.

Representative Miller moved that SB 502 be recommended favorably. Representative Kline seconded the motion. The motion carried.

Representative Reardon made nas motion to recommend SBed 520 Laworably. Representative Hassler
