Final Action on HB 2740: An act relating to hazardous wastes; amending K.S.A. 1983 Supp. 65-3430, 65-3431, 65-3432, 65-3433, 65-3435, 65-3436, 65-3437, 65-3439, 65-3441, 65-3442, 65-3443, 65-3444, 65-3445 and 65-3446 and repealing the existing sections; also repealing K.S.A. 1983 Supp. 65-3448.

A special meeting of House Energy and Natural Resources Committee was held for Final Action on $\underline{HB\ 2740}$.

Representative Rosenau expressed concern and stated he was opposed to the amendments in line 187.

Representative Farrar expressed concern that in line 232 the provisions to process established procedures for listing hazardous wastes were not clearly defined. Representatives from EPA and Department of Health and Environment stated the provisions were established to concur with federal regulations.

Representative Fox moved to recommend HB 2740 favorable as amended. Representative Grotewiel seconded the motion.

Committee discussion ensued with Representative Farrar recommending that HB 2740 be tabled to enable the full concept of the legislation to be understood. Representative Acheson agreed. Representative Farrar stated that the Department (KDHE) should provide a list of generators of hazardous waste that would be affected and the impact on the people involved.

Representative Fox insisted that the committee was aware of what was transpiring and closed on his motion. The original motion to recommend favorably as amended carried. Representatives Farrar, Guldner, Acheson, and Rosenau requested to be recorded as voting against the bill.

There being no further business before the committee, the meeting was adjourned at 11:30 a.m.
