RE: Summary of Holdover Bills of 1983 Legislative Session

Senate Bills in Senate Committee

- S.B. 163 -- S.B. 163 amends K.S.A. 25-4501 to continue the presidential primary.
- S.B. 179 -- S.B. 179 amends the campaign finance act concerning reports of expenditures. S.B. 179 amends K.S.A. 25-4143, 25-4148, 25-4150, and 25-4154, and repeals the existing sections.
- $\underline{\text{S.B. 185}}$ -- S.B. 185 amends the campaign finance act to make the act applicable for certain local offices.
- S.B. 299 -- S.B. 299 provides for the submission of petitions for nonbinding advisory referenda on matters of local and statewide public interest.
- S.B. 380 -- S.B. 380 amends K.S.A. 25-2104 and 25-2503 relating to question submitted elections of cities. The definition of "question submitted election" means any election at which a special question is to be voted on by the electors of a city including any nonbinding advisory referendum called under the authority of section 5, article 12 of the constitution of Kansas.
- $\frac{\text{S.B. 415}}{\text{make}}$ -- S.B. 415 amends the campaign finance act to make the act applicable for certain local offices.

House Bills in Senate Committee

H.B. 2400 -- H.B. 2400 amends K.S.A. 25-409 and 25-2909 concerning voting by challenged voters.

H.B. 2400 amends K.S.A. 25-409 to provide that paper ballots for challenged voters shall not include ballots for the election of precinct committeemen and precinct committeewomen. The amendments to K.S.A. 25-2909 are clean up amendments.

S.B. 116, passed in the 1983 Session, amends K.S.A. 25-409 and 25-2909, concerning the use of absentee ballots. The amendments to these sections would allow the challenged voter and disabled voter to vote an absentee ballot instead of a separately printed ballot.
