Conferees appearing before the committee:

Senate Bill 232 - Treatment act for drug abusers.

The chairman referred the committee to the balloon copy of the bill indicating the proposed changes. A committee member requested staff to check whether the amendments on page 5 of the balloon copy parallel with the alcohol treatment statutes. No action was taken on the bill at this time.

Senator Hess moved that the minutes of February 8, 1984, be approved; Senator Mulich seconded the motion, and the motion carried.

Senate Bill 692 - restrictions on granting diversion of criminal charges.

The chairman explained the amendments that were made to the bill previously. Senator Mulich moved that the bill be reported favorably as amended; Senator Burke seconded the motion. Senator Werts made a substitute motion to amend the bill by striking lines 46 through 49. Senator Mulich seconded the motion, and the motion carried. Senator Mulich made a motion to report the bill favorably as amended; Senator Burke seconded the motion, and the motion carried.

Senate Bill 642 - Criminal procedure, conditions for release on bond.

The chairman reviewed the bill. Senator Steineger moved to amend the bill to include the content of Senate Bill 25 that was acted on last year to provide for notice to county attorney and to the victim. Senator Burke seconded the motion, and the motion carried. Senator Burke moved to report the bill favorably as amended; Senator Hess seconded the motion, and the motion carried.

<u>Senate Bill 368</u> - Crime of interference or aggravated interference with parental custody.

The chairman reviewed the bill. <u>Senator Mulich made a motion to amend the bill to raise the age from 14 to 16 in line 25</u>. Committee discussion followed. The consensus of the committee was to wait to take further action on the bill.

Senate Bill 485 - Surrogate mothers, restrictions thereon.

Considerable committee discussion was held. Senator Winter stated he felt, as he listened to the hearings during the interim, there were more problems than the state was ready to deal with, and he would like to see the Supreme Court act on a case to see how the court deals with it. Senator Gaar moved to report the bill adversely. Senator Hess seconded the motion, and the motion carried.

Senate Bill 665 - Prohibiting glue and paint sniffing.

Senator Gaines moved to report the bill adversely; Senator Mulich seconded the motion, and the motion carried.
