HB 2098 - Restricting advertising by other than licensed child placing agency

Jack Snavely, Alliance of Christian Children's Home, Inc., expressed concern about the wording of this bill with regard to his organization. It was decided to hold the bill in committee so that it would be worked out with Emalene Correll, Legislative Research Department and Norman Furse, Revisor of Statutes office.

HB 3024 - Prohibiting home health aides from prefilling insulin syringes

Senator Meyers distributed testimony from Esther Sobering, Riley County Health Homemaker Services, Inc., and Dr. Lois Scibetta, Kansas State Board of Nursing, both supporting HB 3024. (Attachments #1 and #2).

Senator Johnston moved that HB 3024 be reported favorably.

Norman Furse suggested a technical amendment be made in Line 16 by striking the word "persons" and inserting "employees of home health agencies".

Senator Johnston withdrew his original motion and offered a substitute motion that the amendment suggested by Mr. Furse be adopted. Senator Hayden seconded the motion and it carried.

Senator Johnston moved that HB 3024 be reported favorably, as amended. Senator Bogina seconded the motion and it carried.

HB 2784 - Repealing statutes which authorize certain counties to license physicians and charge fees therefor

Senator Johnston moved that HB 2784 be reported favorably. Senator Morris seconded the motion and it carried.

HB 2893 - Kansas Commission for the Deaf and Hearing Impaired, continuation of its existence, duties and fees

Senator Chaney moved that these amendments be adopted. Senator Johnston seconded the motion and it carried.

HB 2851 - Hearing aid examiners, licensure requirements, audiometer recalibration

Senator Johnston moved that the effective date be changed to January 1, 1985. Senator Hayden seconded the motion and it carried.

The Board is in support of HB 3024 which would prohibit health aides from pre-filling insulin syringes, because this practice would be dangerous for the public in our judgment.
