Senator Meyers announced that a resolution had just been referred to this committee.

HCR 5086 - urging and encouraging the Kansas Commission for Deaf and Hearing Impaired and State Board of Education to engage in a cooperative effort to coordinate state services

Emalene Correll, Legislative Research Department, reviewed the resolution.

Senator Francisco moved that HCR 5086 be reported favorably. Senator Chaney seconded the motion and it carried.

<u>Sub. HB 2997</u> - concerning family and children trust fund; establishing a state filing fee for certificates of birth

Rep. Sandy Duncan spoke in support of the bill, which this committee had reported adversely yesterday. He recommended that the original language, as it was amended by the House PH&W Committee, be restored and that the bill be referred to an interim committee for study.

Senator Johnston moved that the Senate PH&W Committee reconsider its action on Sub. HB 2997. Senator Morris seconded the motion and it carried.

Senator Morris moved that Sub. HB 2997 be amended by restoring the original language as it came from the House PH&W Committee, and the language on Rules and Regulations. Senator Johnston seconded the motion and it carried.

Senator Johnston moved that Sub. HB 2997 be reported favorably, as amended. Senator Ehrlich seconded the motion and it carried.

HB 2736 - concerning hospital districts in certain townships; relating to tax levies for the operation and maintenance of the hospital

Emalene Correll stated that this problem is addressed in HB 2003 and if you have both bills you will have an internal conflict. If HB 2003 passes the Senate, the problem is taken care of.

Senator Chaney moved that the minutes of March 29, 1984, be approved. Senator Francisco seconded the motion and it carried.

The meeting was adjourned.
