HB 2680 - FY 1985

Section 2 - Abstracters' Board of Examiners

Senator Hein presented the subcommittee report on this section. Committee members were given opportunity to question him.

Section 3 - Board of Accountancy

Following Senator Hein's review of the subcommittee report on this section, committee members were given opportunity to question him.

Section 4 - State Bank Commissioner

In connection with his presentation of the subcommittee report, Senator Hein explained that the subcommittee had made a system-wide recommendation on the four financial agencies in HB 2680 to upgrade their personnel. The Personnel Division seems to think this is necessary, and that is the reason for the recommendation for all four agencies. However, since this is an Executive Department recommendation originally, it is felt that a Governor's Budget Amendment is necessary.

Section 5 - Board of Barber Examiners

During his review of the subcommittee report, Senator Hein called the committee's attention to the recommendation to combine the Board of Barber Examiners and the Board of Cosmetology, and to introduce legislation to that effect. There were questions concerning this recommendation. Senator Hein said that it was felt there is duplication of inspection, because one person inspects a shop for cosmetologists and another for barbers. He added that this problem has been dealt with in other agencies. He further stated that there are 18,000 cosmetologists and 1,500 barbers in Kansas, the barbers are being reduced at the rate of 10% each year.

Motion was made by Senator Steineger and seconded by Senator Gaines to amend the subcommittee report on Section 5 to delete the introduction of the above-mentioned bill. The motion carried by voice vote.

Section 6 - Behavioral Sciences Regulatory Board

Senator Hein presented the subcommittee report on this section. Motion was made by Senator Werts and seconded by Senator Hein to amend the subcommittee report to include a notation that Recommendation No. 3 be subject to a Governor's budget amendment. The motion carried by voice vote.

Following a brief discussion, the motion carried by voice vote. There was discussion about the amount of coverage for each person, and it was decided that could be done by rule and regulation.

AN ACT concerning the licensing of social workers; relating to fees; amending K.S.A. 1983 Supp. 75-5359 and repealing the existing section.

Be it enacted by the Legislature of the State of Kansas:

Section 1. K.S.A. 1983 Supp. 75-5359 is hereby amended to read as follows: 75-5359. The following license and examination fees shall be established by the board by rules and regulations in accordance with the following limitations:

- (a) Renewal fee for a license as a social work associate shall be not $\frac{1}{2}$ ess-than- $\frac{1}{2}$ θ -nor more than \$50.
- (b) Application or renewal fee for a license as a baccalaureate social worker shall be not $\frac{1}{2}$ than \$50.
- (c) Application or renewal fee for a license as master social worker shall be not less-than-\$lθ-nor more than \$50.
- (d) Application or renewal fee for a license in a social work specialty shall be not $\frac{1}{2}$ work specialty shall be not $\frac{1}{2}$ work specialty shall be not $\frac{1}{2}$
 - (e)--Examination-fee-not-more-than-\$50-
 - (f)--Duplicate-license-fee-not-more-than-\$20.
- (e) Examination fee for a license as a baccalaureate social worker, for a license as a master social worker or for a license in a social work specialty shall be not more than \$75. If an applicant fails an examination, such applicant may be admitted to subsequent examinations upon payment of an additional fee prescribed by the board of not more than \$75.
- (f) Replacement fee for reissuance of a license certificate due to loss or name change shall be not more than \$20.
 - Sec. 2. K.S.A. 1983 Supp. 75-5359 is hereby repealed.
- Sec. 3. This act shall take effect and be in force from and after its publication in the statute book.
