Motion was made by Senator Talkington and seconded by Senator Harder to reconsider the Senate Committee's action on this section and to restore \$100,000 from the State General Fund which was deleted by item 1 of the Senate Subcommittee report. The motion carried by voice vote.

It was the concensus of the committee to report HB 2692 as further amended favorably for passage.
