The Committee took under consideration S.B. 300 - Regulation of public warehousemen storing grain, examinations, contracts, records, procedures, letter of credit and penalties for crime.

Representative Roenbaugh moved to require the department to examine each licensed warehouse two times each year. The motion was seconded. A vote was taken and the motion failed.

Representative Hamm moved to pass S.B. 300 out favorably. The motion was seconded by Representative Sallee, and the motion carried.

The Committee took under consideration S.B. 330 - Enacting the Kansas Chemigation safety law for discussion and action.

Harland Priddle explained they had eliminated the position of hydrologist which would reduce the fiscal note by \$34,000. He recommended eliminating the words within sight and sound on line 47, and reducing the chemigation user's permit fee from \$60.00 a year to \$50.00 a year. If the Committee wants to reinstate the examination he would recommend an open book mail-out examination.

Representative Neufeld moved to strike the words within sight and sound in line 47. Representative Roenbaugh seconded and the motion passed.

Representative Clifford Campbell made a motion to reduce the chemigation user's permit fee from \$60.00 a year to \$50.00 a year. Representative Roenbaugh seconded the motion. The motion passed.

Representative Teagarden moved to require an open book examination and the examination fee would be \$10.00 once every three years.

Representative Neufeld seconded the motion. The motion passed.

Representative Sallee moved to pass out favorably S.B. 330, as amended. Representative Bryant seconded the motion and the motion passed.

The Committee took under consideration S.B. 331 - Requiring the registration of pesticide dealers.

A motion was made by Representative Buehler and seconded by Representative Teagarden to pass out favorably S.B. 331.

Representative Freeman moved to conceptually amend S.B. 331 by exempting the sale of general use pesticides purchased for household use only. Representative Buehler seconded the motion.

The Chairman recessed the Committee meeting and announced the Committee would meet on adjournment of the House in Room 313-S.

The Committee discussed Representative Freeman's conceptual motion to amend S.B. 331. A vote was taken and the motion passed.

Upon questioning by the Committee Harland Priddle stated the fiscal note on S.B. 331 was four additional employees and they anticipate approximately 9,000 dealers. He suggested reducing the registration fee to \$15.00 for the first year, or setting a fee for three years.

Representative Eckert moved to change the registration fee for pesticide dealers from \$25.00 a year to \$15.00 a year and to pass the bill out favorably, as amended. Representative Apt seconded the motion.

Representative Buehler made a substitute motion to set the registration fee for pesticide dealers at \$25.00 every three years. The motion was seconded by Representative Freeman. A vote was taken and the substitute motion failed.

A vote was taken on the motion by Representative Eckert and the $\underline{\text{motion passed}}$.

The meeting was adjourned at 12:15 p.m.
