Speaker of the House, Mike Hayden Edward A. Martinko, State Biologist, Director, Kansas Biological Survey

The first order of business was <u>House Bill 2588</u>--Protection of ground-water requiring plugging of wells before abandonment. <u>Representative Mollenkamp made a motion to propose House Bill 2588 for interim study. Representative Holmes seconded the motion. The motion passed.</u>

The next item taken up was House Bill 2610--Establishing the natural and scientific areas advisory board and prescribing powers and duties. Speaker Mike Hayden testified in favor of this bill. He explained that this bill would reorganize the mechanism dealing with the Natural and Scientific Areas Act, which he had sponsored in 1974. that the purpose of the bill was to recognize and protect certain irreplaceable environmental, geological and archeological areas which otherwise might be lost. The Speaker noted that the mechanism of the act as well as the mechanism for an advisory board was placed under the jurisdiction of the Park and Resources Authority in 1974, but the legislation had not been implemented. House Bill 2610 would change that jurisdiction to the Kansas Biological Survey. Speaker Hayden noted that the Kansas Biological Survey is located at the University of Kansas and their purpose is very similar to that in the Natural and Scientific Areas Act language. He said that the Biological Survey had agreed to be the designated agency and would move to establish the advisory board and to enter into the register certain natural and scientific areas which should be preserved for future generations in Kansas. Committee discussion followed.

Edward Martinko, Director of the Kansas Biological Survey, was another proponent of $\underline{\text{House Bill 2610}}$. It was his belief that since the Biological Survey was mandated to study the native plants and animals of Kansas, especially those of economic and educational importance, it would be a logical step to couple those activities with the preservation of the natural heritage of Kansas. (Attachment 1)Discussion followed Mr. Martinko's presentation. Representative Patrick asked if this would provide for powers of condemnation. Staff believed not, but suggested that language could be added to clarify that. tative Heinemann made a conceptual motion relative to clarifying that this act does not give power of condemnation. The motion was seconded by Representative Patrick. Motion carried. Representatives Heinemann and Patrick accepted a suggestion of staff that for further clarification, rather than listing the positions of Director of the State Biological Survey and Director of the Geological Survey, it would be more appropriate to say the "State Biologist" and the "State Geologist." Representative Heinemann made a motion to recommend House Bill 2610 as amended favorably. Representative Acheson seconded. The motion passed.

Turning to <u>House Bill 258l</u>—Concerning conservation fee fund of state corporation commission; relating to groundwater pollution research, Mr. Donald Schnacke spoke on behalf of the Kansas Independent Oil & Gas Association. He commented that the money for the conservation fee fund derives from his clientele, the producers of oil and gas throughout Kansas. He noted that the problems he had with the original <u>House Bill 258l (Attachment 2)</u> had been stricken by the amendments in the balloon copy. (<u>Attachment 3</u>) With these amendments, he said it would be tied to the Kansas Corporation Commission and would have some review by the keeper of those funds. Mr. Schnacke still was not in favor of the bill, but felt that the amendments provided considerable improvement over the original bill.

Representative Heinemann explained that <u>House Bill 2581</u> was the statute creating a conservation fee fund and it was clearly under the control of the Kansas Corporation Commission. He said that through the Water Office and the Dakota study, it was clear that the relationship was so close that the posture was that the conservation fee funds could be used for the research that was going on, and the original bill did that. Representative Heinemann noted that the Kansas Corporation Commission and the Water Office had agreed to cooperate and use the fee fund, and the amendments would allow the Kansas Corporation Commission to control it. He said that the conference committee had pulled the general fund money out of the budget pending this committee's action and the omnibus bill would be adjusted appropriately. Representative Heinemann moved the adoption of the amendments. Representative Holmes seconded the motion. The motion carried.

During discussion, Representative Heinemann explained that Mr. Bryson, Director of the Oil and Field and Environmental Geology Bureau of the Kansas Department of Health and Environment, had indicated that he felt it would be appropriate that the program be coordinated and he would get information that would be useful to him. Representative Heinemann felt that it would be appropriate to use the conservation fee fund to do this. He said that \$99,000 was to be in the study but if part of that should be a general fund obligation, that adjustment would be in the omnibus bill. He noted that there was over \$2 million in the conservation fee fund at the present time. Lengthy discussion continued.

Representative Spaniol noted that the committee had recommended House Bill 2588 for interim study and felt that perhaps this bill should be studied at the same time. Representative Spaniol made a motion to table House Bill 2581 and recommend it for interim study, along with House Bill 2588. Representative Rosenau seconded the motion. The voice vote was not decisive. On division, there were 8 votes in favor and 9 votes opposed. The motion was defeated. More discussion followed, but time ran out because the House was to reconvene at 2:30 p.m.

The minutes of March 25, 26, 27, and April 1 were adopted.

The meeting was adjourned at 2:30 p.m.

Chairman Fox, Members of the Committee, I am here to speak in support of House Bill No. 2610. As originally established in 1974, a mechanism for a system of natural and scientific areas was created under the Park and Resources Authority. The communication liaison segment, an advisory board, was also established. In 1984 the board was abolished but the system for dedicating natural and scientific areas remained intact under the Park Aurhority.

As you are aware over the last several years many important natural resource issues have come to the forefront. These issues have been dealt with by state agencies and legislators who are dedicated to promoting public well being and preserving the integrity of Kansas. The establishment of a board composed of the groups outlined in the bill will re-establish a functional board with broadly based representation cognizant of the needs of the people and the state. This board will facilitate in coordination of future issues related to natural and scientific areas.

The re-establishment of this advisory board in concert with the natural and scientific areas preservtion act and placement of both the board and the act under jurisdiction of the Kansas Biological Survey will provide a comprehensive mechanism for a land owner to dedicate and commit land for public and scientific use. Since the Biological Survey is mandated to study the native plants and animals of Kansas, especially those of economic and educational importance, coupling the activities of this board with those of the Biological Survey will be a logical step for the responsible preservation of the natural heritage of Kansas.

The backbone of this legislation is the identification of natural and scientific areas, dedication of an area by gift or donation and management of the dedicated areas. You can see by looking through the membership of the board, the processes for dedication and the role of the Biological Survey that the intent of the act is to clarify the mechanisms for the effective utilization and preservation of these areas.

In closing I would like to quote from the Natural and Scientific Area Preserves act passed in 1974. "The purpose of this act is to secure for the people of Kansas the benefits of an enduring resource of natural and scientific areas by establishing a system of natural and scientific preserves, to provide for the protection, control and management of these areas, and to establish and maintain a registry of natural and scientific areas." I feel that passage of House Bill No. 2610 will fulfill this purpose.
