HB 2160, concerning county extension councils; relating to the filing of the budget and other documents.

HB 2183, authorizing hospital district No. 1, Linn and Bourbon counties, to enter into a contract to borrow money for the purpose of building an addition to an existing home for the aged; placing certain conditions upon such contract.
