The meeting was called to order by Representative Williams, Vice-Chairman, to discuss House Bill 2182 and House Bill 2219.

## HOUSE BILL 2182 - HEARING

Marshall Crowther, appearing on behalf of the Governor's Office on House Bill 2182, indicated it establishes a minimum-maximum lump-sum optional life insurance death benefit of \$100,000 instead of the current \$50,000 for active state employees in KPERS retirement system. There is no fiscal implication since employees pay the full cost from payroll deductions. Mr. Crowther added that no additional staff will be needed to implement raising the death benefit.

## HOUSE BILL 2219 - HEARING

Representative Acheson said he was contacted by one of his constituents regarding the problem of members' spouses of Kansas Police and Firemen's retirement system not receiving benefits upon remarrying after the member is deceased.

Representative Branson recommended changing language on Page 2, Lines 56-63, to allow deceased KP&F members' spouses to receive benefits whether or not spouses remarry. She added that the fiscal note for

the state would be \$30,000 and \$240,000 for local subdivisions.

Speaking on behalf of the Fraternal Order of Police and as a Lawrence police officer, David Reavis indicated support of House Bill 2219.

In answer to a question from Representative Sand, Marshall Crowther said Representative Acheson's constituent could eventually receive two benefits if the bill is amended, since she is the widow of a fireman and currently married to a policeman.

Representing the Kansas State Council of Firefighters, Jerry Marlatt, said the Council supports House Bill 2219.

The Vice-Chairman announced that Representative Branson will construct an amendment to allow spouses to receive benefits whether or not they remarry, for a future meeting.
