Chairman Bunten called the meeting to order at 1:40 p.m.

HB 2069 -- an act concerning state funds management; relating to issuance of state revenue anticipation notes and certificates of indebtedness under certain circumstances; prescribing powers, duties and functions for the state finance council and the pooled money investment board and imposing guidelines therefor; amending K.S.A. 75-3711c and 75-3725a and repealing the existing sections.

Representative Shriver moved that HB 2069 be recommended favorable for passage. Seconded by Representative Chronister. Chairman asked if there were any questions regarding the bill, to which there was considerable discussion, both pro and con concerning the bill.

Representatives Ott, King and Rolfs stated their opposition to the bill. The vote was tied nine to nine. Chairman Bunten broke the tie by voting aye. The motion carried.

Art Griggs appeared before the committee and requested introduction of nine (9) separate bills as follows: (Attachment II)

- 1. Insurance for DISC equipment.
- 2. Payment of tuition expenses.
- 3. Surplus property.
- 4. Pay Plan.
- 5. Kansas Civil Service Board.
- 6. Performance Evaluations.
- 7. Civil Service and other Personnel matters.
- 8. Certification of participation financing.
- 9. Educational building fund.

Representative Rolfs moved that these bills be introduced and referred back to this committee. Seconded by Representative Heinemann. Motion carried.

Alden Shields gave a presentation on the overall budget as proposed for FY 85-86. A 4-page handout was provided (Attachment III) which gives a summary of state general fund expenditures and a list of the major budget recommendations. Of the total projected budget of \$151 million, he pointed out that \$96 million of that amount is "being sent back home".

An additional request this year is a request of \$150,000 for an Honor's Academy which would provide additional educational opportunities to those deserving students and is designed to encourage them to excel in certain fields, primarily mathematics and science. It was proposed by Department of Education. Representative Lowther, who served on the committee, further explained it would be on a nomination basis throughout the state and would

encourage those students to pursue their goals. It's also a way to recognize the high achievers and stimulate them to continue.

A total of \$640,000 is projected for graduate teaching assistant improvements. Mr. Shields explained that the purpose of this recommendation is not to increase the number, but an effort to pay them better. The waiver would be increased from 60% to 75%.

There was discussion relating to Item 6 under Education pertaining to preschool special education for 4-year old handicapped children. There is a budget request for \$600,000. Asked if this amount is in addition to what we are already spending, Shields replied that this is in addition to that asked for in No. 2, "Maintain special education effort at 75% of excess cost". He said \$300,000 would be distributed through the formula and \$300,000 would be in the form of categorical grants. Asked if this would cover all anticipated needs for 4-year old handicapped children, he said he would have to check it out and report back.

Representative Rolfs asked if there is any provision made for implementation of the internship program that the legislature recommended last year. Shields replied that he could not say for sure, but considering that the interim committee was working on this, he believes consideration is being given to those recommendations.

Mr. Shields briefly reviewed page 4 of the handout which is a table showing actual and recommended unappropriated cash balance and related several reasons why we need to build the balance. (1) has to do with the cigarette tax; (2) has to do with efforts of congress to come to grips with the deficit. He said we need to create an environment in terms of the ending balance to make a responsible reaction to the federal government decisions. He said the state might want to pick up on some of those. Number 3 has to do with the nursing home suit which is still with us. The industry refuses to settle for nine million plus.

Being no further business, Chairman adjourned the meeting at 2:50 p.m.

Request for Introduction of Legislation

The Department of Administration is requesting the Committee to introduce the bills summarized below.

- 1. Insurance for DISC Equipment -- This bill would authorize the Department of Administration to purchase property and casualty insurance for data processing and telecommunications equipment.
- 2. Payment of Tuition Expenses -- In cases where a state agency agrees to pay the tuition expenses of an employee, current law requires that the payment be made directly to the educational institution. Because some state agencies prefer to reimburse an employee after successful completion of the course, the bill allows tuition payments to be made either directly to the educational institution or reimburse the employee.
- 3. Surplus Property -- This bill establishes a state surplus property program and prescribes general powers and duties relating thereto.
- 4. Pay Plan -- This bill provides for the pay plan revision, secretarial reclassification, performance awards and other matters pertaining to compensation of state officers and employees.
- 5. Kansas Civil Service Board -- This bill would permit the reappointment of Board members in cases where Congressional district redistricting has resulted in two Board members being in the same new district. The bill also increases compensation from \$35 to \$70 per day and provides compensation for certain travel days.

- 6. Performance Evaluations -- This bill amends civil service statutes relating to performance evaluations and paves the way for timely changes in personnel regulations relating to performance evaluations.
- 7. Civil Service and Other Personnel Matters -- This bill modifies several Civil Service Act statutes and related personnel statutes. The majority of the changes were suggested by the Division of Personnel Services and constitute minor revisions.
- 8. Certification of Participation Financing -- This bill would expressly provide for the Secretary of Administration to be the centralized authority to arrange for certificate of participation financing for all state agencies.
- 9. Educational Building Fund -- This bill is designed to address the recent cash flow problems of the Educational Building Fund. The bill permits the director of accounts and reports to treat anticipated revenues to the Educational Building Fund and Institutional Building Fund on an accrual basis.
