After the Chairman called the meeting to order, Senator Montgomery moved and Senator Arasmith seconded a motion to approve Committee minutes of March 18 and 19. The motion carried.

The Chairman called the Committee's attention to HB 2058 which, he said, had been passed out of Committee with the recommendation that it be placed on the Consent Calendar. He explained that because the Committee vote had not been unanimous, HB 2058 could not be placed on the Consent Calendar, and the Committee had expunged its previous action on the bill. When the Chairman opened the meeting for further discussion and/or action on HB 2058, Senator Salisbury moved and Senator Karr seconded the motion to recommend HB 2058 favorably for passage. The motion carried.

The Chairman then reviewed the deadline schedule for finance bills and noted the urgency for the Committee to take action on HB 2144 relating to school finance. The Chairman briefly reviewed HB 2144 and reminded the Committee that the bill did not contain any funding. He further stated that the actual amount for funding education in the 1985-86 school year will not be known until a later time and that additional funding could be provided when the omnibus bill is considered by the Ways and Means Committee. He explained that the Education Committee does not control the amount of funding to be used for school finance.

The Chair referred the Committee's attention to the explanation given by Mr. Dale Dennis of the State Department of Education at a previous meeting relating to linear transition. He then called upon Mr. Dennis who distributed and explained updated printouts (Attachment 1) for HB 2144 and then distributed printouts (Attachment 2) which compared the districts financially by the addition of a linear transition in the fourth enrollment category. Mr. Dennis pointed out that the shifts in linear transition represent a redistribution of moneys and not new moneys.

Following Mr. Dennis' explanation, Senator Kerr moved to amend HB 2144 by allowing interest earned on moneys in the capital outlay fund to be transferred to the general fund to be used in the base for determining the school district's budget controls for the subsequent year. The amendment was seconded by Senator Karr, and the amendment was adopted.

Senator Karr then made a conceptual motion to amend HB 2144 by restoring the language that had been stricken by the House relating to funding for pre-school handicapped children. The motion was seconded by Senator Parrish. When the Chair ruled that the motion to amend HB 2144 did not carry, a division was requested. A recount confirmed that the Chair's original ruling was correct.

Senator Allen moved, and Senator Arasmith seconded the motion to recommend HB 2144, as amended, favorably for passage. The motion carried.

When the Chair called for action on HB 2101 relating to changing the date for counting enrollment for the purposes of receiving state aid, Senator Anderson moved that HB 2101 be recommended favorably for passage. The motion was

seconded by Senator Parrish, but the Chair ruled that the motion did not carry.

When the Chair called for action on HB 2353 relating to Johnson County, Senator Arasmith moved and Senator Karr seconded the motion to recommend HB 2353 favorably for passage. Senator Parrish then made a substitute motion that would require approval of the State Board before the district could transfer funds from the general fund into the capital outlay fund. This was seconded by Senator Salisbury. Following Committee discussion, Senator Parrish withdrew her motion to amend HB 2144, and Senator Salisbury withdrew her second. The Chairman then called for a vote on the primary motion, and the motion carried.

The Chairman adjourned the meeting.
