Senator Hoferer chaired the committee today in the absence of Senator Frey.

<u>Senate Bill 204</u> - Diversion agreements, filing KBI and division of vehicles.

Senator James Francisco, prime sponsor of the bill, explained the request for this bill came from the Association of Legislative Action of Rural Mayors. He said under diversion agreements the district or county attorneys do not send diversion agreements to a clearing house here in Topeka until diversion agreement is completed. They want the agreements as soon as they are placed on diversion. The district attorneys and the law enforcement are waiting until diversions are completed before they send it in. The law doesn't state when the report will be required. They want the names and addresses of a person who is on diversion. Committee discussion followed.

Senate Bill 191 - Prosecutor's duties with respect to complaints alleging cruelty to animals.

Senator Phil Martin, sponsor of the bill, presented background to the bill. In 1983 and 1984 they had an unusual circumstance in Pittsburg. An individual was killing a large number of cats over a period of six to nine months. The humane society had a problem in dealing with the situation because of the lack of cooperation from the county attorney's office. He stated the American Humane Society suggested in line 45, after "guardian" inserting "the expenses paid to the agency providing the care"; in line 52, after "shall" inserting "immediately"; and in line 53, following "and" and inserting "without delay". He also suggested increasing the penalties.

Mary Kay Caldwell, President of the Southeast Kansas Humane Society near Pittsburg, related the bizarre animal abuse case to which Senator Martin had referred. A copy of her testimony is attached (See Attachment I).

Audrey B. McCaig, Helping Hands Humane Society, appeared in support of the bill. She testified this amendment is necessary so that county and district attorneys will prosecute. A copy of her testimony with suggested amendments is attached (See Attachment II).

Dick Ketterman, Lawrence Humane Society, testified they have problems in getting district attorneys to prosecute these cases; however, their new district attorney has agreed to handle these cases. Mr. Ketterman stated he had a case in a bordering county, and the district attorney said he had more important things to do. He believes the wording, "search warrant" is needed in the bill.

MY NAME IS MARY KAY CALDWELL. I AM PRESIDENT OF THE SOUTHEAST KANSAS HUMANE SOCIETY LOCATED NEAR PITTSBURG, KANSAS.

DURING 1983 AND 1984 THE SOCIETY WAS CHALLENGED WITH THE MOST BIZARRE ANIMAL ABUSE CASE IN THE SOCIETY'S 12 YEAR HISTORY.

DURING AUGUST 1983 WE RECEIVED A CALL FROM AN ELDERLY LADY WHO REPORTED THAT HER DAUGHTER WHO IS DEAF AND CANNOT SPEAK HAD WITNESSED A YOUNG MAN WHO LIVED NEXT DOOR MISTREATING CATS. WE CHECKED THE SITUATION AND FOUND HER INFORMATION TO BE TRUE. FROM AUGUST 1983 UNTIL MARCH 1984 WE KEPT A CLOSE WATCH ON THIS INDIVIDUAL. WE SOUGHT HELP FROM OUR LOCAL POLICE DEPARTMENT BY ASKING THEM TO KEEP A WATCH ON THIS PERSON. THEY TOLD US THAT THEY DID NOT HAVE THE MANPOWER OR TIME. WAS THEN LEFT TO THE VOLUNTEERS FROM OUR SOCIETY. WE ANSWERED CALLS IN HIS NEIGHBORHOOD WHERE WE FOUND BEAUTIFUL SPAYED AND NEUTERED CATS THAT HAD BEEN STRANGLED AND MUTILATED TO A CAT WITH AN EYE POKED OUT. IN MID MARCH IN DESPARATION WE VISITED WITH THE PITTSBURG CITY ATTORNEY. HE HAD US LOG AND DATE ALL THE INFORMATION THAT WE HAD COLLECTED. THREE OF US WROTE FOR THREE HOURS. HE THEN TOLD US THAT WE WOULD HAVE TO CATCH HIM IN THE ACT BEFORE THEY COULD DO ANYTHING ABOUT IT. THE POL-ICE TOLD US THAT WHEN WE CAUGHT HIM THEY WOULD ARREST HIM. WE WERE OFF. WE MADE A PLAN AND CAUGHT HIM IN ACTION BEFORE THE WEEK WAS OUT. IT WAS MARCH 21ST. ON MARCH 25 MY NEW BUICK WAS TURPENTINED

ON MARCH 23rd OUR ENDORSEMENT OF WITNESS WAS FILED AND THE DEFENDANT WAS TO APPEAR MARCH 27th. THE DEFENDANT ENTERED A PLEA OF "NOT GUILTY". THE TRIAL WAS SET FOR APRIL 12th AND THE DEFENDANT WAS RELEASED ON \$100 BOND. HE WAS NOT TO HAVE ANY CATS IN HIS POSSESSION NOR WAS HE TO HAVE ANY CONTACT WITH ANY WITNESSES IN THE CASE.

DURING THE NIGHT.

AM 3/8/85 Ottele:I ON APRIL 9TH CASE CONTINUED BY DEFENDANT'S ATTORNEY AND TRIL RESET FOR APRIL 26TH.

APRIL 10TH DEFENDANT WAS CAUGHT WITH ANOTHER CAT AND ACTING IN CONTEMPT OF COURT. APRIL 11TH DEFENDANT CAUGHT AGAIN WITH A CAT. ON APRIL 12TH I TALKED TO THE ASSISTANT COUNTY ATTORNEY ABOUT REVOKING THE DEFENDANT'S BOND. HE WAS NOT IN AGREEMENT BUT AFTER A BIT OF INTENSE DISCUSSION HE AGREED TO MAKE A MOTION TO REVOKE BOND. HEARING WAS SET FOR APRIL 20TH. AT THAT TIME BOND WAS RAISED TO \$1000. ON APRIL 19TH THE TRIAL WAS CONTINUED BY THE COUNTY ATTORNEY AS HE AND HIS ASSISTANT TOOK A TRIP TO THE BAHAMAS. WE WERE QUITE ANXIOUS FOR THE TRIAL TO PROCEED AS HAD BEEN PLANNED AS WE HAD A FIELD INVESTIGATOR FROM THE AMERICAN HUMANE ASSOCIATION IN DENVER IN TOWN.

ON APRIL 26TH THE TRIAL WAS CONTINUED BY THE DEFENANT'S ATTORNEY TO MAY 22. ON MAY 10TH THE TRIAL CONTINUED AGAIN BY THE COUNTY ATTORNEY TO MAY 29TH.

MAY I INJECT AT THIS POINT THAT THE COMMUNITY WAS BECOMING VERYUPSET ABOUT THESE CONTINUANCES. THE COUNTY ATTORNEY'S OFFICE PHONE WAS FLOODED WITH CALLS. THE COUNTY ATTORNEY MADE A COMMENT TO ANOTHER BOARD MEMBER AND ME THAT HE HAD RECEIVED MORE CALLS OVER THESE DUMB CATS. THAN ANY MURDER TRIAL. EVERYONE FELT THAT THIS INDIVUAL WAS COMPELLED TO DO THIS AND THAT HIS ACTIVITIES WERE CONTINUING. MANY CATS WERE STILL COMING UP MISSING. PEOPLE WERE FRIGHTENED TO THINK THIS SICK INDIVIDUAL WAS RUNNING LOOSE. ON APRIL 29TH THE DEFENDANT'S WIFE GAVE BIRTH TO A BABY WHICH COMPLICATED THE MATTER. NOW EVERY.

ON MAY 29TH AT THE TRIAL THE DEFENDANT'S ATTORNEY CHANGED HIS PLEA FROM "NOT GUILTY" TO "NOLO CONTENDERE". HE DID NOT APPEAR. THE COURTROOM WAS FULL.

ON JUNE 19TH AN ORDER WAS FILED BY THE STATE ORDERING THE DEFENDANT

TO BE EXAMINED BY THE MENTAL HEALTH CENTER. ON JUNE 26TH THE SENTENCING

WAS SET FOR JULY 31st.

ON JULY 15TH AT 2:00 A.M. THE DEFENDANT WAS FOUND WITH ANOTHER CAT IN HIS POSSESSION.

ON JULY 19TH THIS BOND WAS REVOKED AND HE WAS SENT TO JAIL UNTIL JULY 24TH. SINCE HE WAS GOING TO JAIL THE SENTING DATE WAS MOVED UP TO THE 24TH FROM THE 29TH. WE EVEN SUMMARIZED AND INDEXED THE CASE FOR THE C.A. ON JULY 24TH HE WAS SENTENCED TO 6 MONTHS AS AN INPATIENT OR . JAIL. ON THE NIGHT OF JULY 25TH HE ATTACKED AN EMPLOYEE IN THE MENTAL WARD OF OUR LOCAL HOSPITAL. HE WAS THEN TRANSFERRED TO THE OSAWATOMIE SAME HOSPITAL. HE WAS RELEASED NOVEMBER 1ST. HE IS ON PAROLE FOR ONE YEAR. WE FEEL THAT THIS CASE SHOULD HAVE BEEN BROUGHT TO TRIAL MUCH MORE QUICKLY AS THE DELAY CAUSED MANY MORE ANIMALS TO SUFFER AND DIE; PET OWNERS TO FEAR FOR THEIR PETS; AND THE COMMUNITY TO BE THREATENED BY AN INDIVIDUAL WHO WAS IN DESPERATE NEED OF HELP.

Senator Frey and Members of the Committee. I am Miss Audrey B. McCaig, Executive Director of the Helping Hands Humane Society here in Topeka.

I am here today in support of SB-191 which amends K.S.A. 21-4311. This amendment is necessary so that County Attorneys and District Attorneys in the State of Kansas will prosecute this Statute on Cruelty to Animals. I have had the full cooperation of Gene Olander, District Attorney for Shawnee County and his staff, but there are many humane societies who do not receive the cooperation of their County Attorney or District Attorney.

The people who mistreat animals can also harm children and adults, and should be prosecuted.

The only change I would make in this amendment is to insert the phrase, "with a Search Warrant" on line 0026 after the words, "may take into custody any animal,....". This is for the protection of all involved in taking into custody the animal in question.

Therefore, I urge each of you to join me in support of SB-191, because we need this bill passed during this session. Your help will be deeply appreciated.
