The meeting was called to order by the chairman.

The hearing for H.B. 2112 was opened. Fred Logan, Johnson County, Prairie Village, KS. spoke in favor of the bill. The bill provides that the library board in Johnson County be increased from five to seven members. The bill would be effective upon publication in the Kansas Register. Mr. Logan stated the Johnson County Commissioners endorsed the bill, also, Duane Fox, State Librarian, It would give the board greater participation. It was thought it would be best for the bill to take effect immediately, since the present board expires, May 1, 1985, it would be in the best interest to go ahead and get the new members on at that time.

H.B. 2206, Scott Lambers, City of Overland Park, spoke briefly in support of the bill. The bill provides Overland Park with the authority for fire service delivery within their corporate boundaries. Mr. Lambers introduced Andrew Happer and Jack Sanders from Overland Park, who both spoke in support of the bill. Mr. Happer's written testimony is a part of these minutes (attachment 1). Mr. Sanders gave a brief history of how the fire service is set up now and why the proposed change. He read into record written testimony from Bill Janke, President of the Overland Park Fire Department, which is a part of these minutes (attachment 2).

There were no opponents present from Johnson County. Senator Langworthy stated she had spoke with Larry Winn III, council for water district #2, Johnson County, and they are maintaining a neutral stance. It will reduce their tax base 23% and they do realize that. It was expected that at sometime Overland Park would want their own fire department.

Senator Allen moved to pass H.B. 2206 favorably. Senator Langworthy seconded the motion. The motion carried.

H.B. 2112, Senator Allen moved to recommend it favorably for passage. Senator Langworthy seconded the motion. The motion carried.

Senator Salisbury moved to reconsider H.B. 2226, that was recommended favarably for passage yesterday. Senator Steineger seconded the motion. The motion carried.

Senator Ehrlich moved to approve the minutes of March 20, 1985, meeting. Senator Allen seconded the motion. The motion carried. Senator Montgomery announced the meeting scheduled for March 22, 1985 would be cancelled.

The meeting adjourned until Monday, March 25, 1985.

REMARKS BY COUNCIL PRESIDENT ANDREW HAPPER CITY OF OVERLAND PARK, KANSAS BEFORE THE SENATE LOCAL GOVERNMENT COMMITTEE REGARDING HB 2206 THURSDAY, MARCH 21, 1985

MR. CHAIRMAN AND MEMBERS OF THE COMMITTEE, MY NAME IS ANDREW HAPPER, AND I AM THE COUNCIL PRESIDENT OF THE CITY OF OVERLAND PARK. I'M APPEARING BEFORE YOU IN SUPPORT OF HOUSE BILL 2206.

FIRE SERVICE IS PROVIDED IN OVERLAND PARK BY FIRE DISTRICTS WHICH ARE GOVERNED BY FIRE BOARDS APPOINTED BY THE COUNTY COMMISSIONERS. THE CITIES OF OLATHE, LEAWOOD, LENEXA, SHAWNEE AND MERRIAM HAVE CONTROL OF AND RESPONSIBILITY FOR FIRE SERVICE IN THEIR COMMUNITIES. OVERLAND PARK DOES NOT. PASSAGE OF HB 2206 WILL PROVIDE US WITH AUTHORITY FOR FIRE SERVICE DELIVERY WITHIN OUR CORPORATE BOUNDARIES.

THE CITY OF OVERLAND PARK IS COMMITTED TO ENSURING ITS
RESIDENTS ARE PROVIDED FIRE PROTECTION SERVICE IN THE MOST
