HB-2863, An act relating to levy limitations. Bev Bradley, Kansas Association of Counties, appeared in behalf of the bill. She stated the bill would continue to allow local units of government to use valuations in existence before the farm machinery exemptions for the purpose of establishing levies. (Attachment 1)

HB-2745, An act granting tax credits for research and developof hydrogen. Representative Leach moved, second by Schmidt, that the Federal definition of Research and Development be incorporated into the bill; that the credits be extended to all businesses; and that the title be amended. Representative Fox moved, second by Spaniol, that a substitute bill be adopted which would include the provisions of the Leach amendment and apply only to R&D conducted in Kansas. The substitute motion was withdrawn. The original motion was withdrawn. Representative Reardon moved, second by Fry, that the bill be amended to include the federal definition of Research and Development. The motion carried. Representative Wunsch moved, second by Wagnon, that the credits apply only to expenditures made within the State of Kansas. The motion carried. Representative Fox moved, second by Spaniol, that the bill be tabled. Representative Wagnon moved, second by Reardon. that the bill be reported favorably as amended. The substitute motion lost. The original motion lost.

Representative Fox moved, second by Spaniol, that a committee bill be introduced which would provide for a 1% R&D tax credit for all expenditures made within the state of Kansas providing for a maximum credit of 50% of State tax liability. The motion carried.

The minutes of the previous meeting were reviewed and approved. There being no further business, the meeting was adjourned.

This bill was requested by Kansas Association of Counties to extend the provisions of 79-1973 which suspends all statutory fund and aggregate levy limitations.
