Minutes of the House Committee on Assessment and Taxation. The meeting was called to order by E. C. Rolfs, Chairman, at 9:00 a.m. on March 6, 1986 in room 519 South at the Capitol of the State of Kansas.

Representative Moomaw reported on HB-3068, an act providing income and sales tax incentives for certain business development, amending the job expansion and investment credit act of 1976. He reported that the sub committee had three meetings on this bill and recommended that lines 166 and 170 on page 5 be reinstated. He suggested that Ways & Means be requested to introduce a bill with language in the sales tax exemption up front.

Representative Moomaw moved, second by Representative Erne that the deleted language in lines 166 and 170 be reinstated. The motion carried.

Representative Moomaw moved, second by Representative Erne, that the committee adopt the sub-committee's report on Enterprise Zones. The motion carried.

The next bill considered was HB-2901, an act concerning enterprise zones; providing for their designation in certain counties. Representative Moomaw moved, second by Representative Ott that the balloon on this bill be adopted with the exception that the wording "having a population of less than 10,000" be deleted. The motion carried. Representative Moomaw moved, second by Representative Erne, that HB-2901 as amended be reported favorably. The motion carried.

HB-3066, an act concerning countrywide retailers' sales tax; relating to the distribution of the proceeds derived therefrom, was discussed. Representative Fox moved, second by Representative Lowther that  $\underline{\text{HB-3066}}$  be  $\underline{\text{reported}}$  favorably. The motion carried.

Discussion on HB-2968, an act relating to taxing authority of cities. Representative Reardon moved, second by Representative Adam, that  $\frac{HB-2968}{S}$  be recommended for interim study. The motion carried.

 $\rm HB-3056$ , an act providing for checkoff donation for the purpose of funding the Kansas Silver Haired Legislature, was discussed. Representative Leach moved, second by Representative Reardon, that  $\rm HB-3056$  be referred to Ways & Means Committee. The motion did not carry.

The minutes of March 6 were approved.

There being no further business, the chairman adjourned the meeting.

## Presented to the House Committee on Assessment and Taxation March 6, 1986

 $\,$  Two amendments to HB 2901 are requested by the Kansas Department of Economic Development.

The first is to strike the language concerning the recertification of previously designated enterprise zones to comply with 1983 amendments to the law. Since all such cities have been recertified, the language on lines 0069 to 0076 are no longer necessary and create confusion if left in the law.

The second amendment attempts to clarify multiple areas within one enterprise zone. Conflicting interpretation of whether the act provides for multiple areas in one zone and/or multiple zones within one city could create future problems. Currently, most cities have multiple areas within one zone.
