Chairman Jeff Freeman opened the meeting and continued consideration of the proposed amendments to \underline{SB} 228, copy attached to March 5 minutes. Discussion began concerning Boeing amendment on page 5-3.

Representative Friedeman moved that the amendment "or employee_owned credit unions or not-for-profit businesses located on the provider's premises in the same building used by one provider and operating for the express purpose of providing a service only to the provider's employees and not to the public at large" be inserted in line 176 following "employees." The motion failed for lack of a second.

Representative Dean made a motion that "or other individuals or legal entities located on the provider's facilities to offer a service to the provider or provider's employees" be inserted in line 176 following "employees." The motion failed for lack of a second.

Representative Friedeman preferred modification of the Southwestern Bell amendment on the previous page to include government entities but not subcontractors and asked Jim Wilson to work up some language on this.

The Wesley Medical Center amendment on page 5-4 was discussed. Representative Dean made a motion that the amendment be accepted. Representative Friedeman seconded the motion. Eva Powers, KCC, said the KCC had granted Wesley Hospital's application but had excluded one of the buildings from the application. The motion failed. They agreed to leave Wesley Hospital amendment available for further modification.

On the CATV Association amendment on page 8, "municipality and municipal franchise" was suggested in place of "government entity." A motion was made and seconded that the amendment_be accepted with the changed wording.

The motion carried.

Representative Dean moved to approve the amendment by Southwestern Bell on page 7. Representative Friedeman seconded the motion. The motion carried. Eva Powers said this grants exclusive certification to Southwestern Bell. Representative Dean moved to reconsider and strike the Southwestern Bell amendment on page 7. Representative Friedeman seconded the motion. The motion carried.

Representative Friedeman moved to strike all in the balloon on page 7-1 following "message toll or private line service." Representative Dean seconded the motion. Representative Friedeman amended the motion to also delete "or private line service." Representative Dean seconded the amendment. The amendment and motion carried.

Representative Dean made a motion to change the date from "April 1, 1985" to "effective date of this act." Representative Friedeman seconded the motion. The motion carried.

The meeting adjourned at 4:30 p.m.
