Chairman Jeff Freeman opened the meeting for further discussion and action on SB 226.

Representative Friedeman moved that the minutes of February 19 and 26 and March 5 be approved. Representative Dean seconded the motion. The motion carried.

After discussion, Representative Friedeman moved that on line 178 at the period behind the word "property" strike the period and add "or dormitories on community college property." Representative Dean seconded the motion. Representative Friedeman withdrew his motion with Representative Dean agreeing and made a motion that on line 178, the period be struck and add "or community college property." Representative Dean seconded the motion. The motion carried.

In discussion, it was brought out that the FCC regulations superseded and the amendments suggested by Kansas Power and Light were not needed. Representative Dean moved to strike their previous actions, "or private carrier use" on line 162, the balloon on line 180, and "or" on line 182 and resubmit the language on lines 185 and 186 that were striken. Representative Friedeman seconded the motion. The motion carried.

The amendment submitted by Boeing Military Airplane Company was discussed extensively. Representative Dean made a motion that "or legal entities located on the provider's premises in the same building used by the provider, and operating for the express purpose of providing a service only to the provider or the provider's employees and not to the public at large" be inserted on line 176 following the word "employees." After much discussion, Representative Dean withdrew his motion. Representative Friedeman made a motion that on line 176 following the word "employees," the following wording be inserted ", or other individuals or legal entities located on the provider's facilities to offer a service exclusively to the provider or provider's employees,". Representative Dean seconded the motion. The motion carried.

There was considerable discussion concerning the amendment submitted by the Wesley Medical Center for exempting hospitals. Representative Friedeman made a motion to insert on page 5, line 176 following the word "employees" the following, ", (2) by a hospital to provide services to members of its medical staff and to the other organizations directly related to the hospital located on the hospital's premises,". Representative Dean seconded the motion. The motion carried.

The meeting adjourned at 6:00 p.m.
