The meeting was called to order by Chairman Fox, who asked that the time element be kept in mind because the House would go back into session at 5:00~p.m.

Senator Norvell testified in support of Senate Bill 199, which he had sponsored. He said that the bill would amend the statutes that authorized the issuance of permits by the State Park and Resources Authority. The bill would allow the Authority to issue a special permit or pass to persons attending bona fide church services at a state park where permits are required. Senator Norvell had introduced this bill in 1985 because of a problem which had arisen at Lake Wilson. Some people who had attended Sunday services there had been issued tickets for not purchasing a park permit before attending the services. The bill was passed by the Senate and by this committee, but the Ways and Means Committee incorporated it with House Bill 2575, which increased penalty provisions for late payment of permit fee. That bill was vetoed by the Governor because of a question as to what constitutes a "bona fide" church service. Responding to a question of the Chairman, Senator Norvell said that the services at Lake Wilson had received consent of the Park Authority, and in fact, people in western Kansas had used private money to construct an open shelter which had a roof with pews for seating and different denominations scheduled services there at different times. The Senator indicated that he would be amenable to including language which would tie this matter in with the Park Authority's rules and regulations for allowing services there, in order to define a "bona fide" church service.

Turning to <u>House Bill 2738--Municipal energy agency act</u>, Gilbert Hanson represented the Kansas Municipal Energy Agency (KMEA). He spoke in support of the bill and distributed background information. (See <u>Attachment 1</u>) Mr. Hanson said that KMEA has 32 member cities and is authorized by law to plan, finance, and construct projects for the purchase, sale, generation, and transmission of electricity for the purpose of securing an adequate, economical, and reliable supply of electricity and other energy for its members. KMEA also is authorized to issue and sell revenue bonds for the purpose of providing funds to pay all or part of the cost of the acquisition, purchase, and construction of such projects. Mr. Hanson stated that the basic purpose of the proposed legislation was to provide "clean up" changes to the KMEA ACT of 1976

which were deemed advisable by the member cities of KMEA. The significant points of the proposed changes of the Act are listed on page 5 of Attachment 1.

Joe Norton, general counsel to Kansas Municipal Energy Agency, explained in detail the changes proposed by $\underline{\text{House}}$ $\underline{\text{Bill}}$ $\underline{2738}$. (See Attachment 1) He also distributed copies of proposed amendments to $\underline{\text{House}}$ $\underline{\text{Bill}}$ $\underline{2738}$ and explained those. (See Attachment 2) Representative Patrick and other committee members asked several technical questions related to the impact of the proposed changes.

Brian Moline expressed concerns of the Kansas Corporation Commission regarding the proposed changes. Chairman Fox asked Mr. Moline to draft amendments that would address the concerns of the Corporation Commission.

The meeting was adjourned at 4:40 p.m.

Mr. Chairman. members of the Committee, I am Gilbert E. Hanson, Jr.. General Manager of the Kansas Municipal Energy Agency (KMEA) and with me is our general counsel. Mr. Joe Norton of the law firm, Gaar and Bell.

Mr. Norton and I are here today representing KMEA in support of house bill number 2738. The following is some basic information, the effects of the changes on the Agency, and letters of support from several member cities of the Agency.

BACKGROUND INFORMATION AND OTHER DOCUMENTATION:

Brief History: Kansas Municipal Energy Agency was formed in May 1980 and is a joint financing agency created pursuant to K.S.A. 12-885 to 12-8,111, inclusive. KMEA's predecessor, the Northwest Kansas Municipal Energy Agency, was formed by agreement among 9 cities in 1978. KMEA now has 32 member cities and is state-wide in nature. The agency is authorized by law to plan, finance, and construct projects

for the purchase, sale, generation, and transmission of electricity for the purpose of securing an adequate, economical, and reliable supply of electricity and other energy for its members. PROJECTS BY KMEA:

Nearman Project Participants: In December 1982, the Agency issued bonds in the principal amount of \$16,900,000. The bonds were issued to finance the purchase of a capacity entitlement in and energy from the Nearman Creek generating station Unit No. 1 owned by the Board of Public Utilities in Kansas City -- the largest municipally-owned

electric utility in Kansas. The cities of Baldwin City, Fredonia, Mulvane, Neodesha, Ottawa, and Winfield have entered into power sales contracts with KMEA for participation capacity and energy. The bonds were secured solely by the revenues generated from that project and were issued under a separate bond resolution.

Northwest Cities Project: In a participation letter agreement signed January 7, 1983, the Agency contracted for 4,000 kilowatts of capacity from the Sunflower Electric Coopertive. Inc. Holcomb Plant Unit #1. KMEA resells the power and energy to the following member cities:

Oberlin (2,000 kW), St. Francis (1,300 kW), and Sharon Springs (700 kW). Sunflower also has agreed to provide emergency energy service, replacement energy service, and scheduled outage energy services to KMEA for use by these cities.

Interconnection Project No. I: The Agency issued \$5.985.000 in bonds to finance interconnection facilities for Ellis. Norton, Oberlin. St. Francis, and Sharon Springs. This issue was just refinanced on December 18. 1985, with a new issue of \$3,754,000 in bonds that will result in a savings of \$1.186.373 over the life of the bonds.

Interconnection Project No. 2 (Fredonia): In March 1983, KMEA issued \$1,285,000 in bonds for the City of Fredonia to finance the cost of acquisition and construction of interconnection facilities to upgrade the city's tie with Kansas Gas & Electric.

Southwestern Power Administration Hydro Power Pool Project: KMEA, in 1984, contracted with the Southwestern Power Administration to

administer a pool of power and energy allocations granted by SPA to 25 Kansas municipal electric generating cities.

FUTURE AGENCY PLANS:

Western Area Power Administration Post-1989 Marketing Allocations:

KMEA, along with the Kansas Municipal Utilities. Inc. (KMU), has been involved for the last several years in trying to obtain federal hydro power allocations from the WAPA area. Both KMEA and KMU are in the process of securing approximately 40,000 KWs of firm hydro power for 56 cities beginning in mid-1989. This low cost power from federal government dams will be an economic benefit for the qualifying cities.

The Agency's principal purpose is the securing of an adequate, economical, and reliable supply of power and energy for qualifying cities. The Agency just finished preparing a loads and resource study for 21 cities. This study is the first of a series of studies to provide system planning to various cities which have not previously had the resources or the in-house expertise required to formalize the planning process.

RESOLUTION #66:

The basic purpose of the proposed legislation is to provide "clean up" changes to the Act which were deemed advisable by the member cities of KMEA. The significant points of the proposed changes of the Act which is nearly 10 years old, are:

- (1) Organization changes are not made by the amendments, but merely give member cities the flexibility to determine administrative operation of the Agency.
- (2) Amendments bring the Agency under the umbrella of the Kansas Tort Claims Act.
- (3) Clarifies that the Agency may provide certain services to any city, but retains prohibition on sale of electricity set forth in the original Act.
- (4) Provides modifications to clarify certain legal questions and technical questions raised by municipal rating agencies during discussions relating to issuance of the Agency's revenue bonds.

RESOLUTION NO. 66

A RESOLUTION AUTHORIZING AND APPROVING THAT CERTAIN PROPOSED AMENDMENTS TO SEVERAL SECTIONS OF KSA 12-885 THROUGH 12-8.111 MUNICIPAL ENERGY AGENCIES BE ADOPTED AND THAT KMEA GENERAL COUNSEL AND MANAGEMENT TAKE THE NECESSARY STEPS TO HAVE SAID AMENDMENTS INTRODUCED FOR CONSIDERATION AND ADOPTION BY THE KANSAS STATE LEGISLATURE, 1986 SESSION.

WHEREAS, KSA 12-885 through 12-8,111, including amendments thereto, titled Municipal Energy Agencies (the Act) was originally enacted by the Kansas State Legislature in the 1977, session and;

WHEREAS, the Northwest Kansas Municipal Energy Agency (Agency) was established on the 22nd day of May 1978 and organized as authorized in accordance with the Act and;

WHEREAS, on May 1, 1980 the Agreement creating Northwest Kansas Municipal Energy Agency (the Agency Agreement) was amended to include additional member municipalities and to change the name of the Agency to the Kansas Municipal Energy Agency (KMEA) and;

WHEREAS, KMEA has been operating as a public utility as provided for in the Act and since beginning operation of selling wholesale electric power and energy since January 1, 1983 to certain member cities and;

WHEREAS, KMEA has experienced problems with the organizational structure as required by the Act and as set forth in the Agency Agreement and;

WHEREAS, the Executive Committee of the Board of Directors has studied KMEA's organizational problem areas and has concluded that if the "Act" were amended as set out in the KMEA document entitled Proposed Amendments to the "Act", the terms of a new organizational structure could be provided for through amendment of the Agency Agreement and By-laws which yould be beneficial to both the member cities and By-Laws which would be beneficial to both the member cities and KMEA.

NOW THEREFORE BE IT RESOLVED BY THE BOARD OF DIRECTORS OF THE KANSAS MUNICIPAL ENERGY AGENCY THAT: The Proposed Amendments to the "Act" are hereby approved and management and general counsel are authorized to take the necessary steps to have said proposed amendments introduced to the Kansas State Legislature for their consideration in the 1986 session.




Dear Mr. Stroup:

The City of Norton is a member of the Kansas Municipal Energy Agency (KMEA). Presently, KMEA consists of thirty two (32) member cities, all of which own and operate a municipal electric utility.

Since the passage of the legislation in 1977 (KSA12-885 through 12-8, 111, including subsequent amendment(s)), nine northwest Kansas cities created the Northwest Kansas Municipal Energy Agency in 1978. In May 1980 twenty three (23) additional cities joined the Agency and at that time changed its name to KMEA.

In 1982 KMEA became operational in that it began selling wholesale power and energy to certain member cities. The Agency has also financed the construction of interconnection facilities for six (6) municipalities. The Agency has proven to be a valuable resource to the member municipalities, as well as to some other cities seeking information and assistance in the operation of their electric utilities.

Although KMEA has performed in meeting its responsibilities to the member cities, the present organizational structure, as required by statute, has proven to be cumbersome. Following several months of study and discussion, the KMEA Board of Directors instructed the Agency staff and general counsel to prepare amendments to the statutes which would provide the flexibility for the Board of Directors to determine an organizational structure better suited to meet the future needs of the cities and the Agency.



In addition to these "house cleaning" measures, it is proposed that the statute also be amended to provide that the Agency, like the cities it represents, come under the provisions of the Kansas tort claims act. It seems logical that, since the statutes define the Agency as a quasi-municipal corporation and as such is an extension of each member city, it should realize the same liability limitations afforded the municipalities.

The KMEA Board of Directors, at its November 1985 meeting, adopted by resolution the proposed amendments to the statutes. The governing body of this City supports the Board and encourages affirmative legislative action. The House Committee on Energy will be receiving this proposed legislation and we ask for your assistance and support for the passage of these amendments.

The Kansas Municipal Energy Agency proposes to amend House Bill No. 2738 by inserting in Line 228 after the word city the following:

and by deleting the comma after the word utility in Line 228.

Section 5 of House Bill No. 2738 with the proposed amendment will state as follows:

Sec. 5. K.S.A. 12-897 is hereby amended to read as follows: 12-897. No municipal energy agency created under this act shall be authorized to enter into any agreement or contract for the direct sale of electricity to any person other than to a member eity of the agency or a utility operating: (a) A city; or (b) a utility, which operated an electric generating system during the calendary dar year 1976.
